## of CrossWalk Church

### Amended and Adopted this 5th day of January, 2022

CrossWalk Community Church, Incorporated (hereinafter referred to as "CrossWalk"), a Virginia non-stock, non-profit corporation, by the solemn action of its Board members, as further defined in Article V, Paragraph 5.2 (hereinafter referred to as the "Board"), and its Presbytery, as further defined in Article IV, Paragraph 4.1.3 (hereinafter referred to as the "Presbytery"), hereby adopts these bylaws and willingly submits to be governed by them so that it may effectively carry out the sacred mission of the Church given by Jesus Christ as described herein. These bylaws shall constitute and evidence the agreement by the Board that its governance, business, and activities shall be conducted as permitted to the fullest extent by §13.1-801 through §13.1-946 of the Code of Virginia of 1950, notwithstanding any inconsistency with the other provisions of Chapter 10 of title 13.1 of that code, as amended from time to time, and the bylaws of the Presbytery, as amended from time to time, and described herein.

## Article I. NAME

The official name of this church shall be CrossWalk Community Church, Incorporated, with its principle office located at 7575 Richmond Road in Williamsburg, Virginia, and its website address at www.crosswalk.cc.

## Article II. MISSION

Derived from a firm and steadfast conviction that a great commitment to the Great Commandment<sup>2</sup> and the Great Commission<sup>3</sup> will grow a great church, CrossWalk shall maintain an environment where its people may both corporately and individually encounter Jesus genuinely through worship and prayer (upreach), encourage one another authentically through fellowship and discipleship (inreach), and engage its community and the world relevantly through evangelism and service (outreach). All three purposes shall have a balance of emphasis.

In willful compliance with §501(c)(3) of the *Internal Revenue Code of 1986*, as amended from time to time, CrossWalk shall have perpetual existence and shall operate exclusively for religious, charitable, and educational purposes.

## Article III. TENETS OF FAITH

- **3.1 Consistency:** CrossWalk shall maintain a cooperative fellowship with the affiliated network of ministries described in Article IV, Paragraph 4.1.3, and Exhibit A herein, and in keeping with the essential beliefs set forth in this Article III, Paragraph 3.3 hereof.
- **3.2 Unity:** Since it is absolutely necessary for the participants to be united in thought and purpose so that CrossWalk will remain healthy and vibrant<sup>4</sup>, this church shall embrace the following position:
  - In essential beliefs, CrossWalk shall endeavor to maintain unity.<sup>5</sup>
  - In non-essential beliefs, CrossWalk shall endeavor to maintain liberty.<sup>6</sup>
  - In all beliefs, CrossWalk shall endeavor to maintain charity.<sup>7</sup>
- **3.3 Essential Beliefs:** CrossWalk shall safeguard the following essential beliefs:
  - The Bible is...
    - The divine revelation of God to mankind.<sup>8</sup>
    - Our fixed source of authority for faith and conduct.<sup>9</sup>
    - o Without error and endurable for all generations and cultures. 10
  - God is...
    - Eternal, having always existed outside of time and space.<sup>11</sup>
    - o A single Being consisting of three Persons Father, Son, and Holy Spirit. 12
  - Jesus is...
    - o The eternal Son of God is both fully God and fully human. 13
    - Conceived by the Holy Spirit and born of a virgin. 14
    - o Without sin. 15
    - The only One who ultimately restores people from sin through the shedding of His blood.<sup>16</sup>
    - Raised from the dead and seated with the Heavenly Father.<sup>17</sup>
    - o The Healer of the sick.<sup>18</sup>
    - o Returning to reign forever in a new heavens and a new earth.<sup>19</sup>
  - The Holy Spirit is...
    - Active today to make people aware of their need for salvation.<sup>20</sup>
    - O Active today to empower every believer to follow Jesus Christ more victoriously,<sup>21</sup> offering a subsequent baptism experience with gifts to confirm the power of the gospel.<sup>22</sup> The gifts of the Holy Spirit shall operate in harmony with the Holy Scriptures and shall never be used in violation of Biblical parameters.<sup>23</sup>
  - People are...
    - Made in the spiritual image of God.<sup>24</sup>
    - o Fallen from innocence due to a willful choice to do wrong.<sup>25</sup>

- Destined for eternal separation from God.<sup>26</sup>
- Provided an opportunity to be reconciled to God through Jesus Christ, not because of human effort and good works, but through faith alone.<sup>27</sup>
- o Invited to accept Jesus Christ, repent of sin, and be regenerated through the power of the Holy Spirit.<sup>28</sup>
- o In need of being separated from carnality and set apart unto God to become more like the character of Jesus Christ.<sup>29</sup>
- Commanded to relinquish the authority over their lives to Jesus Christ, making Him the Lord of their lives.<sup>30</sup>

#### • The Church is...

- The body of Jesus Christ that consists of all believers<sup>31</sup> on a three-fold mission to encounter Jesus,<sup>32</sup> encourage each other,<sup>33</sup> and engage the world.<sup>34</sup>
- Observant of two ordinances water baptism<sup>35</sup> and Holy Communion.<sup>36</sup>

#### • The Future is...

- Hopeful for the Christ-follower because of the imminent, physical, and visible return of Jesus Christ to establish His Kingdom of a new heaven and a new earth at a date that is undisclosed by the Scriptures.<sup>37</sup>
- Dismal and bleak for the unbeliever who has rejected Jesus Christ because of eternal judgment and damnation in hell, separated from God.<sup>38</sup>

#### Sin is...

- A condition of the human heart since birth that causes each and every person to fall short of the standard of moral perfection established by God.<sup>39</sup>
- O Any unrighteous behavior identified in the Holy Scriptures, as interpreted by the Board (hereinafter defined) and the affiliated network (hereinafter defined), therefore requiring appropriate action, including sanctions as necessary, to protect the fellowship of believers and the testimony of Jesus Christ.<sup>40</sup>

#### • Matrimony is...

- A holy, monogamous marriage between one man and one woman as long as they both shall live.<sup>41</sup>
- o A divinely ordained institution of God. 42
- The basic unit of a healthy society.<sup>43</sup>

## ARTICLE IV. PREROGATIVES

- **4.1 Governance:** CrossWalk shall have the right to govern itself according to the principles of the Bible. CrossWalk shall be a church led by its Executive Leadership Team (defined hereof) under the authority of its governing Board.
- <u>4.1.1 Board:</u> The Board members of CrossWalk (hereinafter the "Board" and defined in 5.2 hereof), under the Virginia Non-stock Corporations Act, shall act as the governing authority for CrossWalk by exercising corporate powers.
- 4.1.2 Executive Leadership Team: The Executive Leadership team shall comprise of the senior leadership of the church, including the Pastor and his designees, without term limits. This team shall provide spiritual guidance, set the church's major policies and procedures, and demonstrate responsibility for ministries, operations, and budget.<sup>44</sup>
- 4.1.3 Advisory Team: The Advisory Team shall serve the Executive Leadership Team to lend counsel and local knowledge and input regarding the business affairs of CrossWalk.<sup>45</sup> Their purview is non-legislative and does not include the vision, mission, ministries, and staffing of the church. The Advisory Team shall serve three-year, staggered terms with each term beginning on January 1. Their service shall be limited to one term.
- 4.1.3 Presbytery: The Board shall voluntarily submit itself to the apostolic authority of the affiliated network of ministries as described in this Section IV, Paragraph 4.3 following.<sup>46</sup> The Presbytery shall protect CrossWalk through advice, prayer, equipping, and the accountability of its pastors.
- <u>4.1.4 Congregation:</u> Other leaders, both volunteers and employees, shall protect the pastors from distractions to the ministry by alleviating the operations of CrossWalk.<sup>47</sup> The congregation shall be empowered to share in the work of the ministry under the supervision of the Board, Executive Leadership Team, Pastors, and Ministry Leaders.<sup>48</sup>
- **4.2 Autonomy:** CrossWalk maintains the right to govern itself and to conduct its own affairs provided herein, including but without limitation, the calling of the Lead Pastor, as further defined in Article V, Paragraph 5.1.1 following, the selection of leadership, and the implementation of its own ministries and operations. CrossWalk shall also have the right to purchase or acquire by gift, bequest or otherwise, either directly or as Trustee, and to own, hold in trust, use, sell, convey, lease or otherwise dispose of any real estate or property as may be necessary for the furtherance of its purposes, and to exercise all other powers conferred upon it by its charter, the Virginia Nonstock Corporations Act, other applicable laws of the Commonwealth of Virginia, and the bylaws of the affiliated network of ministries.
- **4.3 Affiliation:** CrossWalk shall voluntarily enter into full cooperative relationship with the affiliated network of ministries known as the General Council of the Assemblies of God, within the jurisdiction of its Potomac Ministry Network (hereinafter

referred to as the "Assemblies of God" or "Presbytery"). CrossWalk shall willingly share in the privileges and assume the responsibilities enjoined by such affiliation. Accordingly, CrossWalk shall recognize, align with, and support the officials, churches, missionaries, and other ministries within this network. (See Exhibit A)

#### ARTICLE V. CHURCH MANAGEMENT

- **5.1 Lead Pastor:** CrossWalk recognizes the biblical authority, divine calling, and training of the Lead Pastor, the Executive Leadership Team, and its pastoral staff. As such, the Lead Pastor and the Board (defined herein) shall establish the core ideology of CrossWalk, including the unique vision, mission, and values of the church as well as the planning of ministries and developing the budget.
- <u>5.1.1 Qualifications:</u> The Lead Pastor shall be credentialed with the Assemblies of God. The Founding Lead Pastors of CrossWalk are Reverends Mark and Pam Morrow.
- <u>5.1.2 Duties:</u> The Lead Pastor is uniquely called to be the primary visionary and apostolic leader of CrossWalk. The duties include, but are not limited to:
  - 1) Spiritual oversight of the congregation.
  - 2) Oversight of the pastoral and administrative staff, including, but not limited to:
    - a. All employment decisions
    - b. Delegation of responsibilities to all staff
    - c. Day-to-day operations
  - 3) Chairman of the Board
  - 4) Official spokesperson for CrossWalk
  - 5) Ex Officio member of all teams, groups, and ministries
- 5.1.3 Vacancies and Appointments: The Founding Pastors shall serve for an indefinite period of time. When a vacancy occurs for any reason, then their successor (Landon Morrow) shall begin serving as Lead Pastor. In the absence of an eligible successor, the Board shall seek the assistance of the Presbytery in identifying and installing a qualified leader to become the next Lead Pastor.
- <u>5.1.4 Discipline of Lead Pastor:</u> The Lead Pastor is morally, theologically, and ethically accountable to the Presbytery. The ultimate responsibility for any discipline of the Lead Pastor lies with the Presbytery who will conduct a thorough investigation in any matter that would affect the Lead Pastor's credentials and be the final arbiters in any discipline of the Lead Pastor.

#### 5.2 The Board:

- 5.2.1 Duties: The Board shall consist of the Lead Pastor and such number of additional persons as may, from time to time, be nominated by the Lead Pastor and approved by a majority of the Board. Board members may not be inexperienced, must have a heart for the core ideology of CrossWalk, but do not necessarily have to be participants. The Board shall consist of not less than three and no more than seven members. The Board shall be comprised of a majority of members that are neither related to each other nor employed by Crosswalk. If both a husband and wife serve on the Board (ie: Lead Pastors), then their vote shall count as one vote when making corporate decisions.
- <u>5.2.2 Qualifications</u>: Members of the Board may consist of current and/or former pastors, employees, and volunteers. The qualifications of a Board member include:
  - 1) Theological agreement with CrossWalk; and
  - 2) Philosophical agreement with the Lead Pastor and the core ideology of the church

A member of the Board, whose employment with CrossWalk is terminated for any reason, shall be removed as a member of the Board.

<u>5.2.3 Powers:</u> The Lead Pastor shall serve as a voting member and Chairman of the Board and shall be present and preside at all Board meetings unless the position of Lead Pastor is vacant. The Lead Pastor will call meetings of the Board at least annually. Additional meetings may be called at the discretion of the Lead Pastor.

All corporate powers shall be exercised by or under the direction of the Board. The Board shall have the following powers:

- 1) Manage the affairs, funds, and property of the corporation.
- 2) Buy, sell, mortgage, pledge or encumber any church property and incur related indebtedness as outlined in the bylaws.
- 3) Adopt procedural rules from time to time as necessary for the proper functioning of CrossWalk.

The Board and the Executive Leadership Team shall fulfill their spiritual and temporal duties in a spirit of servanthood to God, CrossWalk, and one another. Neither are they to exercise dictatorial leadership over one another or CrossWalk but shall cooperatively work together as a model of Christian unity and leadership, each submitting to one another as the Spirit, need, or circumstance may require. If disunity may become present between the Lead Pastor and the Board, then it shall be the responsibility of each to attempt to solve the difference between them. If failing to do so, then it shall be the responsibility of each to seek the mediating efforts of the Presbytery in order that the conflict may not be carried into the rest of the church, but resolved within the circle of church leadership.

- 5.2.4 Terms and Conditions: All members of the Board shall generally serve one-year terms. The Lead Pastor, as Chairman, shall serve in perpetuity until resignation, death, or vacancy. One-year terms shall follow the calendar year. Members of the Board will serve from January 1 through December 31, unless otherwise designated by the Lead Pastor. Members appointed at any point during a calendar year shall serve through December 31 of the calendar year they were appointed. New members shall be nominated by the Lead Pastor and approved by a majority of the Board in the last quarter of every calendar year. There are no term limits for members of the board.
- <u>5.2.5 Removal:</u> Any member of the Board may be recommended for removal by the Lead Pastor. The full board would then vote on the recommendation of the Lead Pastor. If the board member receives a majority vote for removal, then the board member shall be immediately removed.

In the case of any moral, theological, or ethical deviance from biblical standards, the process to be followed is prescribed in Matthew 18:15-20:

- 1) Bring the matter to the attention of the Lead Pastor
- 2) The Lead Pastor will privately consult with the Board member;
- 3) The Board will conduct a thorough investigation before making any recommendation for the removal of a member.
- <u>5.2.6 Nomination:</u> The Lead Pastor shall nominate members of the Board. Upon nomination, new members shall be ratified by majority vote of the existing Board, which vote shall include the affirmative vote of the Lead Pastor.
- 5.2.7 No compensation for being members: Whether or not employed by CrossWalk for other purposes, members of the Board shall for their duties be regarded as volunteers and serve without compensation for those duties, but shall be entitled to reimbursement for any reasonable expenses incurred on behalf of CrossWalk. Any member barred from receiving compensation under these provisions shall not be barred from serving CrossWalk in any other appropriate capacity, such as Lead Pastor or church staff, and receiving reasonable compensation for such other services.
- <u>5.2.8 Full Disclosure of Possible Conflicts</u>: A contract or other transaction between CrossWalk and one or more of its members thereof (hereinafter "interested party"), or between CrossWalk and any other entity, of which entity one or more members are also interested parties, or in which entity an interested party has a financial interest shall be voidable at the sole election of CrossWalk unless all of the following provisions are satisfied:

- 1) CrossWalk entered into the transaction for its own benefit or for the benefit of another supported organization;
- 2) The transaction was fair and reasonable as to CrossWalk, or was in furtherance of its religious, charitable, or educational purposes at the time CrossWalk entered into the transaction;
- 3) Prior to consummating the transaction, or any part, the Board authorized or approved the transaction, in good faith, by a vote of a majority of the members then in office, without counting the vote of the interested member or members, and with full knowledge of the material facts concerning the transaction and the interest of interested parties in the transaction; and
- 4) Prior to authorizing or approving the transaction, the Board, in good faith, determined after reasonable investigation and consideration, that either CrossWalk could not have obtained a more advantageous arrangement, with reasonable effort under the circumstances, or the transaction was in furtherance of the tax-exempt purposes of CrossWalk.

Interested parties may be counted in determining the presence of a quorum at a meeting of the Board (or a team thereof) that authorizes, approves, or ratifies such contract or transaction, but may not be counted for voting purposes.

<u>5.2.9 Actions</u>: The Board shall try to act by consensus. However, a majority decision of the members present and deciding at a meeting, which decision must include the affirmative vote of the Lead Pastor, shall be sufficient to constitute the act of the Board unless the act of a greater number is required by law or these bylaws. At least half of the members of the Board in attendance at any given meeting shall constitute a quorum.

In the case of a deadlock where the Board is unable to reach a conclusive decision, the Lead Pastor shall cast a ballot, which shall be known as a "majority ballot" so that the Board may take an official act or make a decision. The majority ballot shall be cast in addition to the regular member's vote cast by the Lead Pastor.

- <u>5.2.10 Minutes:</u> An official record of actions taken by the Board shall be kept in the administrative office of CrossWalk. The minutes shall keep track of all decisions made by the Board and be open to review by the Board and the Presbytery.
- 5.2.11 Indemnification: To the fullest extent permitted by Virginia law, as now in effect or as may hereafter be amended, no member of CrossWalk shall be personally liable for damages in any proceeding brought by or in the right of CrossWalk, or in connection with any claim, action, suit or proceeding to which they may be or is made a party by reason of being or having been a Board member of CrossWalk, provided, however, that such relief from liability shall not apply in any instance where such relief is inconsistent with any provision applicable to corporations described in §501(c)(3) of the Internal Revenue Code or Virginia law for indemnification by non-profit corporations.

CrossWalk may provide liability insurance and indemnification for the Board for the following reasons:

- 1.) To protect individual members from the financial hardship of potential legal expenses; or
- 2.) To assure the congregation that monies donated to CrossWalk will not be spent on legal defense in case of a lawsuit.

#### 5.3 Other Pastors, Church Employees, Secretary, and Treasurer:

- <u>5.3.1 Appointments:</u> All pastors and other church employees shall be appointed by the Lead Pastor.
- 5.3.2 Secretary: The Secretary of CrossWalk shall keep the minutes of the official meetings of the Board and specially called meetings of the Board. He/she shall keep a record of the Board, and shall be the custodian of all legal documents of CrossWalk and its corporate seal (if applicable). He/she shall file such annual corporation reports with the secretary of state in compliance with state law. In the event the Secretary of CrossWalk is not a member of the Board, the Board shall appoint its own secretary from the Board to record and keep all minutes of Board meetings.
- <u>5.3.3 Treasurer:</u> The Treasurer of CrossWalk shall be entrusted with all the finances of CrossWalk, subject to the supervision of the Lead Pastor and the Board, and shall:
  - deposit all funds in federally insured accounts in the name of CrossWalk
  - disburse such funds by check as authorized by the Lead Pastor and the Board
  - keep an itemized account of receipts and disbursements
  - under consultation with the Advisory Team, present a report to the Board
  - have all the finances reviewed by an external certified public accountant (CPA)
  - make available for full disclosure and accountability an annual report to all CrossWalk members on the church's website.
  - assist CrossWalk in acquiring and maintaining available tax exemptions under state and local law.
  - provide a record of all identified giving to each donor at least annually.
  - make available church records at all time for audit under the direction of the Board.
  - maintain sound procedures for accounting and tabulating offerings
  - maintain all other internal controls pertinent to organizational money handling
- <u>5.3.4</u> Business Administrator: For this version of these bylaws, until further revised, the Business Administrator shall be employed by CrossWalk and serve in both capacities of Secretary and Treasurer, as described hereof, along with other duties as assigned by the Lead Pastor.

## ARTICLE VI. BIBLICAL RESOLUTION OF DISPUTES

In any dispute arising between or among the Board, the Executive Leadership Team, the Advisory Team, the Presbytery, pastors, or staff of CrossWalk, the dispute may be resolved by the Board according to the *Rules of Procedure for Christian Conciliation* as amended from time to time, by the Institute for Christian Conciliation. All employees, contractors, and vendors of CrossWalk shall be asked to sign policies or contracts with this Christian dispute resolution clause in them. A decision shall be reached after prayerful consideration, in a spirit of humility, with each conciliator seeking that which most glorifies God and regarding one another before themselves.

Any claim or dispute arising between or among the Board, the Executive Leadership Team, Advisory Team, the Presbytery, pastors, or staff of CrossWalk shall be settled by mediation and, if necessary, legally binding arbitration in accordance with the *Rules of Procedure for Christian Conciliation* of the Institute for Christian Conciliation. Judgment upon an arbitration decision may be entered in any court otherwise having jurisdiction. Leaders, pastors, and staff shall understand that these methods shall be the sole remedy for any controversy or claim arising within CrossWalk or against CrossWalk and expressly waive their right to file a lawsuit in any civil court against one another for such disputes, except to enforce an arbitration decision.<sup>50</sup> In that case, any court having competent jurisdiction, in conformity with the state laws, may enter judgment upon an arbitration award.

## ARTICLE VII. DISSOLUTION

- **7.1 Property Status upon Division**: In the event of that the congregation of CrossWalk becomes divided over irreconcilable differences to the extent that there is a permanent church division, all property, both real and personal, shall remain the property of CrossWalk, as governed by the Board and these bylaws. The Board shall adhere to the Tenets of Faith outlined in Article III herein and shall remain in good standing with the Presbytery.
- **7.2 Property Status upon Disaffiliation:** CrossWalk shall not disaffiliate with the Presbytery without a majority decision of the Board, which decision shall include the affirmative vote of the Lead Pastor.

Prior to a decision to disaffiliate, a representative from the Presbytery shall be permitted to speak to the Board.

In the event of a decision to disaffiliate by the Board, the Lead Pastor shall give written notice of disaffiliation to the Presbytery. Upon disaffiliation, all property shall remain under the ownership of CrossWalk.

- **7.3 Property Status upon Dissolution:** Upon the dissolution of CrossWalk, none of its funds or assets shall be distributed to any pastor, Board member, or any other individual. In the event CrossWalk shall cease to function as a church body, not having a primary service for a period of three (3) consecutive months, the Board shall:
  - 7.3.1 Pay all outstanding liabilities of CrossWalk;
  - 7.3.2 Dispose of all funds and assets of the Church in compliance with the rules and regulations of Section 501 (c)(3) of the *Internal Revenue Code of 1986*, (or the corresponding provisions of any future United States Internal Revenue Law) governing tax exempt religious organizations.
  - 7.3.3 Specifically, the Board may, by a majority decision, which decision shall include the affirmative vote of the Lead Pastor, choose to dispose of all funds and assets of CrossWalk by conveying the same to another 501(c)(3), tax exempt religious organization or Christian church.
  - 7.3.4 In the event that such agreement cannot be reached by the Board, or in the event that no organization qualifies for distribution as specified, then all funds and assets of CrossWalk shall be conveyed to the Presbytery, for its purposes, provided that said Presbytery at the time qualifies as an exempt organization under section 501 (c)(3) of the *Internal Revenue Code of 1986*, (or the corresponding provisions of any future United States Internal Revenue Law).
  - 7.3.5 Any such funds or assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the corporation is then located, to such organization as said Court shall determine, which is organized and operated exclusively for religious purposes.

#### ARTICLE VIII: TEAMS

CrossWalk, through its Executive Leadership Team, may create and maintain such teams as may be necessary and advisable for the extension of its mission and work. All such departments and organizations shall be subordinate to CrossWalk and shall contribute to the harmony and development of the whole. They shall be under the general supervision of the Lead Pastor and the Executive Leadership Team, and the Pastor shall be an *ex-officio* member of all teams and ministry departments.

#### **FISCAL**

- **9.1 General:** CrossWalk, through the Executive Leadership Team, shall create and maintain such departments and sub-organizations as may be necessary and advisable for the extension of its financial work. All such departments and organizations shall be subordinate to CrossWalk and shall contribute to the harmony and development of the whole. They shall be under the general supervision of the Lead Pastor and the Executive Leadership Team. All significant contracts should be reviewed by the Business Administrator, a competent attorney, and representatives of the Board prior to signing.
- **9.2 Budget and Financial Reviews:** The Business Administrator shall prepare, under consultation of the Advisory Team, and the Executive Leadership Team shall approve annually a unified budget for CrossWalk. Said budget shall include all monies received or expended by and for any and all ministries of CrossWalk. The Executive Leadership Team shall conduct or arrange for an annual review (or audit) by an external certified public accountant.
- **9.3 Robert's Rules of Order:** Where not in conflict with other provisions of these bylaws, *Robert's Rules of Order*, latest edition, may be used as the procedure for all business meetings of CrossWalk at the discretion of the Lead Pastor, to help facilitate order in the meetings of the Board, and teams established by or pursuant to the Articles of Incorporation and these bylaws of CrossWalk.

## ARTICLE X. CROSSWALK POLICY AND OPERATIONS MANUAL

The development of the CrossWalk Employee Handbook and the CrossWalk Policy Manual shall be overseen by the Lead Pastor, Executive Leadership Team, and the Business Administrator with professional consultation and review. This manual shall include all CrossWalk policies, procedures, job descriptions, and organization charts depicting lines of responsibility in the administration of CrossWalk. The manual shall be kept in the CrossWalk office and made available for use by any leader of CrossWalk upon reasonable request. The Business Administrator shall maintain the manual. The Executive Leadership Team shall review the manual at least bi-annually and adjust policies and procedures accordingly. The annual budget shall be kept in the CrossWalk office and made available to any leader of CrossWalk upon reasonable request.

## ARTICLE XI. AMENDMENTS

Amendments to Articles I through IV of these bylaws shall be proposed by the Board and shall require a three quarters (3/4) affirmative decision of the Board members present at a duly called meeting, which decision shall include the affirmative vote of the Lead Pastor, after giving two weeks written notice for each meeting including the proposed amendment. All other Amendments to these bylaws may be made by a simple majority of the Board, which decision shall include the affirmative vote of the Lead Pastor. At least fifty percent (50%) of the Board shall be required to be in attendance at a duly called meeting to constitute a quorum. Opinions may not be submitted in absentia; Board members must be present and able to participate in deliberations in order to make a decision.

#### Exhibit A

Assemblies of God (or herein referred to as "Presbytery")

CrossWalk has voluntarily affiliated with the Assemblies of God – a worldwide cooperative fellowship functioning as a network of ministries relating laterally and sharing common interests covenantally.

The official website for the Assemblies of God is www.ag.org, which contains ample information regarding its history, beliefs, vision, leadership, governing structures, statistics, affiliations, and other matters of interest.

Local churches in this network operate independently once they become affiliated with the General Council of the Assemblies of God. This necessarily means:

every church may choose its own lead pastor every church owns its own assets every church determines its own programs and ministries

CrossWalk is located within the Potomac Ministries Network of the Assemblies of God whose stated purpose is "neither to usurp authority over the various local assemblies, nor to deprive them of their Scriptural and local rights and privileges, but to recognize and promote Scriptural methods and order for worship, unity, fellowship, work, and business for God; and to disapprove unscriptural methods, doctrines, and conduct..."

(Constitution and Bylaws of the Potomac District Council of the Assemblies of God)

The Presbytery lending apostolic oversight for CrossWalk is the body of officers of the Potomac Ministries Network of the Assemblies of God. The candidates for these offices are chosen from the membership of the Network – a body of credentialed ministers of which members of the pastoral staff of CrossWalk are a part.

**History:** The Assemblies of God has its roots in a religious revival that began in the late 1800s. In 1914, both clergymen and laymen gathered from twenty states and several foreign countries for a "General Council" in Hot Springs, Arkansas. From that meager beginning, the Assemblies of God affiliated network of ministries was born.

1 Corinthians 13:1-2

Pursue love, and desire spiritual gifts, but especially that you may prophesy. For he who speaks in a tongue does not speak to men but to God, for no one understands him; however, in the spirit he speaks mysteries. But he who prophesies speaks edification and exhortation and comfort to men. He who speaks in a tongue edifies himself, but he who prophesies edifies CrossWalk. I wish you all spoke with tongues, but even more that you prophesied; for he who prophesies is greater than he who speaks with tongues, unless indeed he interprets, that CrossWalk may receive edification. But now, brethren, if I come to you speaking with tongues, what shall I profit you unless I speak to you either by revelation, by knowledge, by prophesying, or by teaching? Even things without life, whether flute or harp, when they make a sound, unless they make a distinction in the sounds, how will it be known what is piped or played? For if the trumpet makes an uncertain sound, who will prepare himself for battle? So likewise,

you, unless you utter by the tongue words easy to understand, how will it be known what is spoken? For you will be speaking into the air. There are, it may be, so many kinds of languages in the world, and none of them is without significance. Therefore, if I do not know the meaning of the language, I shall be a foreigner to him who speaks, and he who speaks will be a foreigner to me. Even so you, since you are zealous for spiritual gifts, let it be for the edification of CrossWalk that you seek to excel. Therefore, let him who speaks in a tongue pray that he may interpret. For if I pray in a tongue, my spirit prays, but my understanding is unfruitful. What is the conclusion then? I will pray with the spirit, and I will also pray with the understanding. I will sing with the spirit, and I will also sing with the understanding. Otherwise, if you bless with the spirit, how will he who occupies the place of the uninformed say "Amen" at your giving of thanks, since he does not understand what you say? For you indeed give thanks well, but the other is not edified. I thank my God I speak with tongues more than you all; yet in CrossWalk I would rather speak five words with my understanding, that I may teach others also, than ten thousand words in a tongue. Brethren, do not be children in understanding; however, in malice be babes, but in understanding be mature. In the law it is written: "With men of other tongues and other lips I will speak to this people; And yet, for all that, they will not hear Me," says the Lord. Therefore, tongues are for a sign, not to those who believe but to unbelievers; but prophesying is not for unbelievers but for those who believe. Therefore, if the whole church comes together in one place, and all speak with tongues, and there come in those who are uninformed or unbelievers, will they not say that you are out of your mind? But if all prophesy, and an unbeliever or an uninformed person comes in, he is convinced by all, he is convicted by all. And thus, the secrets of his heart are revealed; and so, falling down on his face, he will worship God and report that God is truly among you. How is it then, brethren? Whenever you come together, each of you has a psalm, has a teaching, has a tongue, has a revelation, has an interpretation. Let all things be done for edification. If anyone speaks in a tongue, let there be two or at the most three, each in turn, and let one interpret. But if there is no interpreter, let him keep silent in church, and let him speak to himself and to God. Let two or three prophets speak, and let the others judge. But if anything is revealed to another who sits by, let the first keep silent. For you can all prophesy one by one that all may learn and all may be encouraged. And the spirits of the prophets are subject to the prophets. For God is not the author of confusion but of peace, as in all churches of the saints. Let your women keep silent in church, for they are not permitted to speak; but they are to be submissive, as the law also says. And if they want to learn something, let them ask their own husbands at home; for it is shameful for women to speak in church. Or did the word of God come originally from you? Or was it you only that it reached? If anyone thinks himself to be a prophet or spiritual, let him acknowledge that the things which I write to you are the commandments of the Lord. But if anyone is ignorant, let him be ignorant. Therefore, brethren, desire earnestly to prophesy, and do not forbid to speak with tongues. Let all things be done decently and in order. 1 Corinthians 14:1-40

**Marriage** is a covenant made between two people, one man and one woman, with God. The Christian marriage covenant requires the married parties to be faithful, loving and helpful to each other as long as they both shall live. (Malachi 2:15-16; Matthew 5:32; 19:5-6,9; Romans 7:2-3; I Corinthians 7:10-11, 15; II Corinthians 6:14; Ephesians 5:22-25).

Marriage is a union ordained by God. It was first instituted by God in the early chapters of Genesis, codified in the Levitical law, the Old Testament prophets compared it to a relationship between God and his people, examples of it are in the historical narratives, and, the scripture discusses the unique unity of this relationship. Jesus explained the original intention and core elements of marriage, and several New Testament Epistles give explicit instructions on this union. Marriage is a typology of Jesus Christ and the Church. As such, the Church views marriage as a profound spiritual institution established by God. We believe the term "marriage" has only one meaning, and that is marriage sanctioned by God which joins one man, and one woman in a single, exclusive union, as delineated in Scripture.

Due to the importance of marriage in the biblical witness, this church adopts the following:

Only currently Licensed or Ordained CrossWalk staff Pastors may officiate a marriage ceremony or renewal of vows ceremony.

Staff Pastors employed by CrossWalk shall be subject to dismissal and loss of Licensing/Ordination for officiating a same gender or transgender marriage ceremony, or a same gender or transgender renewal of vows ceremony.

CrossWalk facilities or properties may not be used by any individual, group, or organization that advocates, endorses, or promotes homosexuality or transgender life as an alternative or acceptable lifestyle. This policy applies to events including but not limited to: Birthday parties, Classes, Reunions, Anniversaries, Baby Showers, Weddings, and Renewal of Vows services.

## 42 Matrimony is ordained by God

And the Lord God said, "It is not good that man should be alone; I will make him a helper comparable to him."

#### <sup>43</sup> Matrimony is the basic unit of society through its ministry and testimony

Therefore, just as CrossWalk is subject to Christ, so let the wives be to their own husbands in everything. Husbands, love your wives, just as Christ also loved CrossWalk and gave Himself for her, that He might sanctify and cleanse her with the washing of water by the word, that He might present her to Himself a glorious church, not having spot or wrinkle or any such thing, but that she should be holy and without blemish. So husbands ought to love their own wives as their own bodies; he who loves his wife loves himself.

### 44 Today's pastors are the same as the New Testament elders

[Paul to the Elders of CrossWalk in Ephesus] Therefore take heed to yourselves and to all the flock, among which the Holy Spirit has made you overseers, to shepherd [poimen] CrossWalk of God...

#### <sup>47</sup> Non-pastoral leaders that govern the operations of CrossWalk

#### 49 Moral Integrity and Personal Lifestyle

The Bible dictates standards of sexual behavior and declares that as a follower of Christ, we are not to engage in inappropriate sexual conduct. Inappropriate conduct includes but is not limited to heterosexual activity outside of marriage (premarital sex, cohabitation, extramarital sex), homosexual activity, sexual harassment, use of pornographic material or websites, and sexual abuse or improprieties toward minors as defined by Scripture and federal or state laws.

Any promiscuity, homosexuality, or other sexual behaviors forbidden in the Scriptures violates the bona fide requirement of being a Christian role model. The unique roles and gender identity of the male and female are clearly defined in Scripture. Romans 1:24-32 states that God recognizes homosexual behavior as sin. (Romans 12:1-2, 1 Corinthians 6:9-20, Ephesians 4:1-11, 5:3-5, I Thessalonians 4:3-8, 1 Timothy 4:12, 2 Timothy 2:19-22, 1 Peter 1:15-16, 1 John 3:1-3).

The Bible exhorts us to display the highest Christian virtue and personal decorum, serving as a Christian role model (1 Timothy 4:12) both in and out of Church (Luke 6:40), and as an example to the community in dignity, respect, and Christian living. This includes, but is not limited to, refraining from such activities as the abuse of alcohol and the use of illicit drugs, pornography, or vulgar and profane language. (Colossians 3:17, Titus 2:7-8, 1 Thessalonians 2:10, 1 Thessalonians 5:18, 22-23, James 3: 17-18). It is the goal of the Church that each person will have a lifestyle in which "God may have the preeminence" (Colossians 1:18).

### <sup>50</sup>Avoidance of the Court of Law in Settling Disputes in the Church

When one of you has a dispute with another believer, how dare you file a lawsuit and ask a secular court to decide the matter instead of taking it to other believers. Don't you realize that someday we believers will judge the world? And since you are going to judge the world, can't you decide even these little things among yourselves? Don't you realize that we will judge angels? So, you should surely be able to resolve ordinary disputes in this life. If you have legal disputes about such matters, why go to outside judges who are not respected by the church? I am saying this to shame you. Isn't there anyone in all the church who is wise enough to decide these issues? But instead, one believer sues another - right in front of unbelievers! Even to have such lawsuits with one another is a defeat for you. Why not just accept the injustice and leave it at that? Why not let yourselves be cheated? Instead, you yourselves are the ones who do wrong cheat fellow believers. and even your 1 Corinthians 6:1-8
