Executive Order No. 4 (2018)



**CITY OF HOBOKEN
OFFICE OF THE MAYOR
EXECUTIVE ORDER**

**EXECUTIVE ORDER DECLARING THAT ALL BOND ORDINANCES
SHALL BE DRAFTED TO INCLUDE A PROVISION DEDICATING A
MAXIMUM OF 1% FOR THE FUNDING OF ART INSTALLATIONS IN
THE CITY OF HOBOKEN**

EXECUTIVE ORDER **Date: June 25, 2018**

WHEREAS, the installation and inclusion of artwork in and around public buildings, grounds, and parks enriches the lives of the citizenry and increases the attractiveness of the area to tourists, businesses, and investments; and,

WHEREAS, cultural projects such as art installations play a fundamental role in revitalizing neighborhoods and promoting economic prosperity; and,

WHEREAS, the arts provide a catalyst for the creation of social capital and the attainment of important community goals; and,

WHEREAS, participation in the arts improves physical and psychological well-being; and,

WHEREAS, public art promotes neighborhood cultural diversity and reduces neighborhood crime and delinquency; and,

WHEREAS, the Administration in the City of Hoboken seeks to increase funding for the arts within the City of Hoboken in order to encourage and facilitate the installation of works of public art which provide significant benefits to residents and visitors as delineated above; and,

WHEREAS, the Administration wishes to establish an administrative procedure in order to ensure financial support for art programs by including a provision in every bond ordinance dedicating a maximum of 1% towards art installations.

NOW, THEREFORE, I, Ravinder S. Bhalla, Mayor of the City of Hoboken, New Jersey by virtue of the authority vested in my by the Statutes of this State and the laws of the City of Hoboken, do hereby, ORDER, DIRECT AND ISSUE THE FOLLOWING EXECUTIVE ORDER:

Section 1.

All bond ordinances prepared by the Administration for the consideration by the City Council shall include a provision dedicating a maximum of 1% to a public arts project or projects. This dedication shall be reviewed by Bond Counsel for a determination as to the legality and feasibility of the specific dedication. Public arts projects may include but are not limited to paintings, murals, frescoes, mosaics, inscriptions, stained glass, fiber work, statues, reliefs or other sculpture; monuments, fountains, arches, or other structures intended for ornament or commemoration; carvings, mobiles, photographs, drawings, collages, prints, crafts—both decorative and utilitarian—in clay, fiber, wood, metal, glass, plastics and other materials. Works of art may be temporary as well as permanent.

Section 2.

The Business Administrator and/or the Business Administrator's designee shall be permitted to promulgate such reasonable internal regulations as to effectuate the intent and purpose of this Order.

Section 3.

Within 30 days, the Clerk of Hoboken shall send copies of this Chapter, including any future amendments thereto that may be made, to every department, agency and commission in Hoboken. Each appointing officer in Hoboken shall inform all employees under her or his jurisdiction of their requirements related in this Executive Order, the duty of all of her or his employees to comply with the requirements in this Executive Order, and that employees who fail to comply with the requirements of the Executive Order shall be subject to appropriate disciplinary action. Each agency will provide its employees with a written directive with instructions for implementing the provisions of this Executive Order within thirty days of notice.

Section 4.

If any part of this Executive Order, or the application thereof, is held to be invalid, the remainder of this Executive Order shall not be affected thereby, and this Order shall otherwise continue in full force and effect. To this end, the provisions of this Order, and each of them, are severable.

Section 5.

All city agencies and employees shall fully cooperate with this Executive Order.

Section 6.

This Executive Order shall take effect immediately and supersedes all inconsistent Executive Orders.

**EXECUTIVE ORDER ESTABLISHING A CITY OF HOBOKEN ART COMMITTEE
ADVISORY BOARD**

CITY OF HOBOKEN **No.: 2**

EXECUTIVE ORDER **Date: May 10, 2019**
 Revised: August 31, 2021

WHEREAS, pursuant to Executive Order No. 4 dated June 25, 2018, the City increased “funding for the arts within the City of Hoboken in order to encourage and facilitate the installation of works of public art which provide significant benefits to residents and visitors” in the City; and,

WHEREAS, Executive Order No. 4 directed that the City must include a provision in every bond ordinance dedicating a maximum of 1% towards art installations; and,

WHEREAS, pursuant to N.J.S.A. 40:69A-40 the Mayor is responsible for negotiating contracts on behalf of the City, including contracts to artists for the art installations to be funded by the bond ordinances; and,

WHEREAS, by Executive Order No. 2, dated May 10, 2019, the Mayor established an Art Committee to advise the Mayor and provide guidance on all questions involving public art and the City of Hoboken Art Program; and,

WHEREAS, the Administration wishes to amend the qualifications to be considered for appointment to the Art Advisory Committee to include residents, property owners, business owners, and employees of businesses in the City of Hoboken.

NOW, THEREFORE, I, Ravinder S. Bhalla, Mayor of the City of Hoboken, New Jersey by virtue of the authority vested in me by the Statutes of this State and the laws of the City of Hoboken, do hereby, **ORDER, DIRECT AND ISSUE THE FOLLOWING EXECUTIVE ORDER:**

Section 1. Purpose of Executive Order:

The purpose of this Executive Order is to create a City of Hoboken Art Committee to act in an advisory capacity to the Mayor in the administration of the City of Hoboken Public Art Program, which terms are to be defined as follows:

- a) *City of Hoboken Art Committee*: The purpose and object of the Art Committee Advisory Board created by this Executive Order is to act as an advisory board to the Mayor and City Administration relating to all questions involving public art and the City of Hoboken Art Program.
- b) *City of Hoboken Public Art Program*: The purpose of the City of Hoboken Public Art Program is to create an enhanced visual environment for City of Hoboken residents, to commemorate the City’s rich cultural and ethnic diversity, to integrate the work of artists into the development of the City’s capital infrastructure improvements, and to promote tourism and economic vitality in the City through the artistic design of public spaces.

As used herein unless the context clearly indicates otherwise:

- a) *Art or artwork* means works in any permanent medium or combination of media that has been approved by the City’s Bond Counsel to be purchased from the 1% Bond dedication for the funding of art installations, including, but not limited to, paintings, murals, frescoes, mosaics, inscriptions, stained glass, fiber work, statues, reliefs or other sculpture; monuments, fountains, arches, or other structures intended for ornament or commemoration; carvings, mobiles, photographs, drawings, collages, prints, crafts – both decorative and utilitarian – in clay, fiber, wood, metal, glass, plastics and other material produced by artists who are generally recognized by critics and peers as professionals of serious intent and substantial ability;
- b) *City of Hoboken art collection* means all public works of art located in the City of Hoboken;
- c) *Public Art Plan or Plan* means the prioritized list of public art projects to be commenced during a fiscal year and the budget to effect it.

Section 2. Establishment of City of Hoboken Art Committee:

The City of Hoboken Art Committee, as defined above, shall be comprised of nine (9) individuals as follows:

1. The Business Administrator or the Business Administrator's Designee; and,
2. One (1) member of the Hoboken City Council selected by the Mayor; and,
3. Seven (7) individuals that must be either a resident, property owner, business owner, or an employee of a business in the City of Hoboken. Of the seven (7), four (4) shall be selected by the Mayor, and the Mayor may invite the Hoboken City Council to select the other three (3). The City Council must make their selection(s) no later than January 30th of each year. If the City Council does not make their selection(s), the Mayor shall appoint the remaining members to the vacant spots.
4. The Mayor shall appoint a person to serve as Chair of the Art Committee.

The nine (9) members of Art Committee shall serve for a term of one (1) year, and until a successor is appointed. The members of the Art Committee shall serve in an advisory capacity only as delineated herein. Service on the Art Committee is purely voluntary and members shall serve without compensation.

Section 3. Procedure for Review of Proposed Artwork:

Artists may submit proposals for artwork to the Administration. The Administration may then forward the proposal to the Art Committee for review.¹ The Business Administrator shall ensure that the Mayor receives a copy of all proposals that are submitted. The Art Committee shall review and vote on proposals within forty-five (45) of receiving said proposal. The Art Committee shall vote to recommend, not recommend, or recommend with amendments the proposal, and shall send to the Mayor the results of the vote and an evaluation in the form of a statement of reasons which sets forth the reasons for the Art Committee's decision. The statement of reasons shall include, at a minimum*, an analysis of the following factors:

1. Contribution and meaningfulness to the Hoboken community;
2. Contribution to the City of Hoboken art collection;
3. Historical relevance (if applicable);
4. Relevance to a prominent Hoboken figure or establishment (if applicable);
5. Price and value;
6. Useful life;
7. Quality of the proposed artwork;

¹ Nothing herein shall be construed to prevent the Mayor from taking action on a proposal received by the Administration without referral to the Art Committee.

8. Relationship to surrounding area;
9. Unique and innovative aspects of the artwork; and
10. Recommendation of the Councilperson for the Ward wherein the proposed artwork will be located.

**Additional considerations beyond the required factors above are encouraged to be included in the statement of reasons.*

The Art Committee shall also invite the Ward Councilperson for the Ward wherein the artwork is proposed to be located to review and participate in at least one discussion regarding any artwork proposed before forwarding the evaluation to the Mayor. The Ward's Councilperson's recommendation, comments, thoughts, and ideas shall be made clear in the statement of reasons provided to the Mayor.

The Mayor will review all recommendations and evaluations of proposals submitted to the Art Committee. The Mayor will negotiate the terms of an agreement with the artist directly for all proposals that he approves. Once an agreement has been negotiated, the Mayor will present the agreement to the City Council for a public hearing at the next available regularly scheduled City Council meeting. At the next regularly scheduled City Council meeting following the public hearing, the Mayor will submit a resolution of approval to the City Council to approve the agreement.

The Business Administrator shall be responsible to keep the following records:

1. All applications for the Public Art Program submitted to the Administration;
2. Applications that are referred to the Art Committee;
3. The vote and written evaluation of the Art Committee;
4. All projects approved by the Mayor and Council to be included in the City of Hoboken Art Collection;
5. A restoration, maintenance, and repair plan for the Art Collection; and,
6. A Public Art Plan to be submitted to the Mayor on at least an annual basis.

Section 4. Duties:

In addition to the evaluation of proposals as delineated in Section 3 above, the City of Hoboken Art Committee shall advise and make recommendations to the Mayor regarding the Public Art Program concerning the following matters, without limitation:

- a) Preparing recommendations for the annual Public Art Plan to be submitted to the Business Administrator;

- b) Surveying the City of Hoboken Art Collection on an annual basis to make recommendations for restoration, repair and maintenance if necessary. These recommendations shall be reviewed and approved by the Business Administrator for presentation to the Mayor;
- c) Preparing an evaluation of the Public Art Program to determine if there are any recommended changes to the Program every two years and presenting the recommendations to the Mayor.

Section 5. Funding:

- a) Funding for the City of Hoboken Public Art Program shall be accomplished by annually setting aside one percent (1%) of Capital Improvement Project funding for public art as outlined in Executive Order No.: 4, dated June 25, 2018. The percentage, approved in advance by the City Council for the Public Art Program, shall be added to the total cost of each proposition in the City of Hoboken's Capital Project programs.
- b) Funds shall be used for the artist fees and costs related to the production and maintenance of artwork. Funds shall not be used for professional graphics, mass produced work or work not produced by an approved artist. Allocations shall be calculated based on the total of all engineering, design and construction costs. The appropriation for the Public Art Program will be calculated only on the original appropriation for amendments and change orders.

Section 6. Regulations:

The Business Administrator and/or the Business Administrator's designee shall be permitted to promulgate such reasonable internal regulations as to effectuate the intent and purpose of this Order.

Section 7. Distribution to City Departments:

Within 30 days, the City Clerk of the City of Hoboken shall send copies of this Executive Order, including any future amendments thereto that may be made, to every City Department. Each Department Head shall inform all employees under her or his jurisdiction of their requirements related in this Executive Order, the duty of all of her or his employees to comply with the requirements in this Executive Order, and that employees who fail to comply with the requirements of the Executive Order shall be subject to appropriate disciplinary action.

Section 8. Severability:

If any part of this Executive Order, or the application thereof, is held to be invalid, the remainder of this Executive Order shall not be affected thereby, and this Order shall otherwise continue in full force and effect. To this end, the provisions of this Order, and each of them, are severable.

Section 9. Cooperation:

All city agencies and employees shall fully cooperate with this Executive Order.

Section 10. Immediate Effect:



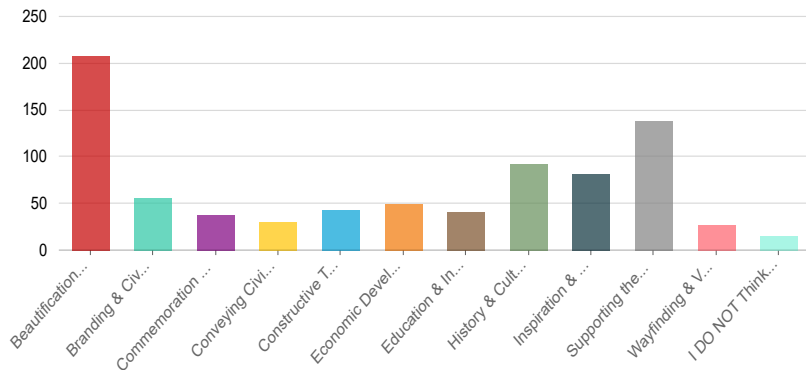

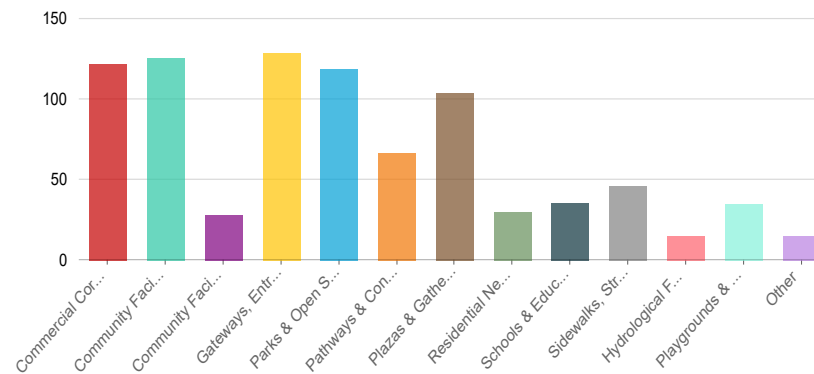

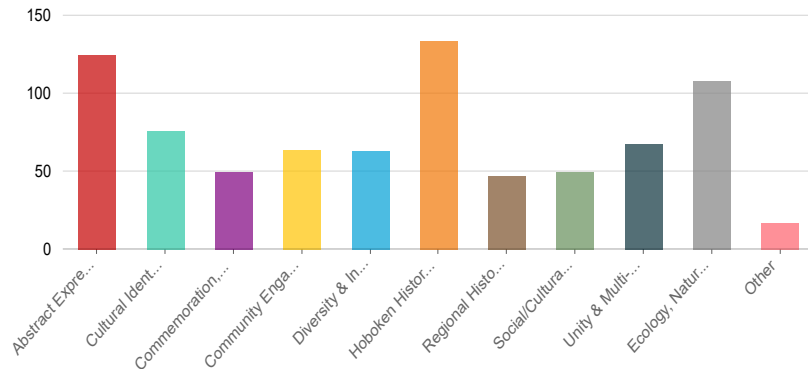

What artistic themes are you most excited by? *

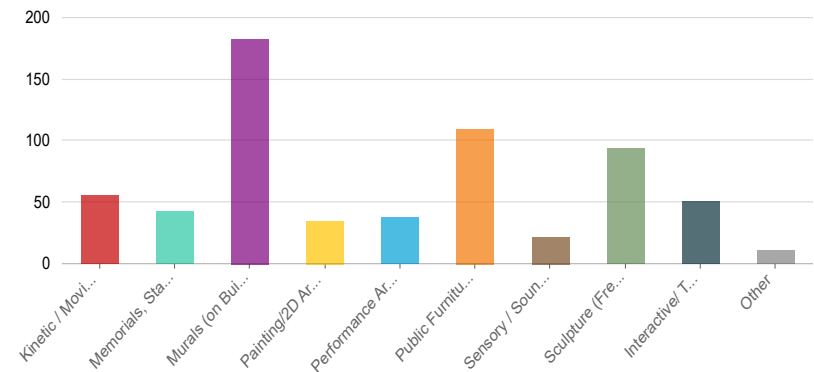

What types of public art should be prioritized? *

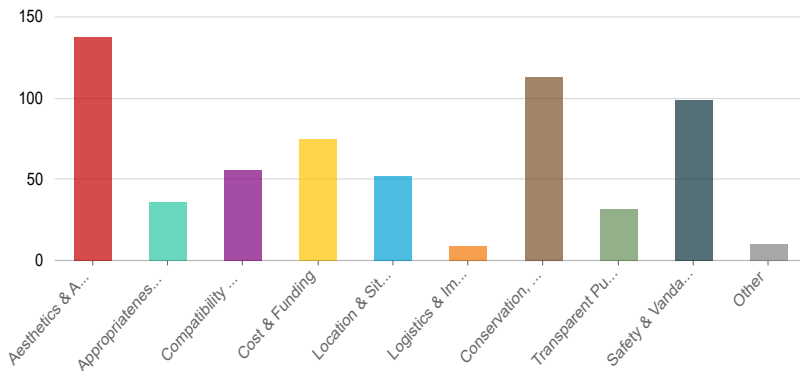

What are your top concerns about public art? *

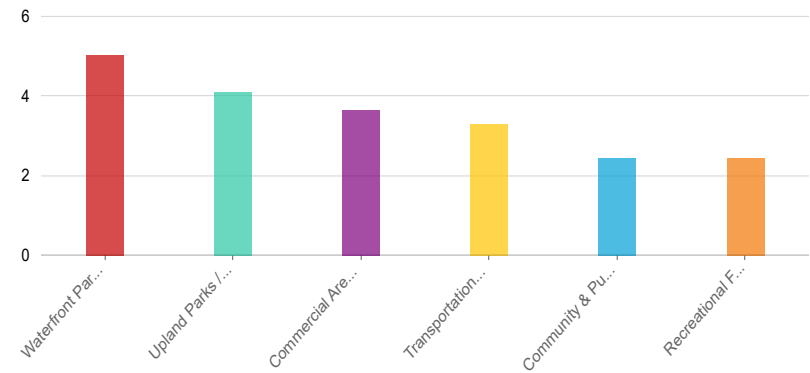

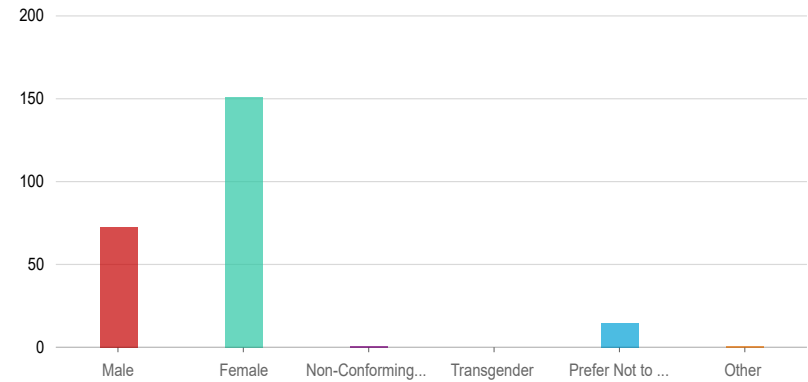

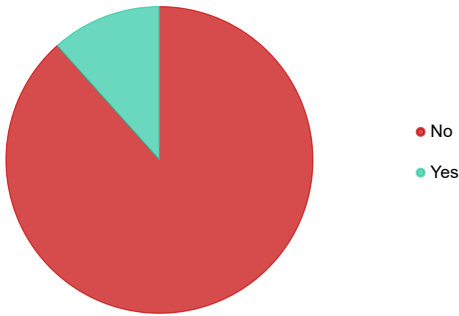
