## RESOLUTION FOR THE PROPOSED AMENDMENTS OF THE KINGSTON AND ST. ANDREW CORPORATION (PLACES OF AMUSEMENT) REGULATIONS, 1999

Below are the proposed amendments to be made to the Places of Amusement Regulations, 1999:

- 1. The Heading may be amended by inserting immediately after the words "THE KINGSTON AND ST. ANDREW" the words "MUNICIPAL".
- 2. The Regulations may be amended by deleting the number "1999" and replacing it with the number "2018"
- 3. Section 2 of the Regulations may be amended by inserting after the words ""cinema" means any place where cinematograph exhibitions are held;" the words ""Council" means the Council of Kingston and St. Andrew Municipal Corporation"
- 4. Section 2 of the Regulations may be amended by inserting immediately after the words "skate rink" the words "or such places as the Council may deem by its activities qualify as a place of amusement"
- 5. Section 2 of the Regulations may be amended by inserting after the words "prescribed requirements means the requirements prescribed in these Regulations, for the grant of a licence" the words " "special event licences" are licences granted to places of amusement that would not require an annual licence based on the nature and duration of the entertainment"
- 6. Section 3(2) may be amended by inserting after item (c) the following words as item (d):
  - "(d) the number of security personnel, or police and security personnel that will be utilized;"

- 7. Section 3(2) may be amended by inserting after item (d) the following words as item (e):
  - "(e) a traffic plan may be requested for events with a capacity exceeding 2.000 persons."
- 8. Section 3(3) may be amended by inserting immediately after the words "local community" the words "However the Place of Amusement Licence may not be waived.
- 9. Section 3 may be amended by inserting immediately after item (3) the following as item (4):
  - "(4) Applications for Special Event Licences must be made ten (10) days prior to the commencement date of the event. All late applications will attract a fee of \$1,500 per day outside of the prescribed period."
- 10. Section 3 of the Regulations may be amended by inserting after item (4) the following as item (5):
  - "(5) Events that fall outside of the scope of an applicant's usual activities shall require a special amusement licence whether the event is being held by the same applicant or otherwise."
- 11. Section 4(e) of the Regulations may be amended by deleting the words "Town Clerk" and replacing them with the words "Chief Executive Officer".
- 12. Section 5(4) of the Regulations may be amended by inserting immediately after the words "as the Council thinks fit." the words "If a person operates more than one (1) place of amusement, a licence shall be applied for each place of amusement."
- 13. Section 8(1) of the Regulations may be amended by inserting immediately after the words "remuneration therefor" the words "The

annual licensing fees for a place of amusement may be prorated once it is proven that same started after the middle of the calendar year.".

- 14. Section 13 of the Regulations may be amended by numbering the paragrapii as item (1).
- 15. Section 13 of the Regulations may be amended by inserting immediately after item (1) the following as item (2):
  - "(2) Each issued licence shall be displayed in a prominent area of the building or grounds for which the application was made and shall be used only by the applicant in respect to places of amusement."
- 16. Section 14 of the Regulations may be amended by replacing the words "ten thousand" with the words "one hundred thousand in the first instance and two hundred thousand in the second instance.".
- 17. The First Schedule of the Regulations may be amended by inserting immediately after the words "TO: THE KINGSTON AND ST. ANDREW" the word "MUNICIPAL".
- 18. The First Schedule of the Regulations may be amended by inserting after item (c) the following as item (d):
  - "(d) the number of police and security personnel that will be utilized and a traffic plan if required"
- 19. The Second Schedule of the Regulations may be amended by deleting the words "in column 2"
- 20. The Second Schedule of the Regulations may be amended by deleting the words "in column 1" and replacing them with the word "below"
- 21. The Second Schedule of the Regulations may be amended by deleting Column 1 and Column 2 and replacing them with the following words:

(R)

- "(a) For licensing of a special event on buildings or grounds per day:
  - (i) With a capacity not exceeding 500 persons Class D \$5,000 (includes two (2) tents (10x10) and two feather banners)
  - (ii) with a capacity exceeding 500 persons but not exceeding 1,000 persons Class C \$15,000 (includes three (3) tents (10x10) and four (4) feather banners)
  - (iii) With a capacity exceeding 1,000 persons and not exceeding 2,000 persons Class B \$30,000 (includes four (4) tents of any size and six (6) feather banners)
  - (iv) With a capacity exceeding 2000 persons Class A \$40, 000.00 (includes four (4) tents of any size, eight (8) feather banners and one (1) single story cabana or booth
- (b) For annual licensing of a place of amusement:
  - (i) with a capacity not exceeding 500 persons Class C \$50,000.00
  - (ii) with a capacity exceeding 500 persons but not exceeding 1,000 persons Class B \$80,000
  - (iii) with a capacity exceeding 1.000 persons Class A \$110,000,00"
- 22. The Third Schedule may be amended by inserting immediately after the words "THE KINGSTON AND ST. ANDREW" the word "MUNICIPAL".
