Effective immediately, DAA/OKC will now accept credit cards for Accounts Receivable balances. At this time, we will only accept Visa and MasterCard payments.

For any account balance payment below \$25, there is a \$1.50 processing fee. Balances \$25.01 to \$999.99 will not be charged a processing fee (DAA/OKC will simply absorb the associated fee). Any balance \$1,000 and over will be charged a 5% processing fee.

For those of you who wish to have titles or checks overnighted to you and do not have an account with Federal Express or a similar carrier, we will take your card information to pay those charges. Due to the amount of a package shipping fee, there is a \$1.50 processing fee for all these charges.

The fee for ALL vehicle purchases will be 5%, regardless of the amount of the vehicle price. This will cover our additional costs for processing the payment. GSA vehicles are processed through the GSA credit card website and do not carry the DAA/OKC processing charge just as in the past.

As a note, our credit card machine is located in our Accounting Department, so we must have your card to take upstairs OR you may call the information in to the Accounting for processing.

We hope this will assist customers with their monthly statements and provide a simpler, smoother payment method.
