(Name of Schedule)

AVAILABLE: To Customers, other than municipalities, for public highway and roadway lighting in the retail distribution service territory of the District.

APPLICABLE: To all night lighting service (dusk to daylight) for highway and roadway lighting.

CHARACTER OF SERVICE:

District-Owned Systems:

The District will install, operate, and maintain the complete system and furnish street lighting service from dusk to daylight, or approximately 4,000 hours per year.

Customer-Owned Systems:

The Customer will construct, own, and maintain the complete system. The District will supply energy, furnish lamp renewals (excluding LED luminaire replacement), and patrol the system. Service supplied under this Rate Schedule shall not exceed 4,000 hours per year.

- 2. Extensions made for service under this Rate Schedule are subject to the provisions of the District's "General Extension Policy for Retail Electric Services and Facilities".
- 3. The District's General Customer Service Charges Rate Schedule shall apply.
- 4. Usage shall be prorated for application of a change in rate. Such proration shall be accomplished by fractionalizing according to the number of days of service corresponding to each time period by using the District's billing system.
- 5. For billing purposes, usage shall be normalized to 30 days when actual days of service is less than 27 days or exceeds 35 days in any given billing period.
