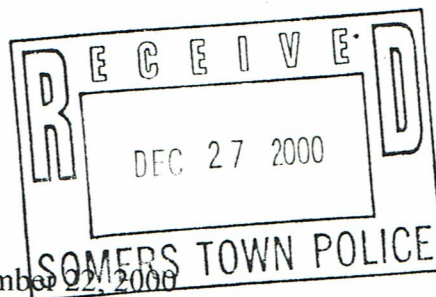

appreciated.

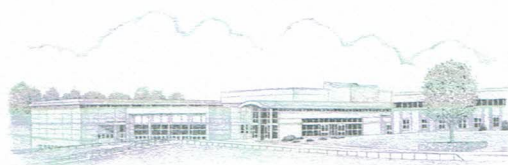
