2023 LA BORINQUEÑA GRANT AWARDS

The La Borinqueña Grants Program was created by Kyung Jeon-Miranda and Edgardo Miranda-Rodriguez to support Puerto Rico. What initially started as a response to Hurricane Maria in 2017, has evolved to supporting the continued work of organizations helping people living in Puerto Rico affected not only by the hurricanes, but the ongoing humanitarian crises that Puerto Ricans continue to face such as the debt crisis, power outages, corruption, earthquakes and the Coronavirus pandemic.

We are very excited to continue our efforts for Puerto Rico, supporting local organizations and projects that lead to sustainable development, most especially in the areas of child development, women's health, agriculture and environmental justice, and the arts. We also support and celebrate organizations that work to preserve Afro-Puerto Rican heritage and envision a Puerto Rico that is self-sufficient and thriving.

Specifically, funds may be used to:

- Provide educational/recreational/artistic direct services to children: in-school, after-school, summer camps
- Provide vocational/educational/health related services to women
- Provide ecological/environmental preservation direct services to communities: wildlife, coastal, nature-preserves, water purification
- Provide direct services related to food: cooperative farms, soup kitchens
- Provide support for artist collectives or arts organizations

APPLYING FOR A GRANT

Eligible Requests

This Request for Proposals invites applications that directly benefit the people of Puerto Rico by non-profit community-based organizations and agencies based in Puerto Rico. We will not make grants to individuals or government agencies, or for capital building projects, lobbying or religious purposes or non-profits based outside of Puerto Rico. Funds must be used in already existing ongoing projects with measurable and positive outcomes.

Grant proposals should adhere to the format outlined in these guidelines.

Award Amount: Applicants may apply for up to \$5,000.00 for proposed programs and activities. Grants

awarded will support one year of activity.

Key Dates: Friday, March17, 2023, Proposals due by 3:00 PM

Final awards will be announced no later than April 3, 2023.

Proposals must be submitted electronically to Kyung Jeon-Miranda at <u>grants@la-borinquena.com</u> by the due date and time indicated above. A single PDF file containing all materials is preferred. Any late applications will not be accepted.



Applicant organizations must meet the following criteria:

- Non-profit corporation based in Puerto Rico with proof of 501(c)(3) tax-exempt status or a fiscal conduit with similar proof and status;
- Evidence of successful completion of a project or data of an ongoing project;
- Experienced, qualified leadership with appropriate credentials; and
- Proven track record of relationships fostered with other organizations and constituencies in the community, and Puerto Rico.

The Grant Review Process

Application Procedures

Please submit an application containing all of the items specified below. We will contact you if we have questions or require additional information. We will acknowledge your application within two weeks of its receipt. If we are interested in funding your proposal, we will contact you to discuss your application within two months.

Application Contents

Your application must include:

- 1. Narrative (no more than 2-3 pages) that includes:
 - Project Description
 - Brief statement of problem to be addressed
 - Goals and objectives
 - Target population
 - Project activities
 - o Plan for measuring project results
- 2. Project Budget (expenses and income)
- 3. Supporting Materials
 - o Certificate of Incorporation and By-Laws
 - o Verification of tax-exempt status (IRS determination letter)
 - o List of officers and Board of Directors
 - o Staff Biographies and Key Staff Resumes
