

Promotion Terms & Conditions

THE MAPLES

Refer and Receive \$3,000 Promotion

- This promotion is being conducted by Hillview 1 Pty Ltd, Victoria C4 Pty Ltd and Frenchview Pty Ltd ("Promoter") of 50 Marine Parade, Southport QLD 4215.
- The promotion commences at 9am (Melbourne time) on 8 March 2019 and ends at 5pm (Melbourne time) on 31 December 2019 ("Promotional Period").
- 3. In these terms and conditions, a referrer is a person aged 18 years or over who provides their friends' or family members' contact details to the Promoter ("Referrer") and the referred person is the person referred to the Promoter by the Referrer.
- 4. A Referrer will be entitled to \$3,000 payable via cheque or electronic funds transfer ("Reward") if:
