The enrollment system is based on priority groups to ensure health care benefits are readily available to all enrolled Veterans. Complementing the expansion of benefits and improved access is our ongoing commitment to providing the very best in quality health care service to our patients when they are needed during that enrollment period, regardless of the treatment program or the location.

Priority Group	Definition
1	Veterans with VA-rated service-connected disabilities 50% or more disabling
	Veterans determined by VA to be unemployable due to service-connected conditions
2	Veterans with VA-rated service-connected disabilities 30% or 40% disabling
3	Veterans who are Former Prisoners of War (POWs)
	Veterans awarded a Purple Heart medal
	Veterans whose discharge was for a disability that was incurred or aggravated in the line of
	duty
	Veterans with VA-rated service-connected disabilities 10% or 20% disabling
