OTC's Neighbourhood Plan allocated land for a community building as part of the Yardley Manor development. The building to be funded and built by the developer consortium as agreed with OTC. It was agreed with the consortium that OTC would engage with the residents to provide feedback. This planning application does not reflect any of Olney Town Council's requests for change of height or layout, or to ensure efficiency of construction to the latest building regulations. It was noted that their application was submitted the day before the building regulations changed. OTC are conscious that they should not be left with a building that will be a future drain on public funds or not be environmentally sound by embracing the latest renewable energy and low carbon technologies, such as solar panels and air sourced heat pumps.

Resolved: Cllr Tennant proposed, Cllr Varley seconded that Cllr Tennant continue to engage with the developer, to express our concerns that detail was not picked up, if necessary, to call it in to MKC DCC to resolve the issues. All agreed.
