OTC22/12/1: Apologies for absence, received from Cllrs Aldred, Bethune, Brock, Stokes Varley and Whitworth

OTC22/12/2: Declarations of interests on items on the agenda none were received.

OTC22/12/3: To approve the minutes of the OTC Meetings held 7th November 2022 Resolved: Cllr Prosser proposed, Cllr Tyler seconded that the minutes of 7th November 2022 be approved, all in favour.

OTC22/12/04: To receive a Ward Councillors report

Ward Councillor Hosking reported that the MKCC proposal for EV charging points on the Cattle Market car park needs feedback and noted it is an item on this agenda.

With reference to the A509 highway closure, MKCC did their utmost to keep disruption to a minimum by insisting that all services worked under the same closure notice. Whilst they undertook additional works in the area, a sinkhole was also discovered, which enabled the work to be rectified at the same time with just an additional day's closure, otherwise it could have been an emergency closure of an additional week's work after filling in and reopening at a later date.

Cllr Hosking added that the criticism of MKCC officers doing their jobs does not go down well. Legislation was covered but people just don't read signs. Our residents are now confused as to the responsibility of services, OTC councillors are not responsible for example planning, waste, housing and highways and should not get involved with responding on these matters, they should be directed to Ward Councillors.

It was noted that MKCC passed a motion to thank all Parish and Town Councils for all the work they undertake in their parishes.

OTC22/12/07: To receive reports from Councillors who represent at external meetings

Cllr Brown reported that he attended the Past Players lunch at the Rugby Club where they unveiled a memorial, Cllr Prosser also attended in her capacity as a Standard Bearer representing the RBL.

The CCTV is fully operational with excellent coverage. Volunteers will soon need to be advertised for.

OTC22/12/10: To approve annual events on OTC land

Clerk requested permission to approve regular events on OTC land as organisers need to be able to plan in advance. Notification of exact dates will be brought to council as usual. **Resolved:** Cllr Brown proposed, Cllr Rodden seconded to allow clerk to approve the use of regular events without having to wait for council approval, all in favour.

OTC22/12/11: To consider the proposal for twinning with Olney, Illinois

Resolved: Cllr Brown proposed, Cllr Prosser seconded that clerk to explore further, make contact with Olney, Illinois, and also advise the museum and schools, all in favour.

OTC22/12/12: To feedback on EV Charging points to Cattle Market car park

Resolved: Cllr Tennant proposed, Cllr Tyler seconded that clerk feedback support for EV charge points but request they consider installing as fast chargers as possible, to make the parking spaces available during the day and to suggest they consider security in the area, all in favour.
