VISION

Tulsa Honor Academy strives to follow local, state, and federal guidance to mitigate COVID-19 and its variants while maintaining in-person learning. THA's COVID-19 Plan will continue to evolve as conditions and guidance evolve.

MITIGATION STRATEGIES

- **Promote COVID-19 Vaccination**

- THA continues to promote vaccination for those who are eligible to be vaccinated. Vaccination requirements can be found [here](#).

- **Stay home when sick and get tested**

- THA will encourage daily symptom monitoring at home and at school but will not perform daily symptom checks at the door.
- If a scholar has 1 A symptom or 3 B symptoms, we will recommend the scholar or staff be sent home. If they do not go home, we will strongly recommend they wear a mask.

"A" Symptoms	"B" Symptoms
Fever > =100.4 F	Nasal Congestion/Stuffy Nose
Sore Throat	Runny Nose
Cough	Muscle/Body Aches
Difficulty Breathing	Fatigue
Diarrhea or Vomiting	Chills
New Loss of Taste or Smell	Nausea
Rash or new unexplained lesions	Loss of Appetite

Recommend staff/student be kept home or sent home if:	
Person has 1 "A" Symptom OR Person has 3 "B" Symptoms	

- Scholars and staff who have tested positive for COVID-19 will be required to isolate for 5 days with Day 0 counting at the first day of symptoms or the date of the test is no symptoms. For the 5 subsequent days, scholars may return but are strongly recommended to wear masks. For the 5 subsequent days, staff may return but must wear masks.
- **Encourage consistent and correct mask use when COVID-19 Community Levels are high.**
 - THA encourages consistent and correct mask use for everyone on school property or at school events when the COVID-19 Community Level is High.
 - Tulsa Honor Academy supports the decision of anyone who chooses to wear a mask at any COVID-19 Community Level.



- **Implement in-school testing programs.**
 - Scholars and staff may opt into an in-school rapid testing program through the [Oklahoma Schools COVID-19 Prevention Program](#). Testing forms are available at each school.
- **Encourage handwashing and respiratory etiquette.**
 - Signs are posted throughout the school about appropriate handwashing and respiratory etiquette.
- **Maintain clean and healthy facilities**
 - We clean our facilities each evening and have options for regular spraying, as warranted.
 - HVAC settings have been checked to maximize ventilation.

KEY CHANGES

- Physical distancing of 3 or 6 feet is no longer implemented.
- Case investigation and contact tracing will be used only in response to a school outbreak.
- Quarantining will not be required or recommended based on close contact.
