It is our time!

This is ECAMA's second newsletter and it is intended to keep our valued members abreast of key developments undertaken by or relevant to the Association in the second quarter and of the activities to be embarked on in the third quarter.

In a bid to increase its visibility and its relevance as an economic think tank, ECAMA resolved to establish a Research/Consultancy Unit in 2018. The establishment of the Research Unit is in line with its strategic goals that aim at building a proactive economic advisory institution that provides evidence based policy advocacy in the field of economics. The key role of the Research unit is to lead in conducting demand-driven and evidence-based research that would form the basis for policy advice to relevant stakeholders. At this stage, the Secretariat has started to respond to call for consultancy work that are falling within the area of research interest of the association. Since the Unit does not have adequate full time researchers, ECAMA is therefore reaching out to its membership willing to collaborate with the Association in undertaking consultancy or research work on various topical issues that will come forward.

Some of Key events and activities this quarter...

2018/19 Post Budget Analysis

Following presentation of the 2018/19 budget statement by the Minister of Finance, Economic Planning and Development on 18th May 2018,

the Association organized a budget analysis workshop on 28th May 2018 at Sunbird Lilongwe Hotel, in Lilongwe.

The main objective of the workshop was to provide a forum for economists, private sector and all interested parties to openly analyse the budget with the aim of identifying the key issues from the proposed budget. In the end participants made their objective and informed opinion on the opportunities and risks embedded in the proposed budget.

There, it was agreed that while the economic environment is favourable for growth, several risks remain in the implementation of the budget and growth prospects. Participants noted that electricity power shortages, huge government borrowing, corruption and weather shocks to agricultural sector remain major risks in implementation of 2018/19 budget. Besides, members noted that private sector was ignored in the proposed budget and this would also have a bearing on the economy.

Consultancy Work

Currently, ECAMA is working in collaboration with United Nations Development Program (UNDP) 'Malawi to review the national budget in order to determine its level of support towards the implementation of Sustainable Development Goals (SDGs) in Malawi. This involves undertaking a review of the National Budgets from 2016/17 focusing on expenditures related to the SDGs and determining how the budget allocations have aligned and support SDGs implementation .

This assignment is being done by the Secretariat and 2 members that have necessary expertise in this particular research area. Apart from raising resources for the association, it is also envisaged that such activities would help to raise profile of the association.
