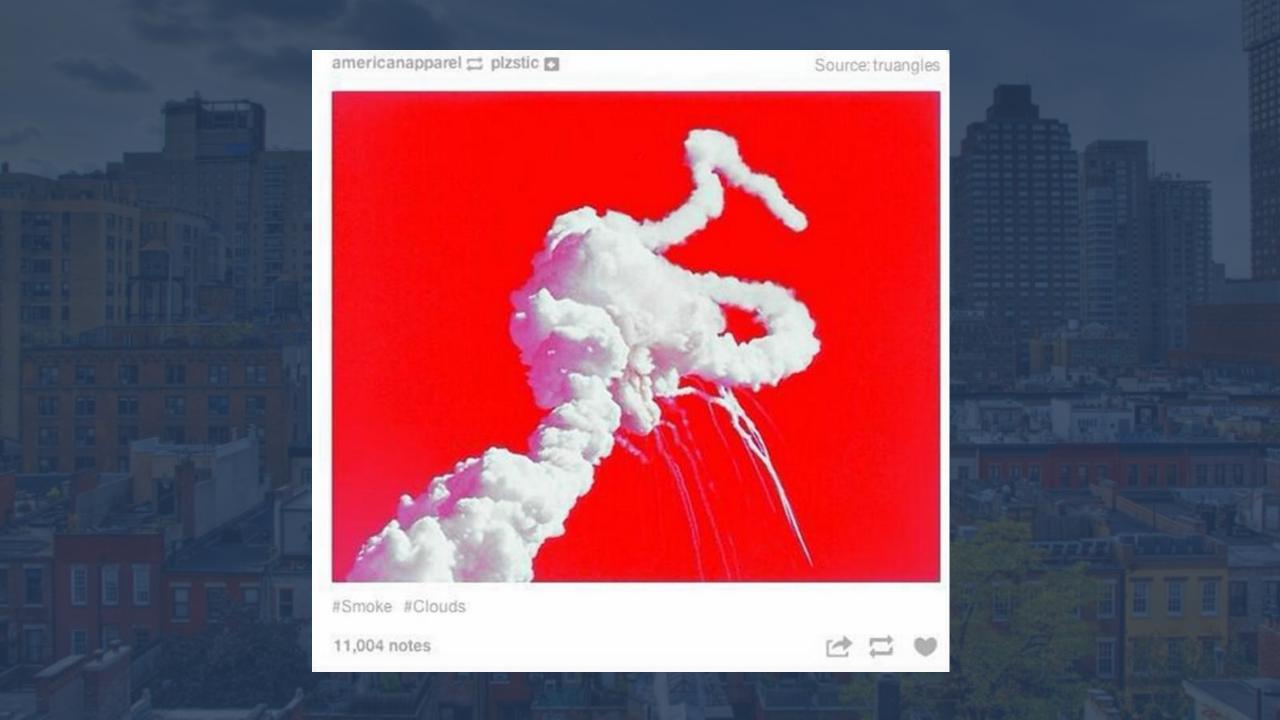


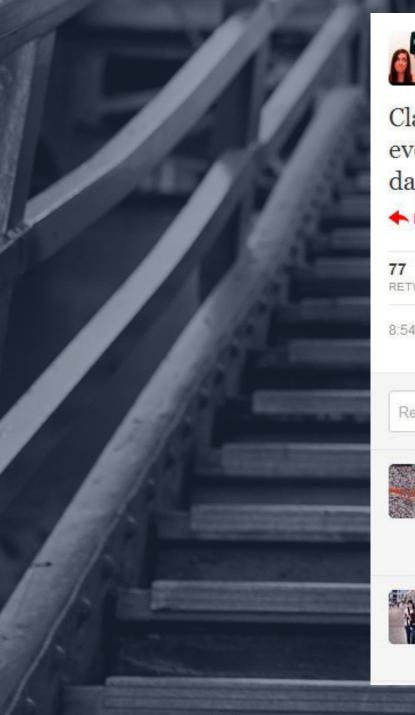


SOCIAL MEDIA DISASTERS

- Human error (People posting from the wrong account, awkward misspellings, etc.)
- Someone representing your organization says something that reflects poorly on your brand
- People catch you behaving badly
- Really bad decisions
- Disgruntled employees

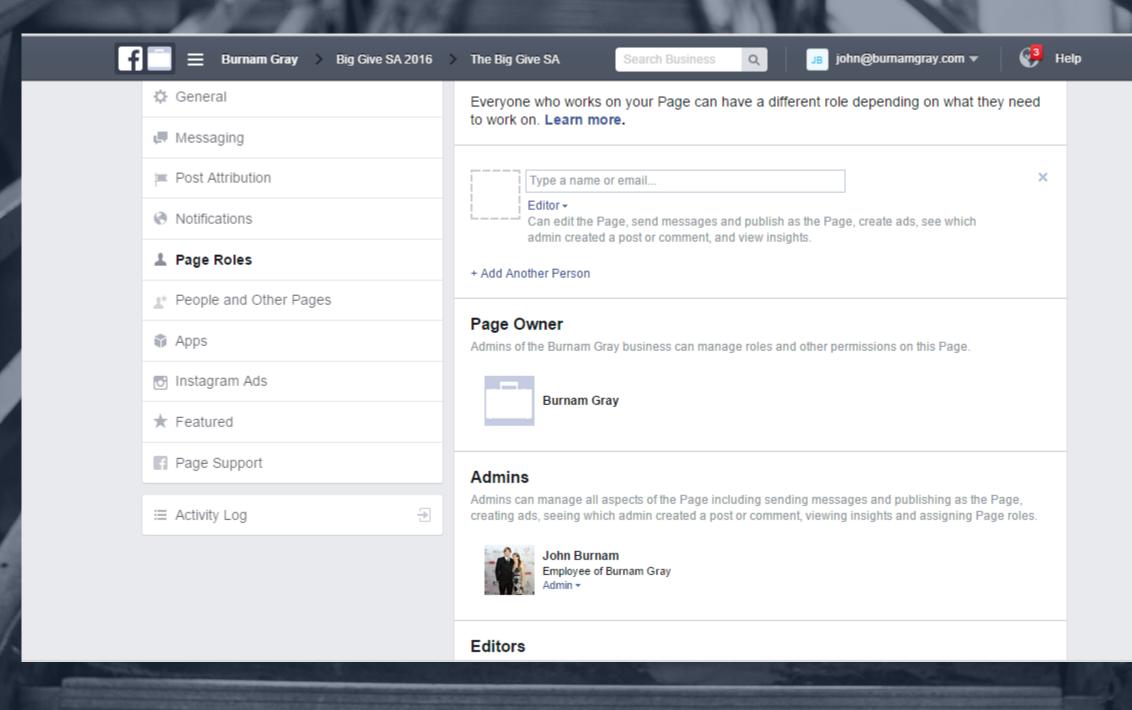
EXTERNAL POLICIES

What to remember

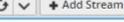
- Encourage staff to state who they work for when referencing work related materials
- Determine your line for posting at work: Who can? Who can't? What can people post?
- Lead by example

COMMON MISTAKES

- Admin settings are IMPORTANT
- Response protocols need to be in place
- Try to monitor the conversation
- Don't be overly restrictive

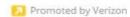
