Our way of life and our culture developed around this magnificent animal. We learned to hunt the buffalo skillfully with all of our members taking part in some way. We migrated northward with them in the summer and south again in the autumn to the winter camps. The Buffalo is most of all a Spirit Being; blessing the people with everything they needed to survive. The Cree People loved the Buffalo and the Buffalo loved the Cree.

Today education is our New Buffalo. We now rely on our education to provide our food, clothing and shelter. We are now developing new skills from our education in order to survive and succeed in the modern world. Our educational training and university degrees shall sustain us, our families and our people in the same way the Buffalo sustained us in the days of our Ancestors.

The Onion Lake Education Trust Fund has been established and designed to provide for the present and future generations of the Onion Lake Cree Nation. The Trust Fund has been developed to assist us like the herds of Buffalo did for countless generations.

The Buffalo are our brothers and sisters. They talk to us and if we listen, we can hear them.



## MESSAGE FROM CHIEF HENRY LEWIS

Education is the vehicle through which our young generations from Onion Lake Cree Nation come to realize their ambitions and goals. A quality education enables our students to achieve their academic pursuits and subsequently meet the challenges and demands of the highly competitive and globalized environment. It also enables the Onion Lake Cree Nation ("OLCN") to build the necessary capacity among our members in order to secure a successful future.

I have long championed the essential role of education in our community – its potential for creating more productive lives, for enabling individuals to reach their dreams and for being a source of great strength for our Nation in a changing and complex world.

The Onion Lake Education Trust Fund ("OLETF") has established itself to be a truly positive force for our students. Taking this into account, in 2022 the Onion Lake Chief and Council approved an agreement as between the OLCN and OTETF. This agreement provides for the payment of five percent (5%) of one of the Nation's royalty streams directly to OLETF from Onion Lake Energy. Chief and Council recognized and affirmed that the OLETF has become an important institution of the Nation and wanted to strengthen its financial position so that it can properly assist Onion Lake students for generations to come. Presently the agreement provides approximately one million dollars per annum paid quarterly.

Our corporate sponsors play a special role in the operation of the OLETF. Without their generous support we would not have the ability to assist our students at the levels that they are presently at. We very much appreciate their financial assistance with all of the donated funds going directly to Onion Lake post-secondary students.



I am also very proud of the OLETF Board of Trustees, past and present, for what they have accomplished for our members in a very short period of time. Their work will enable improved social and economic outcomes for our members and Nation as a whole.

Finally I want to thank each and every one of our students for all of their hard work, discipline and dedication towards their education. It is through them that a promising future is secured for all of us.

## MESSAGE FROM CHAIRMAN MATTHEW FOX

As Chairman of the Onion Lake Education Trust Fund, it is my honour to report to the Onion Lake Cree Nation membership on the activities of the Board of Trustees for fiscal year 2022-2023, our fifth year of operation.

Looking back on the last year and since our establishment six years ago, it is clear that our plan, our discipline and our goal to invest in the ongoing development of our students has been successful and paid out many dividends. The Board of Trustees has a steadfast dedication to assist our students and in turn our Nation for the better.

2022-23 was a very significant year for OLETF. After many months of discussions, the Chief and Council directed that the Board of Directors of Onion Lake Energy to annually set aside and contribute to the OLETF five percent (5%) of the SAGD BORR royalty revenues paid to the Nation pursuant to the Thermal Recovery Project Agreement. This is a game changer. OLETF is now on solid financial ground and will be in a good position to assist our students for the generations to come.

On behalf of the Board of Trustees, I wish to extend our great appreciation to Chief Henry Lewis and Council for their foresight and generosity to the OLETF. During the fiscal year 2022-23 the Trustees, after careful review, designated over one half million dollars as trust capital. Under the trust deed, trust capital can never be spent and is used to generate trust revenue for scholarships and awards. It is the intention of the Board of Trustees to continue to build up trust capital going forward for the long-term sustainability of the OLETF.

In addition, the number of OLETF corporate sponsors has grown substantially over the past year. We are incredibly grateful and thankful for their continued support. Our partners have truly made a difference for our deserving students. Since inception we have assisted 202 students with 387 scholarships with a value of \$374,650.



We wish to acknowledge all of our members pursuing their postsecondary education dreams for their hard work and dedication.

2022-23 was a major step forward for us. We have now solidified our commitment to Onion Lake students present and future. I also want to express my sincere gratitude to each OLETF Trustee for their invaluable insight and guidance. When leadership centres on serving others, great things happen.

## **BOARD OF TRUSTEES**

#### **Onion Lake Education Trust Fund Board of Trustees**

The Board of Trustees is required to administer the Onion Lake Education Trust Fund in the best interests of the Onion Lake Cree Nation and its members with care, skill and caution. The Trustees must act honestly and in good faith with a view to the best interests of the Trust, keeping in mind the beneficiaries of the Trust are both present and future generations of the Onion Lake Cree Nation.

The Trustees' overall management and administrative functions are defined by the OLETF Trust Deed. These include the duties and responsibilities to carry out the purpose of the Trust and to encourage, support and provide supplementary financial assistance to qualifying Onion Lake members attending full-time accredited post-secondary education institutions. The Board is responsible for all financial and administrative aspects of the Trust Fund and operates independently of Chief and Council, Onion Lake Education and the Onion Lake Administration.

The Board is made up of experienced individuals with expertise in education, board governance, policy making, finance, investments and student needs.

In accordance with the Trust Deed, the Trustees serve a three (3) year term and were all appointed by Onion Lake Chief and Council on September 10, 2021.

## THE YEAR IN REVIEW

The Onion Lake Education Trust Fund has established itself as an important vehicle for the means of ensuring strong support and supplemental financial assistance for Onion Lake students attending post-secondary institutions. The OLETF is a perpetual Trust that is established for both present and future generations of Onion Lake students.


Throughout the 2022-2023 fiscal year the Trustees were very active and carried out the following:

- Board of Trustees meetings were held in April, May, July, September, October and December 2022 and January and February 2023. Detailed minutes were taken at every meeting and copies are available to any Onion Lake member.
- Special Board meeting held in January 27, 2023 in Calgary, Alberta for Trustees to meet directly with investment Manager Michael Job and legal counsel Michael Flatters
- The Board reviewed a number of comprehensive written policies that were adopted to provide clear rules for the management of the Trust Fund.

- The Board of Trustees put in place an OLETF database system that was updated this year. The database is an effective and efficient way to keep track of all the information on scholarship applicants and recipients each year. In addition, the database contains information in relation to sponsors, amounts, stipulations and other information. This important tool assists the Board and administrative staff be accountable and to maintain continuity and consistency in its business and administrative affairs involving the Trust Fund.
- The accounting firm MNP LLP was engaged as independent external auditor for the 2022-2023 financial statements of the Trust.
- OLETF's website was updated during the year and allows for students to apply online for scholarships. The website provides all types of information about OLETF to Onion Lake members and the public (www.oletf.ca).
- During the fiscal year the Board of Trustees awarded forty-seven (47) scholarships for Fall Semester 2022 and forty-five (45) scholarships for Winter Semester 2023 to qualifying Onion Lake post-secondary students ranging from \$700 to \$2,500 each.

# Inspiring Today's Students to be Tomorrow's Leaders

- The Board of Trustees made many important decisions throughout the year in relation to the new agreement reached with OLCN for a five percent (5%) share of an OLCN royalty stream. \$694,111.44 was received from OLE during the fiscal year under the agreement.
- After considerable discussion, the Board, during 2022-23 year, deemed the amount of \$500,000 in two tranches as trust capital. Under the Trust Deed trust capital can never be spent and is used for investment to generate trust revenue for payment of scholarships and expenses.
- The Board of Trustees is quickly building financial stability for OLETF. The Trust reported trust capital of \$570.021 at the end of the fiscal year.
- Since the beginning of OLETF, the Board of Trustees have encouraged and financially assisted two hundred and two (202) Onion Lake Cree Nation students with 387 scholarships with a total value of \$374,650.
- OLETF was most grateful to secure additional funding once again through the Onion Lake Lands Department and their consultation process with third parties. Funds are provided for educational purposes to the Nation by various energy companies doing business on the traditional lands of the Onion Lake Cree Nation.
- Throughout the year the Board continued to develop a program to attract corporations and individuals to donate funds for student scholarships. The Board of Trustees has been able to secure contributions from over 35 generous corporations or individuals. In addition, OLETF has received a growing number of multi-year funding commitments from our corporate sponsors.



Linette Fox is OLETF's part-time administrator and bookkeeper. Linette comes to OLETF with many years of experience in accounts payable, rent rolls, data entry and a wide variety of administrative matters. She assists the Trustees with student applications, student scholarships, database, bookkeeping and general management of OLETF. She is a very important asset to the organization.

## Onion Lake Education Trust Fund

### Financial Overview

The OLETF investment portfolio is made up of high grade Canadian, U.S. and Global stocks and investment grade bonds. Approximately 30% is U.S. & Global stocks, 30% Canadian stocks, 35% Canadian bonds and 5% cash and equivalents. It is considered a safe, conservative investment for a trust fund like OLETF with a long-term investment horizon.

2022 will be remembered for a dramatic rise in inflation influenced by COVID-19 disruptions, pent up demand and the war in Ukraine. This created challenging conditions for stocks and bond markets alike producing a rare selloff for both the likes of which have not been seen in 40 years.


Leith Wheeler's investment portfolio proved to be much more resilient than their respective benchmarks in 2022. Although the return of -4.4% was disappointing, it was +5.0% higher than the benchmark of -9.4%. The total rate of return since inception of the OTETF was +9.8%, beating the benchmark of +8.9%.

### **OLETF Portfolio Asset Mix**

Onion Lake Education Trust Fund's portfolio ended 2022 slightly overweight in stocks relative to its benchmark. This was largely a product of stocks outperforming bonds in the latter half of 2022 and early 2023.

# MOST COMMONLY ASKED QUESTIONS & ANSWERS

# Regarding the Onion Lake Education Trust Fund

A It is an independent Trust Fund established in 2018 by the Onion Lake Cree Nation Chief and Council to assist and recognize qualifying Onion Lake Students financially through incentives, scholarships and award programs at the post-secondary education level. The Trust Fund will provide funding in addition to other financial assistance received by students such as Indigenous Services Canada

government funding, student loans, and parental contributions.

WHAT IS THE ONION LAKE EDUCATION TRUST FUND?

# WHAT IS THE PURPOSE OF THE ONION LAKE EDUCATION TRUST FUND?

A The purpose and mission of the Onion Lake Education Trust is to assist and encourage in the educational development of the human resources of the Onion Lake Cree Nation with the view for members to successfully complete their education at the trades, college and university levels and obtain a profession, occupation or skill that will benefit themselves and in turn Onion Lake Cree Nation as a whole.

HOW ARE THE BOARD OF TRUEES APPOINTED?

A Under the trust deed, the Onion Lake Chief and Council have the authority to appoint individuals to be Trustees of the OLETF to three (3) year terms. The terms of the present trustees expire in 2024. Chief and Council will make new appointments and/or re-appointments for Trustees of OLETF.

# WHAT ARE THE RULES THAT GOVERN THE ONION LAKE EDUCATION TRUST FUND?

A First and foremost is the OLETF trust deed which is the primary document that sets out the overall rules for the operation and must be followed at all times by the Board of Trustees. Copy of the trust deed is available to all Onion Lake members and posted on the OLETF website.

In addition to the trust deed, the Board of Trustees has and will develop detailed written policies in all areas of the administration and financial operations of the Trust including student incentives, scholarships and awards. These are also posted on OLETF's website.

The Board of Trustees must also publish an annual report each year for distribution to the membership detailing their activity during the year and must include audited financial statements.

# HOW MUCH MONEY DOES ONION LAKE EDUCATION TRUST FUND HAVE AND CAN IT BE SPENT?

A No, not all the money can be spent. The Trustees can only expend trust revenue generated from the trust capital. They can expend funds provided directly through donations for scholarships. The capital base of the Trust Fund, which is presently \$550,000, is held forever in trust for educational purposes for Onion Lake Cree Nation members and can never be spent. It is hoped that trust capital of the OLETF will grow to millions of dollars over time in order to support all post-secondary students and take into account Onion Lake Cree Nation's fast-growing population.

# ARE THE INVESTMENTS MADE WITH TRUST FUNDS SAFE?

A The Board of Trustees manages the Trust Fund's investments to earn the best possible rate of return consistent with safety. The trust deed itself sets the strict boundaries and restrictions for the types of investments that can be made. Trust capital of the OLETF is presently invested in a conservative portfolio of stocks and bonds with the well-known investment firm Leith Wheeler Investment Counsel. Quarterly reports from the investment manager are available to Onion Lake members.

# WHICH STUDENTS QUALIFY UNDER ONION LAKE EDUCATION TRUST FUND POLICIES?

A Onion Lake students who are accepted to or attending accredited post-secondary educational institutions on a full-time basis for technical trades, college and university programs. The student's name must also appear on the membership list controlled by the Onion Lake Cree Nation to qualify under the Trust. Restrictions apply since the Onion Lake Trust Fund trust funds are limited.

# DOES THE TRUST FUND PAY FOR TUITION, BOOKS, ACCOMODATION, TRAVEL AND SUPPLIES?

A No. The Trust Fund will only provide general financial support through scholarships to qualifying Onion Lake students. The Government of Canada through the Department of Crown-Indigenous Relations and Northern Affairs Canada has a first-line Treaty obligation and trust responsibility for the payment of all tuition, accommodation, travel, books and supplies for Onion Lake students.

Funding from OLETF is only supplementary to any financial support from Indigenous Services Canada through Onion Lake's Post-Secondary Office or elsewhere.

# ARE THERE ANY SCHOLARSHIPS CURRENTLY AVAILABLE FOR ONION LAKE STUDENTS?

A Yes. The OLETF has developed a scholarship program for Onion Lake post-secondary students. Through the generous support of its sponsors, the Board of Trustees has now secured funds for numerous scholarships from \$700 to \$2,500 that will be provided to successful applicants attending full-time accredited post-secondary institutions in Canada in the Fall and Winter semesters.

It is hoped that many more scholarships, awards and incentives for Onion Lake students can be offered in the future as the OLETF student Program grows.

## HOW CAN STUDENTS FIND OUT IF THEY QUALIFY?

A Students need to read the policy guidelines and will also need to fill out a scholarship application form online. They may also be required to supply the Onion Lake Education Trust Fund with additional documents such as letter of acceptance, transcripts and other information in accordance with prescribed rules and deadlines.

Students can apply online for scholarships awarded during the Fall and Winter semesters. Application, deadlines, guidelines and policies can be viewed on the OLETF website at www.OLETF.ca

# Independent Auditor's Report

#### To the Members of Onion Lake Cree Nation:

#### **Opinion**

We have audited the financial statements of Onion Lake Education Trust Fund (the "Trust"), which comprise the statement of financial position as at March 31, 2023 and the statements of operations, changes in net assets and cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies. The financial statements have been prepared by management of Onion Lake Education Trust Fund in accordance with the financial reporting requirements of the Onion Lake Cree Nation Education Trust Deed (the "Trust Deed").

In our opinion, the accompanying financial statements of the Trust for the year ended March 31, 2023, are prepared, in all material respects, in accordance with the financial reporting requirements of the Trust Deed.

### **Basis for Opinion**

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of

the Financial Statements section of our report. We are independent of the Trust in accordance with the ethical requirements that are relevant to our audit of the financial statements in Canada, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

# Emphasis of Matter – Basis of Accounting and Restriction on Distribution and Use

We draw attention to Note 1 to the financial statements, which describes the basis of accounting. The financial statements are prepared to assist the Trust to comply with the financial reporting requirements of the Trust Deed. As a result, the financial statements may not be suitable for another purpose. Our report is intended solely for the Members of Onion Lake Cree Nation and should not be distributed to, or used by, parties other than the Members of Onion Lake Cree Nation. Our opinion is not modified in respect of this matter.

#### Other Information

Management is responsible for the other information. The other information comprises the information, other than the financial statements and our auditor's report thereon, in the 2023 Annual Report.

Our opinion on the financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial statements, our responsibility is to read the other information identified above and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated.

We obtained the 2023 Annual Report prior to the date of this auditor's report. If, based on the work we have performed on this other information, we conclude that there is a material misstatement of this other information, we are required to report that fact in this auditor's report. We have nothing to report in this regard.

# Responsibilities of Management and those charged with Governance for the Financial Statements

Management is responsible for the preparation of the financial statements in accordance with the financial reporting requirements of the Trust Deed, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Trust's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting.

Those charged with governance are responsible for overseeing the Trust's financial reporting process.

# Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Canadian generally accepted auditing standards will always detect a material misstatement when it exists. Misstatements

can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with Canadian generally accepted auditing standards, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.

### Notes to the Financial Statements

#### For the year ended March 31, 2023

#### 1. Nature of the organization

Onion Lake Education Trust Fund (the "Trust") was established by the Onion Lake Cree Nation on January 23, 2018 to provide limited supplementary financial assistance to qualifying Onion Lake Cree Nation members through incentives and scholarships and to assist in other educational endeavours. This assistance is supplementary to the obligations of the Government of Canada. It is the position of the Trust that it is exempt from tax for income tax purposes based on advanced tax rulings for similar entities.

### 2. Significant accounting policies

The financial statements have been prepared in accordance with the significant accounting policies set out below to comply with the financial reporting requirements prescribed by the Onion Lake Cree Nation Education Trust Deed. The policies are:

### Trust Capital

The Trust Capital is subject to the terms and conditions of the Trust which requires the Trustees to hold and preserve the Trust Capital and to apply Trust Income in accordance with the purpose of the Trust.

#### **Trust Capital** (continued)

Trust Capital is defined in the Trust Deed as "all money and property of every nature and kind donated and conveyed or transferred to the Trustees for the Trust Purpose by Onion Lake Cree Nation Chief and Council, the Onion Lake Cree Nation, or by any other person, entity or government and designated by them as Trust Capital".

#### **Revenue recognition**

Trust Income "means all income of every nature earned, accrued or realized upon the Trust Capital and all monies and property donated, conveyed or transferred by Onion Lake Cree Nation Chief and Council or by any other person, entity or government and not designated by them as Trust Capital."

Trust Income is recognized on an accrual basis.

#### Investments

Investments are portfolio investments recorded at fair value. Fair value is determined by published price quotations and adjustments to fair value are immediately recognized in the deficiency of revenue over expenses.

They have been classified as long-term assets in concurrence with the nature of the investment.

#### 3. Investments

The Trust has investments of \$379,983 (2022 - \$45,038) in equities, \$188,879 (2022 - \$20,486) in fixed income and \$19,799 (2022 - \$2,038) in cash and short term investments as at March 31, 2023. The Trust had initially invested \$50,000 of Trust Capital. In the current year, the Trustees designated an additional \$500,000 to Trust Capital.

#### 4. Related party transactions

Included in corporate donations in the statement of operations are donations of \$929,441 from Onion Lake Energy Limited Partnership, which is related by common membership as it is owned by the Onion Lake Cree Nation.

These donations will be recurring going forward as the Trust reached an agreement on July 28, 2022 with Onion Lake Energy Limited Partnership for a transfer of 5% of the annual payments of the SAGD GORR royalties to be paid quarterly to the Onion Lake Education Trust Fund.
