



4a (Code:) (Expenses \$ 284,652 including grants of \$) (Revenue \$) Expeditions - EarthEcho Expeditions was launched to encourage middle and high school students and teachers to explore a critical ocean-based issue, engage students through learning materials designed from real-world data, and prompt them to act to solve the issue in their communities. This was accomplished through a series of videos, virtual field trips, and lesson plans.

4b (Code:) (Expenses \$ 218,824 including grants of \$) (Revenue \$) EarthEcho Water Challenge (formerly the World Water Monitoring Challenge) - EarthEcho International became the official coordinator of the EarthEcho Water Challenge in January 2015, assuming responsibility from the Water Environment Federation. The EarthEcho Water Challenge is an international education and outreach program that builds public awareness and involvement in protecting water resources around the world by engaging citizens to conduct basic monitoring of their local waterbodies, share their findings and protect our most precious resource. The program runs annually from March 22 (the United Nations World Water Day) until December 31.

4c (Code:) (Expenses \$ 132,327 including grants of \$) (Revenue \$) STEMExplore - STEMExplore highlights relatable voices and exciting life experiences to make careers in Science, Technology, Engineering, and Math (STEM) come alive. STEMExplore kindles youth interest in solving problems and becoming critical thinkers about the world around them. The program features a series of interactive videos profiling STEM experts and thought leaders from around the world meeting a critical need by fostering the next generation of STEM professionals.
