MINUTES OF THE REGULAR MEETING OF THE HOLBROOK CITY COUNCIL HELD ON June 24, 2021

CALL TO ORDER: Mayor Young called the meeting to order at 6:00 p.m.

<u>PLEDGE OF ALLEGIANCE/INVOCATION:</u> The Pledge of Allegiance was led by Councilmember Dixon. The Invocation was given by Randolph Hollinsworth from St. Johns Baptist Church.

CALL TO THE AUDIENCE FOR ITEMS ON THE AGENDA: None

NEW BUSINESS:

- a. Navajo County Historical Society annual report Jolynn Fox was unable to attend the Council Meeting, but she did provide the Council with a copy of the Historical Society's annual report.
- b. Navajo County Fair Grounds annual report—Mike Sample shared that the Fairgrounds have been acting as a boarding facility for the animals of fire evacuees. He also shared all the upcoming events that the Fairgrounds will be hosting, including upcoming barrel races, rodeos, the Navajo County Fair and the Annual Demolition Derby. Councilmembers Dixon and Woolford thanked the Fair Board for all of their hard work and for repairing some of the buildings.
- c. Holbrook Chamber of Commerce annual report Cindy Tafoya reviewed the five (5) goals that The Chamber of Commerce has been working to achieve. She explained that many of these goals were put on hold last year because of Covid, but they are back on track now.
- d. Rezone 115 E. Hampshire Street from R-C Residential-Commercial to C-2 General Commercial Zone- Mike Sample stated that the Planning and Zoning Committee met on May 20th and that all criteria was met. The Planning and Zoning Commission recommended that the Council approve the requested Zone change.

Andrew and Jenny Kreighbaum introduced themselves as new residents in the area. They have 10 children. They shared that they were "drawn" to Holbrook and have a desire to bring hope to the town. They are interested in opening a new laundry-mat, as they feel that it is needed in the community.

SUMMARY OF CURRENT EVENTS-MAYOR:

Mayor Young thanked the Fair Board for the use of the Fair Grounds to help evacuees and community members. He also thanked the Coconino Humane Society and local businesses for helping those in need during the fire evacuations. Mayor Young encouraged citizens to pray for the safety of the 1000's of fire fighters who are putting their lives at risk. He also reminded the citizens that the Annual Firemen's BBQ will be held on the 4th of July and will offer dine-in or drive through.

SUMMARY OF CURRENT EVENTS-COUNCILMEMBERS:

- *Vice Mayor Payne thanked everyone including the School District for all they did during the evacuations. She said she is grateful that the Wyrick Fire has calmed down and said to pray for rain.
- *Councilmember Marsh thanked everyone that helped our neighbors during the evacuations. He also shared that every acre of National Forest and State Lands is closed.
- *Councilmember Nilsson attended a virtual NACOG meeting. He said that there are grants for safety related highway projects.
- *Councilmember Woolford gave a shout-out to the community of Holbrook for the shelter that they gave animals and evacuees. Many donations were given. He shared that he was in the Rodeo-Chedeski Fire and knows what it feels like to be in need.
- *Councilmember Kester told Andrew and Jenny Kreighbaum that they will enjoy the Fireman's BBQ and the fireworks in Holbrook

SUMMARY OF CURRENT EVENTS-CITY MANAGER:

City Manager Soltis stated that Holbrook is being used as an evacuation site for those fleeing fires. Thank you to all who helped the evacuees.

The small swimming pool is showing its age. Cracks have surfaced and unfortunately there are sharp edges that can be harmful. The City is in the process of resurfacing the pool to make it safer. He asked for patience.

The City replaced the swimming pool sink and shower boiler with an efficient heater system. Unfortunately, the pool heater is original equipment and will also need to be replaced. The City is in the process of researching our options.

The fourth of July is quickly approaching. City Hall will be closed on July 5th in honor of the holiday. Please have a safe and enjoyable break.

ORDINANCE NO. 21-06

AN ORDINANCE OF THE CITY OF HOLBROOK, ARIZONA, LEVYING A PRIMARY PROPERTY TAX UPON THE ASSESSED VALUATION OF PROPERTY LOCATED WITHIN THE CITY SUBJECT TO TAXATION, FOR THE FISCAL YEAR ENDING JUNE 30, 2022

WHEREAS, in 2019 residents of the City of Holbrook passed a primary property tax; and

WHEREAS, the City Council has the authority to levy and collect taxes for the general expenses of the City and all lawful municipal purposes per Holbrook City Charter Section 6.02(a); and

WHEREAS, a public hearing was held on July 8, 2021 to discuss the budget; and

WHEREAS, pursuant to State law, an ordinance levying taxes is required to be adopted no later than the third Monday in August; and

WHEREAS, Navajo County is the assessing and collecting authority for the City of Holbrook.

NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF HOLBROOK:

SECTION 1: There is hereby levied a rate of \$0.5062 on each one hundred dollars (\$100.00) of assessed valuation of all property located within the corporate limits of the City of Holbrook, except such property as may be exempt by law from taxation, a tax rate sufficient to raise the amount of \$104,954 as required in the Fiscal Year 2021-2022 budget.

SECTION 2: Per State law, this ordinance shall become effective upon adoption.

SECTION 3: The City Clerk is directed to transmit a certified copy of this Ordinance to the County Assessor and the Board of Supervisors of Navajo County, Arizona.

Subject: Transfer Station Waste Hauling

Discussion: The transfer station waste hauling was put out to bid. Larson Waste and Waste Management of Arizona, Inc. bid on the hauling.

Blue Hills current rate: \$350.00 to swap two 40-yard units + \$24.00 per ton.

Larson Waste bid: \$850.00 to swap two 40-yard units + \$60.00 per ton.

Waste Management bid: \$94.00 to swap one 40-yard unit + \$40.25 per ton.

Cost example for 7.25 ton average per 40-yard (May 2021):

Blue Hills: \$350.00 + \$348.00 = \$698.00

Larson Waste: \$850.00 + \$870.00 = \$1,720.00

Waste Management: \$188.00 + \$583.62 = \$771.62.

Fiscal Impact: The lower bid will result in cost savings. As the Sanitation Fund has been running in the deficit, this will help in providing funds for much needed capital upgrades.

Recommendation: Approve the bid submitted by Waste Management of Arizona, Inc.
