City Council may generally not discuss items that are not specifically identified on the agenda, except in certain circumstances. Therefore, pursuant to A.R.S. § 38-431.01 (H), action taken as a result of public comment will be limited to directing City staff to study the matter, responding to any criticism, or scheduling the matter for further consideration and decision at a later date. Items on the agenda will not be heard or discussed in Call to the Public. Video or audio tapes or other overhead visual aids may not be presented during these public appearances. All speakers should begin their remarks by stating their name and address for the record.

**Requests to have an item discussed on a future agenda should be presented on the "Request and Petition of citizens to City of Holbrook Council" form during the Submission of Written Petition for Items Not on the Agenda to the Council at a regular meeting. Once this form is submitted, the Council will consider the petition and a response will be given within 31 days per the Holbrook City Charter Article II, Section 2.18.

Unauthorized remarks from the audience, clapping, stomping of feet, yelling or any similar demonstrations are also prohibited. Violations of these rules may result in removal from the meeting. Individual members of the public body may respond to comments made by others who have addressed the public body.

The Holbrook City Council may discuss or take legal action on any item listed on the Agenda.

SUMMARY OF CURRENT EVENTS-COUNCILMEMBERS:

Councilmember Marsh wished everyone a safe and happy time at the Navajo County Fair.

Councilmember Woolford attended the Arizona League of Cities and Towns Conference. He said that it was very enlightening. He attended the early session and was excited to learn that most Arizonians are on the same track when it comes to "What Arizona Wants". Councilmember Woolford also attended a session on Recycling. He said that he has lots of hope for the future.

SUMMARY OF CURRENT EVENTS-CITY MANAGER:

City Manager Soltis attended the League of Arizona Conference. He stated that it was a great conference. He added that It is always good to connect with colleagues and to get ideas for our community.

The Apache County Coalition, which includes Holbrook, was awarded a \$600,000 brownfield assessment grant. The money can be used for brownfield site inventory, community outreach and engagement, site assessment, asbestos and/or lead-based surveys of buildings to support renovation, cleanup and reuse planning.

The goal is to have at least one project per community. Mr. Soltis will keep everyone posted on how the funds may be used in Holbrook.

Northern Arizona Council of Governments (NACOG) has a vacancy on the Economic Development Council (EDC). If anyone is interested in this position, please let Mr. Soltis know.

The City of Holbrook is in the process of replacing the lights in the gym. The lights are at the end of their life expectancy – 50,000 hours. Our local supplier only had a limited supply available. Additional lights have been ordered. Please be patient.

There has been some vandalism at the Petroglyphs. City staff have installed cameras. Hopefully this will prevent other acts of vandalism.

One of the rear walls of the Bucket of Blood buildings has collapsed. City staff are looking into how the wall may be repaired.

Community clean-up day is this Saturday. Check-in is from 7:30 – 8:00 am at the Courthouse. Bring gloves, rakes, shovels, and brooms.
