Individual members of the public body may respond to comments made by others who have addressed the public body.

MINUTES OF THE REGULAR MEETING OF THE HOLBROOK CITY COUNCIL HELD ON April 13, 2023

CALL TO ORDER: Mayor Smith called the meeting to order at 6:00 p.m.

<u>ROLL CALL:</u> Mayor Kathleen Smith, Vice Mayor Francie Payne, Councilmembers Robert Black, Tim Dixon, and Mike Nilsson appeared in Council Chambers. Councilmember Karina Pack participated via phone. Councilmember Arcenia Pacheco was excused.

CITY STAFF: City Manager Ted Soltis and City Clerk Lisa Hunt.

<u>PLEDGE OF ALLEGIANCE/INVOCATION:</u> The Pledge of Allegiance was led by Vice Mayor Payne. The Invocation was given by pastor Ken Clay.

CONSENT AGENDA:

March 23, 2023, Regular Meeting minutes and March 23, 2023, Work Session minutes.

<u>CALL TO THE PUBLIC FOR NON-AGENDA ITEMS:</u> Steven Carbonneau requesting that updates be made to the parks.

<u>CALL TO THE PUBLIC FOR AGENDA ITEMS:</u> For the Zone Change request, David Smith provided the Arizona Department of Housing (ADOH) Year 2014 Mandatory Design Standards for Multifamily Rental Housing.

NEW BUSINESS:

a. Public Hearing – Zoning Change: Kevin Clancey, FTMSNYC LLC, DBA Veterans Services USA, Parcel 109-18-088, located at 700 -720 Navajo Boulevard: change from C-2 General Commercial to R-C Residential Commercial. Mike Sample, Chairperson of the Planning and Zoning Commission, shared that the Commission recommended the zone change be approved with stipulations. Kevin Clancey asked the Council to approve the recommendation of the Planning and Zoning Commission. He stated that he would talk to his partner about meeting the stipulations, although he said he didn't know if the stipulations could be met. David Smith requested that the apartments meet the minimum ADOH size standards.

The Council opened the Public Hearing at 6:14 pm. Kevin Clancey shared the updates to the property and the work that they have done to build a good clientele.

The Public Hearing was closed at 6:20 pm.

The Council held a discussion. A motion was made to table the zone change.

ROLL CALL VOTE: Councilmember Black "Aye", Councilmember Dixon "Aye", Councilmember Nilsson "Nay", Councilmember Pack "Aye", Vice Mayor Payne "Nay", and Mayor Smith "Aye".

- b. General Plan Timeline and Discussion Mayor Smith shared an updated timeline. She had added a Technical Advisory Committees (TAC). Council had discussion and scheduled appointments for the 2nd Council meeting in May.
- c. Budget Timelines and Priorities Mayor Smith asked City Manager Soltis about the timeline for the Budget. He said that the Budget work session will be on May 25th. The Tentative Budget is scheduled for June 8th. The final budget will be presented on June 22nd. A discussion was held related to public input.
- d. Charter Review Discussion and Timeline Mayor Smith reminded Council that every four years the Charter needs to be reviewed. She proposed that the Council appoint a committee the same way that the Planning and Zoning Commission members are appointed. She added that she would like the City to advertise on the Water bills and the City web site.
- e. Proclamation: Fair Housing Month Mayor Smith read the Fair Housing Month Proclamation.
- f. Proclamation: Happy Holbrook Month Mayor Smith read the Happy Holbrook Month Proclamation.

SUMMARY OF CURRENT EVENTS-MAYOR:

- -Mayor Smith said "Thank You" to the Little League for a successful Easter Egg Hunt. She heard that it was a lot of fun and a great success.
- -She gave a shout out to all the volunteers and the cast for the Holbrook Jr High production of Annie Junior.
- -The Holbrook Chamber of Commerce is hosting their Holbrook Clean-up on April 22 from 7:30 am- Noon.
- -Save the Date Old West Fest is moving to June this year, June 9 10. They have a lot of great events planned and are partnering with the Navajo County Fairgrounds - Rodeo, Races, Games, Battle of the Bands and more.
- -The Holbrook Levee is a great place to walk and to ride a bike, but it is not for motorized vehicles. Please be respectful.
- -Keep sending in your Happy Holbrook nominations. It has been wonderful again to highlight some of our citizens and share a little bit about each of them. We really do have some great people in Holbrook.

Subject: Zone Change: Kevin Clancey, FTMSNYC LLC, DBA Veterans Services USA, Parcel 109-18-088, located at 700 - 720 N. Navajo Boulevard; change from C-2 General Commercial to R-C Residential Commercial.

Discussion: Council tabled the Planning and Zoning recommended rezone to provide time to research information introduced at the April 13, 2023 Council meeting.

The document that was introduced titled "Arizona Department of Housing (ADOH) Year 2014 Mandatory Design Standards for Multifamily Rental Housing" does not apply here. The exhibit only applies to new, site-built rental housing financed by ADOH.

The nation is dealing with hotels/motels turning into housing due to the lack of affordable housing. While it may be desirable to introduce standards for rental housing, these considerations are not applicable to a rezone.
