Bond Sale

Commissioner Daniels said that the District will be holding its annual bond sale next month for approximately \$3 million, which will provide the remaining funding for the current year capital projects.

OSLAD Grant

Mr. LaFrenere said that we hosted an open house last week regarding the OSLAD grant process to make sure that public input was received. We will be holding another public input open house on September 25th. This application includes a shade structure, outdoor restrooms and an educational presentation area at Spring Valley. A copy of the presentation that was done that night is included in BoardDocs. Commissioner Schmidt thanked Mr. Brooks and Mr. King for their great job that they did with the presentation. He said it was well done, and they explained everything very clearly.

Events

Mr. Parsons said that this weekend they are having their Club Championship on September 15th and 16th. On Wednesday, September 19th they are hosting the Tap House

golf outing. This is a new event for them this year. He stated that on Tuesday, October 9^{th} they have 25^{th} District, which is tentative as it was rescheduled from Monday.

Mr. Ward said that they are hosting at 10 and under USTA event at STP this weekend. Today they had the conclusion of the senior Silver Games. There were 177 seniors participating in all of the activities. He said that Mary Poppins auditions are being done tonight and on Sunday. Mr. Ward said that they had a great Family Fun Night last Friday with approximately 450 people in attendance. He said that the Halloween Pooch Parade will be held on September 29th at the Dog Park. On October 12th they will be hosting Pumpkin Smash. They are also going to be doing a fitness event that includes smashing pumpkins and the pumpkins will be recycled.

Mr. Brooks said that the Harvest Bonfire will be held this Saturday from 6:00 p.m. - 8:00 p.m. They invited the public to come out to National Public Lands Day which is on September 22^{nd} . They will be collecting native plant seeds at this event. He said that they are preparing for the Autumn Harvest Festival on Sunday, October 7th from noon to 5:00 p.m. This is a big event for them and he can use all of the volunteers who may want to assist at the festival.

Commissioner Schmidt said that he and Commissioner DiMaria attended the open house at the Schaumburg Public Library. He said the theme focused around the book, The Namesake. Commissioner Schmidt said that they got a tour and it was a very well-done event. Commissioner Johnson said that he was very impressed with Mr. Sienkiewicz's email blasts. When no second is made

After a motion is proposed, if the motion requires a second and none is immediately offered, the <u>chair</u> of the body will usually ask, "Is there a second?" If no second is obtained within a few moments of proposing the motion, then the motion is not considered by the assembly, and is treated as though it was never offered (although it is recorded in the minutes). Such a motion may be introduced again at any later time.

If a motion which requires a second does not receive one, but is discussed or voted on anyway, it is too late to object to the motion on the grounds that a second was not offered. This is because the purpose of the second has been fulfilled: the assembly is obviously willing to consider the motion.^[4]

A <u>point of order</u> that a motion is not in order for lack of a second can only be made before any discussion or vote has taken place on the motion.^[5]
