#### CALL TO ORDER

#### ENGINEER BILL LIST REVIEW

Commissioner Berg stated that he is recusing himself from approving the Engineer bill list as his firm has done work with/for Williams Architect and Gewalt Hamilton on past projects and is currently working on projects outside of the Park District and yielded the floor to Commissioner Mayle.

It was moved by Mr. Hager, seconded by Mr. Osten to recommend that the Park Board approve the Engineer bill list in the amount of \$17,880.00 as presented.

#### FINANCIAL STATEMENT REVIEW

Mr. Burgess reviewed the financials for the month of August, five months into the fiscal year. Mr. Burgess stated that the General Fund year-to-date is at \$1,391,135. The "Other" line item is higher this year due to Olympic Park field rentals as well as higher interest rates. Under Expenditures, year-to-date totals are at 33% of the budget where the benchmark is 42%. Mr. Burgess is projecting a year end surplus of \$1,532,518.

In the Recreation Fund, Mr. Burgess noted user fees at \$3,796,997 which is 83% of the budget with the 42% benchmark compared to last year at \$3,166,251. A large part of this year's increase is golf related and also the sales of passes. Mr. Burgess is projecting the Recreation Fund revenue to be 104% of its budget. Mr. Burgess is projecting a net surplus of \$1,505,687.

The golf course user fees in August were just about at its budgeted revenue, similar to last year. Mr. Burgess is projecting an overall end-of-year revenue of \$3,833,204. Under Expenditures, part-time salaries are running a bit high as the staffing was needed to keep the golf course in playable shape. Mr. Burgess is projecting a net surplus of \$1,125,264.

The year-to-date cash position is \$44,499,863.

Looking at the Recreation Fund by Facilities shows all categories in a good position compared to their budgets.

Mr. LaFrenere added that payroll costs have gone up compared to August last year as this August was a 3-payroll month which will adjust as we move through the year.

### REVIEW OF AUDIT REPORT (MEMO #B23-160)

Auditor Ron Amen presented highlights of both the Audit Report and Management Letter.

It was moved by Mr. Osten, seconded by Commissioner Johnson to recommend that the Park Board approve the audit report as presented.
