NOTICE IS HEREBY GIVEN that Section 7(e) of the Open Meetings Act (the "Act"), which provided that open or closed meetings of a public body, including its committees thereof, may be conducted by audio or video conference without physical presence of a quorum of its members, will no longer be in effect as of May 11, 2023 because Governor Pritzker's disaster declaration related to the COVID 19 pandemic expires on that date. Accordingly, the physical quorum of the Board of Park Commissioners of the Schaumburg Park District (the "Park Board") and of each of its committees, must be physically present for a member or members of the Park Board, or committee, to attend such meeting electronically, and then only in accordance with Part I of Schaumburg Park District Ordinance No. 20-04-1P, "AN ORDINANCE DEFINING MEETING AND ADOPTING PROCEDURES FOR ELECTRONIC ATTENDANCE AT MEETING (PART I) AND SPECIAL RULES AND PROCEDURES DURING THE COVID-19 PANDEMIC PURSUANT TO GOVERNOR PRITZKER'S EXECUTIVE ORDER NO. 2020-17 (PART II)" adopted April 9, 2020.

CALL TO ORDER

FINANCIAL STATEMENT REVIEW

Mr. Burgess reviewed the financials for the month of October. In the General Fund projections, Mr. Burgess pointed out the tax collections year-to-date amounts for this year compared to last year are out of line which is due to the timing of when the county issues the tax bills and payment deadlines. Mr. Burgess also noted the month-to-date increase in the "Other" column is due to interest income and Olympic Park rentals. Mr. Burgess is projecting a year-to-date net surplus of \$1,900,587.

In the Recreation Fund, Mr. Burgess compared year-to-date revenue to last year's and highlighted that this year's continues to grow and stated that this seems to be the trend over the last three years. Year-to-date expenditures are a bit higher than last year's but are trending down over the next couple of months to be back on budget. Mr. Burgess is projecting a net surplus of \$1,457,377.

In the Golf Course Fund, Mr. Burgess noted that this October's month-to-date compared to last October is mostly the same. Expenditures are a bit over its budget but are expected as the course has been generating revenue leading to more required maintenance.

In the Cash Accounts by Fund, Mr. Burgess highlighted total cash this year is \$41,911,128.62, which is ahead of last year's position, but the interest rates are quite higher over the last couple of years.

In the Recreation Fund by Facility, Mr. Burgess highlighted that the Sport Center is having a good year with a net of \$307,038. The other facilities are either on target or running ahead of their budgets.

TAX LEVY ORDINANCE REVIEW (MEMO #B23-199)

It was moved by Mr. Hager, seconded by Commissioner Mayle to recommend that the Park Board adopt the Tax Levy Ordinance as presented.

Mr. Burgess stated that a preliminary tax levy and rate of just over 4% were presented in October and that is now changing to 3.5%. The levy is totaling \$13,340,000.

Commissioner Mayle commended the work of staff to be able to lower the rate and Mr. LaFrenere added that the efficiency of teamwork from all staff across the district including our corporate sponsorships contributes.

PELL ORDINANCE REVIEW (MEMO #B23-200)

It was moved by Mr. Hager, seconded by Mr. Osten to recommend that the Park Board adopt the PTELL Ordinance as presented.
