Review new business-

Mayor Dodson made council aware of the request for donation from the Cullman County Sheriff's Department for \$500.00 for the Rodeo. No questions or discussion.

Mayor Dodson made council aware of the request for donation of \$1000.00 to Vinemont School for Character Education shirts for all students from kindergarten to 12th grade. No questions or discussion.

Mayor Dodson made council aware of the request from Vinemont Baptist Church to use the Community Center on July 3, 2022, for 4th of July Fireworks Show. Mayor Dodson made council aware of Sports Complex Park improvements using the ARPA Funds (\$16387.00) Breakdown is attached in minutes. Discussion followed.

Mayor Dodson made council aware of Community Center improvements/upgrades using the ARPA Funds (\$16105.00) Breakdown attached in minutes. Bonnie Goodwin asked about the sign in front of the Community Center we may need to look at replacing and would like to see it more advertised. Sonya Copeland also made council aware of the Town Sign by bridge may also need to look at replacing it to. Discussion followed.

Chris Thompson made council aware that he would like to do some additional beautification at the Walking Trail. Discussion followed.

Sonya Copeland made council aware that Vinemont Park and Rec Softball team will be attending the World Series in July and would like the council to consider donating some money for direct support, so the team and their families are able to attend. Discussion followed.


Richard Neese addressed the council asking if some of the ARPA money could assist in getting a law enforcement officer and assist in starting a court system. Discussion followed.


