Review of minutes and financials-Mayor asked council if any questions regarding the minutes or financials, no questions, or comments.

Review new business-

Mayor Dodson made council aware of the traffic light upgrade cost is \$10,000.00, \$7000.00 will come out of 7 Cent Account and \$3000.00 will come out of General Fund. Mrs. Copeland asked exactly what was wrong with light. Mr. Graves made her and council aware that a loop at the red light is malfunctioning.

Mayor Dodson made council aware of the resurfacing of Goodwin Road cost is \$65,000.00, \$19,083.00 out of Rebuild Alabama Account, \$20,000.00 out of Capital Improvement Account, and \$15,917.00 out of ARPA Account. Mr. Thompson asked how far down the town paving is, Mr. Graves made him and council aware that it will be the whole road and then the county will continue onto their side with the paving. Discussion followed.

Mayor Dodson made council aware that a pipe on Ridgeway Street needs to be replaced north of the fire department cost will be \$3,000.00 and funds will be used out of the ARPA Account. No questions or comments.

Mayor Dodson made council aware of the Freedom Fest that will be at the Vinemont School August 5, 2022, from 5-8. It has been presented to rent 1 or 2 bounce houses for the festival. Discussion followed

Chris Thompson made the mayor and council aware of his ideas and budget for a Art Park over by the Walking Trail and Community Center. The approximate cost would be around \$11,825.00. Discussion followed.




Mr. Neese has requested to be put on the agenda for the next council meeting.
