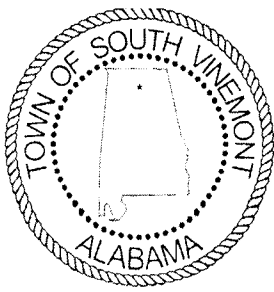

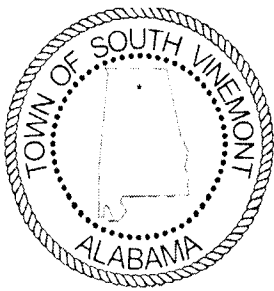


Clerk reminded mayor and council about the BBQ Event Oct 22nd and the Halloween Event at the school Oct 30th.
