Christmas in the Park-Tree Lighting December 3<sup>rd</sup> 4-6; Discussion followed.



Discussion followed.


Charlotte Cospers brought up the Community Center Sign and the Town Sign by the bridge needs some attention of repair or replacement. Discussion followed.
