The clerk made the mayor and council aware of the upcoming Easter Event, also gave update on the Senior Citizen program and exercise with attendance numbers and company sponsorship.





WHEREAS, the Alabama League of Municipalities (the "League") is hosting its annual convention from May 10th through May 13th, 2023, in Birmingham, Alabama; and


