Review of minutes and financials- Mayor Dodson asked council if had any questions regarding the minutes or financials. Chris Thompson asked for an update regarding payment for the damage to the community center, clerk made him aware that a payment plan has been put in place and they are paying for it. Discussion was made regarding a deposit for renters.

Review new business-

Mayor Dodson opened discussion on adding additional items to Walking Trail/ Art Park using the remaining funds from the ARPA that were allocated for community center improvements and walking trail improvements. Chris Thompson wanted to confirm the cost of the pickle ball court and discussions followed. Charlotte Cospers asked if we can get additional quotes from other contractors, which may be cheaper. There was other discussion regarding reserving the pickle ball court and/or pavilion and rules.

The clerk went over the pros and cons of sanctioning with KCBS and what the town would be obligated to do regarding rules, regulations, cost, and timeline. Discussion followed.

Mayor Dodson opened discussion improvements to town hall using the ARPA funds for improvements to town hall, which would include flooring, bathroom-touchless faucet, toilet, soap dispenser and some other additional items. Sonya Copeland asked about whitewashing the outside of the town hall, Bonnie Goodwin asked about painting the inside of town hall, discussion followed.


