# **Update from School Resource Officer (Amended- Added Item)**

Officer Lindahl thanked Cedar Creek Township and all other funders of the program.

#### Wastewater Resolution:

Fees for wastewater and sewer services have changed due to a Memorandum of Understanding the County entered. This agreement was agreed upon by all municipal wastewater users. The MOU required that Cedar Creek Township redo its old Resolution to reflect the new agreement and to change the way in which invoicing Timberline Estates for expenses was managed.

**Motion** made to approve updated Wastewater and Sewer Resolution by Treasurer Jarvis, supported by Clerk Stamy.

## **Salary Resolutions:**

Supervisor Aerts explained that Board member salaries are reviewed each year. This year's Medicare Cost of Living Adjustment is 8.7%, which is what the township has been following. However, after thoughtful consideration and discussion with individual board members, we agree that a 5% Cost of Living Adjustment is the amount we are bringing forward.

Motion made by Trustee Beeman to accept the Cost-of-Living Adjustment data so that the Board could begin the discussion. Supported by Clerk Stamy and Trustee Wright.

Motion Carried.

Trustee Beeman shared his research into Cost of Living data and shared that the recently released COL adjustment is 8.7%. In some previous years, the COL adjustment has been as low as 0%, as it fluctuates with inflation and the true Cost of Living. He explained that the administration puts forth a lot of research and data to come up with their final percentage and he feels that the board salaries should be adjusted to reflect this data. He further explained that it's important for the township to attract talent by offering a fair, livable wage.

Members concluded discussions and ultimately agreed upon the original 8.7% COL adjustment. Individual motions as required by law were then set forth:

### **Computer Replacements:**

Motion to purchase new desktop computers for the Supervisor and Deputy Clerk, from the 2022 budget; and purchase a desktop computer for the Deputy Treasurer from the 2023 budget.

### **Senior Millage Municipal Grant**

Supervisor Aerts gave an update on planned expenditures for the Muskegon County Senior Millage Grant Funds. Outdoor recreation equipment will be purchased for the new park plan behind the township hall with funds from both the millage and ARPA. The remaining MCSM funds will be used for another apple drive this fall and a bag of groceries for senior residents. The Supervisor asked for approval to proceed with this plan.

**Motion** made by Clerk Stamy, supported by Treasurer Jarvis to approve fund expenditures. **Motion made by Roll Call vote.**

# **New Township Building Committee**

Clerk Stamy brought to the Board a request to form a special committee to investigate the feasibility of a new town hall building. This committee will research cost and seek out professional opinions and bring a proposal to the board based on its findings.

**Motion** made by Trustee Wright, supported by Trustee Beeman to approve the request to form a special committee for the feasibility of a new Township Hall facility.

Supervisor Aerts suggested that Clerk Stamy and Trustee Beeman be on this committee. They both agreed verbally.

#### **Public Comment:**

#### Two residents provided comments:

John Anderson took the podium to express his opinion on Board salaries and the new township building committee. He stated that he doesn't see salary increases of 8.7% anywhere and suggested the Board obtain second jobs if necessary to pay their bills. He also expressed concerns about the expense of constructing a new building and suggested the township investigate renting or leasing space instead.

Nancy Beeman took the podium to express her gratitude to the Board for their hard work. She stated that the current board has done more things for the residents of Cedar Creek than any

previous board and expressed her support for the salary increase, stating her understanding of the need to grow with the community.
