#### **Ordinance Enforcement Contract**

Supervisor Aerts explained to the Board that there is a growing need for ordinance enforcement; specifically for blight, in the township. Township citizens highlighted this in their Master Plan survey responses. Funds had not previously been specifically allocated for this, nor did the Zoning Administrator's schedule allow time for enforcement. A contract with Jeff Ream is being presented to the Board to outline a plan to enforce the Township Ordinances and address the growing number of blight complaints. The enforcement activity will be tracked in the software the Township currently uses, BS&A.
