# **Company Cookie Statement**

**Ltd KI Zeme** (hereafter – Company) uses cookies in order to improve the functionality of its official website (hereafter – the site), enhance its user-friendliness and maintain efficiency of the user experience. By using the site you agree to the placement of cookies on your device.

#### What is a Cookie?

A cookie is a small data file stored on a user's device in a process of browsing a particular website. Note that the Bank gathers anonymous cookie data which is not intended to identify a user; therefore, the use of cookies does not imply processing of the personal data.

### How do we Use Cookies?

The Company processes cookies for the following purposes:

- to remember the parts of site visited by the user to provide engaging content for the site visitors and further disclose issues that are topical for the users;
- to provide the smooth browsing experience for visitors by verifying and ensuring compatibility of the site with the device and browser version;
- to maintain the statistics on how often the users visit certain parts of the site, the data is implemented by developers of the site to tailor its usability and enhance the performance.

The Company is not going to use cookies for any purpose other than stated above.

### What Types of Cookies are Used by Company?

Regarding the lifespan, the Company uses the following cookies:

- 1. Session cookies, or transient cookies, are erased as soon as the user shuts the browser down after accessing its content. The session cookies remember what the visitor has chosen on a previous page to avoid repeated input of information during the session. The Bank uses session cookies in order to authenticate the user on the site, providing the browsing session to a site visitor.
- 2. Permanent (persistent) cookies, are saved on the user's end device to recognize his or her browser sessions and to know if there was any contact between the user's device and us before, and to identify the most popular sections of the site to offer more efficient user experience and ensure the device compatibility. For this scope of services, the processor gathers such information as device brand (producer), its interface language, browser data and an operational system data.

The site implements cookies of third parties, namely those of Google. The third-party service providers use the cookies that are saved on the end device to collect data on how the users surf the site, including the total number of visitors.
