PAAC Comments on Saskatchewan Lobbying Consultation Paper

Regina, SK – Thank you for your letter of March 7, 2013 asking the Public Affairs Association of Canada ("PAAC") for further comment on proposed legislation governing lobbying in Saskatchewan. The Saskatchewan Government has done an outstanding amount of policy analysis on lobbying legislation in Canada and the PAAC is in general agreement with most of the recommendations contained in the March 2013 Lobbyists Consultation Paper ("Consultation Paper"). Our comments below will relate to those recommendations we believe require further consideration.

1. 100 hour Time Threshold for In-House Lobbyists

The PAAC believes that the significant part of duties criteria or specific time thresholds tests for in-house lobbyists dilute the transparency of lobbying disclosure laws. The PAAC also suggests that in the interests of establishing a level playing field for all lobbyists that the same standards apply to both in-house and consultant lobbyists in respect of the lobbyist disclosure requirements. The complexity and difficultly of establishing any meaningful way to measure travel time, preparation time and time communicating with public office holders in calculating the 100 hour test, will lead to confusion among in-house lobbyists and the failure to disclosure lobbying activity.

In addition, the 100 hours tests for in-house lobbyists are often viewed by many stakeholders critical of lobbying activity as "loopholes" that mask the true amount and nature of lobbying. This undermines the key policy objective of establishing lobbying disclosure law: to ensure the transparency of lobbying activity among paid professional lobbyists.

2. Exemptions to Lobbying Registration Requirements

The Consultation Paper recommends that British Columbia approach be adopted in Saskatchewan for the municipal sector: in-house lobbyists in that sector will be exempt from registration unless they retain a consultant lobbyist who would then be required to register. The PAAC agrees with this approach. However, the PAAC does not support exemptions for Post-Secondary institutions that have in-house lobbyists and other non-profit organizations (that are not constituted to serve "management, union or professional interests"). We believe all organizations that employ in-house lobbyists should be required to register all of their lobbying activities. This would include charities, trade associations, unions and professional groups. Suggesting that some non-profit groups be exempt from the lobbyist registration requirements for employee's but not if they retain consultant lobbyists does not support the policy objective of full transparency and will undermine the legitimacy of their in-house lobbying activity.

To the extent that very small charities or other non-profit groups lack the administrative resources to comply with any lobbyist registration requirements, the PAAC suggests that the statue, through a specific regulation, allow for such groups to apply for an exemption to be judged on a case by case basis.

In summary, the PAAC fully supports the Government of Saskatchewan's intention to introduce a comprehensive lobbyist disclosure law. We believe that the time thresholds tests only function to obscure the key policy objective of such statutes and will leave the Government and Lobbyist Commissioner vulnerable to unnecessary criticism.
