

Our NurseLine nurses are available around the clock by phone to answer questions and provide guidance about specific health concerns, such as what side effects are to be expected from certain medications.



Get to know STAR Kids.

The first managed care program ever for Texans younger than 21 who receive disability-related Medicaid launches in Nov. 2016! Beginning Nov. 1, 2016, we will offer STAR Kids in the Harris, Hidalgo, Jefferson, Central Medicaid Rural Service Area (MRSA) and Northeast MRSA.

STAR Kids is for youth and children younger than 21 who receive a Supplemental Security Income (SSI) benefit or are enrolled in SSI-related Medicaid or the Medicaid Medically Dependent Children Program.

STAR Kids' covered benefits include:

- ✓ Prescription medications
- ✓ Primary preventive and specialty care
- ✓ Behavioral health assessment, treatment and support
- ✓ Private duty nursing
- ✓ Durable medical equipment
- ✓ Hospital-level care
- ✓ Long-term services and support
