



Sir,

We, the undersigned, ~~are the office bearers of~~ St. Mathew tenants association, comprising farmers cultivating their fields in a vast stretch of khazan land in Azossim. The farmers have been traditionally cultivating their fields for paddy, vegetables, such as chilies, onion etc. since times immemorial.

We would like to draw your attention survey no. 36/1-A, Azossim, Corpir agricultural land has started construction activities illegally without permission from the village panchayat.

The agricultural land is very fertile land in the basin of river zuari and farmers relied on cultivation for their food requirement livelihood. The construction activity recently which poses a severe threat to the agricultural activities of the farmers. Pipes and outlets which may release waste water has been fixed to the boundary walls. This will lead to pollution and destruction to our precious agricultural land and Zuari river creek(Rivulets) which is not even 20metres away. We urge your authorities to look into the construction project as it poses a series danger to our fields and livelihood.

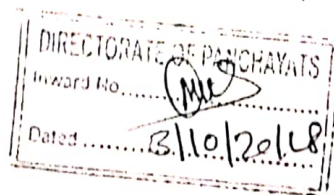
Sir,

We, the undersigned , St. Mathew's tenants association, Azossim and Azossim villagers wish to draw your kind attention to the fact that an unauthorized construction has been commenced in an area of khazan land bearing survey no. 36/1-A, in Corpir ward of Azossim village. The farmers cultivating their fields in a vast stretch of khazan land in Azossim.

The villagers, through various means, have raised the issue with panchayat authorities. Co-owners have sent proposal to raise the issue at gram sabha, an individual complaint has been lodged, based on which an inspection had been held. But as the gate was locked, the panchayat authorities and the villagers could not enter the place.

Dispite assurances following complaints, and through panchayat has said that no permissions have been issued, the work continues illegally. The whole project is in khazan land and near the rivulet and it will destroy and pollute the adjoining cultivable land and rivulet.

We the villagers of azossim and St. Mathew's tenants association hereby request the authorities to conduct an inspection at the site, an issue an order to stop the construction work as the panchayat has considered that the project has not been any sort of approval and construction license.



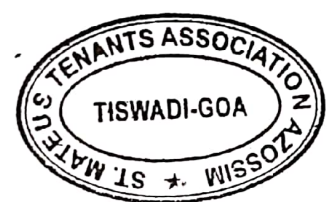
