UPON hearing the counsel the Court made the following
O R D E R

Pursuant to a Central Government's scheme, an area of 1,108 acres has been earmarked for rehabilitation of 54,159 families, 29,444 of which have some kind of title, and 23,237 appears to be encroachers.

Shri Gaurav Agrawal, learned Amicus Curiae, has filed a report before this Court in which he states that out of 36,000 apartments that are to be constructed, 4,352 are already completed and appear to have been allotted to 3,114

families. Another 8,000 are expected to be completed by the end of March, 2021.

We request the learned Amicus Curiae to have a meeting with Shri Sanjay Jain, learned Additional Solicitor General, together with the members of the High Powered Committee, the officers of the State of Jharkhand, as also the officers of the coal companies, in order to draw up an Implementation Plan for shifting this huge population in phases, from the coal field area to the earmarked area of 1,108 acres, about 5-7 kilometers from the coal fields.

The meeting to take place within two weeks from today. An implementation plan to be thereafter drawn up by the learned Amicus Curiae and be submitted to this Court within two weeks thereafter.
