Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to grant stay on taking possession and initiation of any kind of construction activities by the respondent authorities in the lands procured under G.O.Ms 123 dt.30.07.2015 in Etigaddda Kistapur and other villages for the proposed Komaravelli Mallannasagar reservoir, while allowing the agriculture operations to continue in the subject lands, pending disposal of the WP No. 17222 of 2018, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following order. (The receipt of this order will be deemed to be the receipt of notice in the case).

# ORDER:

The learned Additional Advocate-General takes notice on behalf of respondents.

In view of Section 38 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, which prohibits taking of possession until full payment of compensation as well as rehabilitation and resettlement entitlements are paid to entitled persons, including the petitioners herein who claim to be landless agricultural labourers entitled thereto under Section 16 of the said Act, there shall be interim stay as prayed for.
