THIS WRIT PETITION COMING ON FOR PRELIMINARY HEARING, THIS DAY, THE ACTING CHIEF JUSTICE MADE THE FOLLOWING:

ORDER

Ag.CJ (Oral):

1. This writ petition is filed as a cause in public interest. The prayer is to direct the Government to provide suitable burial grounds in the State.

2. Earlier, the petitioner had approached this Court in Writ Petition No.47746/2016 and pursuant to the order made therein, the Principal Secretary to Government, Revenue department, by letter dated 16.12.2016, has instructed all the Deputy Commissioners in the state to provide burial grounds as per several Government circulars already received in this behalf.

3. Petitioner does not state any particular town/village where no burial ground is provided. Hence, we find no WP No.49653/2017 ground to pass any further order relating to the petitioner's grievance. The writ petition is accordingly dismissed.
