The Government of Andhra Pradesh in G.O Ms No:15 Municipal Administration and Urban Development (H2) Department dt:01.02.2016 have notified the Machilipatnam Area Development Authority (MADA) for a total area of 426.16 Sq.Kms. comprising Machilipatnam Municipal Corporation, 28 Revenue Villages i.e including villages of Machilipatnam Mandal (27 villages) one village in Pedana Mandal in Krishna District as a Area Development Authority to achieve the objectives of the region witnesses tremendous growth in the domains of Industries, Imports and Exports etc.

There are several requests received from the willing land owners, who are residing outside the Machilipatnam Area Development Authority Area to extend the time limit for giving their consent in FORM – 3.
