The petitioners are directed to appear before the concerned officer on or before 30.12.2020 to record their statements.

It is however made clear that the present order would be subject to the materials may be available from the case diary. The case diary may also include the Enquiry Report of the Deputy Commissioner, Jorhat. The investigating agency may take all steps to ensure that the investigation is fairly done. The petitioners are directed to co-operate with the investigation and not to indulge any activity which is detrimental to the same.
