# Celebrate July 4th in Bear Valley!

Friday, June 30, the weekly 'Moonlight Movie' will be shown on the banks of Cub Lake. At dusk (roughly 8 p.m.), we will be starting the movie. Check with the Whiting Center for the movie choice. Snacks, and drinks, will be available for movie goers.

Our community celebration starts each morning with a pancake breakfast and colorful hot air balloons, at 6 a.m., at Beaubien Field. The breakfast and balloon flights are scheduled for July 1-2 and Tuesday the 4th this year. Monday will be only a couple of balloons, but no other festivities will take place since Monday is not considered a holiday. Head over to the pool for the day!

Balloon rides can be booked on four specific days in June, in person, at the Whiting Center: Saturday, June 3, from 9 a.m. to 1 p.m.; Sunday, June 4, from 2 to 5 p.m.; Tuesday, June 20, from 9 a.m. to noon; and Thursday, June 22, from 5 to 8 p.m., or until all spaces are filled. The deposit is \$50 per person at the time of reservation, with the remaining \$80 per flight due the day of your flight, in cash.

Balloons are a special part of our community celebration. They are beautiful, colorful, and go where the currents send them. You can communicate with the pilots by spreading a red cloth or sheet on your property if you do not want the balloons to land there, and on the flip side, a white sheet tells the balloonists they are welcome to land on your property! Some balloons may go up

on Wednesday to complete any flights with issues from the previous days. No reservations will be taken for that day.

The main festivities start on Saturday morning with the annual 5K Firecracker Run. New this year is the children's 1st Annual 'Sparkler' 1K! Check at the Whiting Center for the routes and general information. The Sparkler 1K is open to all.

The day continues with craft booths, a game area for kids, music, loads of food, fun and activities around the lake all day! The bands will be 'Divided Highway' on Saturday and 'Will Gail Dance?' on Sunday, both sponsored by Bear Valley Springs Realty.

The Waterwise Garden is holding a Grand Re-Opening on Saturday from 1 to 3 p.m., with docents to guide your tour. The Garden Club has been working hard to revamp and update this special place. Come and appreciate the results of their hard work.

Saturday morning is the annual decorated Freedom Boat Parade, followed immediately by the kayak and paddleboard races, both at 4-Island Lake. Even if you don't have a boat, this is a great spectator event with opportunities for very colorful photos. Check the tentative schedule for all the many activities this year! Our Annual Fishing Derby is held this weekend at both lakes. This year it will be a Crappie Derby with many prizes for families to win.

Sunday morning, all the fun starts all over again with balloons and pancake breakfast. The fun continues all day, with most of the demonstrations, fun, booths, etc., of the previous day. Sunday is also our Classic and Off-Road Independence Day Car Show. View the beautiful Classic Cars and custom off-road vehicles returning to the CSD

parking lot.

At 9 a.m., a worship service will be held at the main stage area of Cub Lake. Local Pastor, Kevin Boesler, will be speaking, with praise band music to accompany. There is no more fitting way to honor our country than to address the principles that our nation is founded upon.

July 4th is on Tuesday this year and Monday is not a national holiday. Because many do not have the day off from work, we have abbreviated activities. Following the balloons, there are no activities at the lake.

On Tuesday, join us for our Independence Day Parade starting at 10 a.m. Our two Grand Marshals this year are Don Kordes, a World War 2 veteran, and Art Ricketts, a Korean War veteran. We want you to know why we are paying tribute to these gentlemen as they are featured in the Grand Marshal vehicle. Thank them for their service! The parade starts at the Oak Tree Country Club. The parade route continues onto N. Lower Valley Rd. to the ball field, turns right and continues to end at Cub Lake. Spectators line the streets with folding chairs and children eagerly await the passing entries.

You'll see classic cars, scouts, horses, other animals (which must always be kept under control!), and of course families and friends from Bear Valley. Anyone wishing to enter the parade needs to fill out a Parade Registration Form on RecDesk. You MUST pre-register by June 29 to be in the parade this year! We need a release of liability form filled out for each person to be in the parade. Be a part of the community fun! Use your imagination – dress up in costume! Decorate your tractor, golf cart, or vehicle – just keep it positive, please. No negative political statements! Imme-

# Viewing June constellations

Humans are prewired to see patterns, sometimes even where no real patterns exist (pareidolia). When our ancestors looked to the sky in wonder, they often saw figures in the random scatter of stars – animals, people, etc. The stars reside in “heaven” and so their patterns were assumed to be gods or figures from mythology. This is basis of the constellations that have been handed down to us and many haven’t changed from antiquity. The constellations along the band of sky through which the planets travel were given special mystical status by astrologers. The International Astronomical Union has divided up the entire sky, looking much like country borders on a globe, resulting in the 88 constellations we officially recognize today.

Some of the easily recognizable constellations in the evening sky this month include:

**BOOTES** (bo-ooH-tees) – Bootes is traditionally represented as the Huntsman, with his dogs (the constellation Canes Venatici, the Hunting Dogs) at his side.

However, there are at least two other stories about him, one not so pleasant! Finding Bootes is relatively easy. The major stars of this constellation form a large kite shape. Follow the “handle” (tail) stars of the Big Dipper (Ursa Major, the Great Bear) out to the bright star Arcturus (“follow the arc to Arcturus”). Arcturus is the third brightest star in the northern hemisphere. East of Bootes is:



**CORONA BOREALIS** – Corona Borealis is the Northern Crown. In classical mythology the crown was set in the heavens by the Cretan princess Ariadne. She was given the crown by the god Dionysus. Corona Boealis is just east of Bootes, on the opposite end from Arcurus. It’s a much smaller constellation than Bootes, but is a very distinctive “U” shape. East of Corona Borealis is:

**HERCULES** – Hercules is a very old constellation, named

after the Roman hero (in Greek Heracles). Hercules was known for his unusual strength and many adventures. The constellation Hercules is very large, it’s the fifth-largest constellation in the sky. However, there are not any very bright stars in this constellation. Look for a large rectangle (called the Keystone) which is his torso. His legs point northward and his arms stretch upward to the south.

# Seven principles of water-wise gardening

There are two public water-wise gardens within Bear Valley Springs. These gardens, located near the road at the CSD Administrative Office and the road in front of the Bear Valley Market & Grill, provide an example of the varieties of water-wise plants that do well in our Valley. We invite you to visit and see for yourself the beautiful water-wise plants that thrive in our specific environment.

## **PLANNING AND DESIGN:**

Developing a landscape plan is the most crucial step in achieving a thriving water-wise landscape. A proper plan will consider the intended uses of the property, the lay of the land and existing vegetation, the regional zone and

micro-climates, winds, and most importantly, the zoning or grouping of plant material by their water needs. A plan also allows the landscaping to be done in phases. The homeowner or a landscape designer can do the planning.

## **SOIL ANALYSIS:**

On any given site, soil can vary from place to place. A soil analysis based on random sampling will provide information that can help determine proper plan selection and soil amendments. Soil amendments and compost can enhance clay or sandy soil by improving drainage, moisture penetration, and water holding capacity.

## **PLANT SELECTION:**

Most plants can have a place in the water-wise landscape. You should consider the plant's adaptability to the site and its ultimate size, shape,

color, and texture when selecting a species for your landscape. The most important thing to remember is to group plants according to their water needs. You can maximize water conservation by choosing plants that are drought-resistant and have minimal water needs.

## **PRACTICAL TURF AREAS:**

If possible, reduce the amount of turf by carefully planning its use, limiting it to smaller areas, and not depending on it for ground cover.

## **EFFICIENT IRRIGATION:**

A well-designed irrigation system conserves water. Using drip lines, micro-irrigation, or soaker hoses and watering deeply instead of frequently encourages roots to grow deep rather than shallow and wide. This simple practice is vital to building a drought-tolerant landscape.

## **MULCH:**

A thick layer of mulch allows water to penetrate better and assists soil in moisture retention, erosion prevention, weed deterrence, and regulation of root temperature. The depth is dependent on the location. Shaded areas and those protected from the wind require only 3-4 inches, while areas that receive full sun or wind may benefit from a 7-8 inch layer.

## **MAINTENANCE:**

Proper maintenance of the plants and irrigation system will preserve a water-wise landscape. When the first six principles are applied, maintenance is easier and less expensive. Because a water-wise landscape is usually healthier, it uses a minimum of fertilizer, pesticide, and other chemicals. 🐾

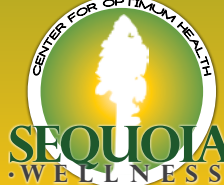

# Fishery update and 4th of July activities

The LQAC is happy to report that it appears the Bullhead Catfish population within Four Island Lake may finally be at a manageable level. As much as I would like to eliminate the Bullheads from our lakes, the primary objective of our harvest goal was to reduce the Bullhead population to a manageable level. The harvest rates have dropped significantly over multiple months; 50% in March and 75% in April. I expect this trend to continue as we harvest throughout the remainder of the year. Now that the Bullheads appear to be under control, the LQAC, at their May meeting, approved moving forward with Stocking Bluegills, Largemouth Bass,

and Red Ear Sunfish into Four Island Lake. The LQAC anticipates the fish will be delivered in late July 2023.

**LQAC Booth:** The LQAC will again have a booth setup at Cub Lake on July 1-2. This year, we've expanded and added a full slot for the kids touch tank area. Stop by to say hello and learn a little about how we manage our lakes. As always, we will have interactive activities for the kids to participate in.

**Fish Stocking:** To fully stock fish into Four Island Lake would require approximately \$72,000. To help offset these costs, the LQAC decided to fundraise over the July 4th weekend. We will have several guessing contests with prizes set up at our booth next to Cub Lake July 1-2. So please stop by and say hello. Your donation will help to offset initial



fish stocking costs. Two of the questions will be: How many pounds of gravel does it take to sink the LQAC boat? How many pounds of Catfish have been harvested since May of 2022?

**Free Hobie Kayak demos:** The LQAC has again teamed up with Copes Tackle and Rod shop from Bakersfield to offer free Hobie Kayak demos on Four Island Lake on Saturday, July 1, from 9 a.m. to 1 p.m. If you're feeling adventurous,

- **NO SNORKLES OR FACE COVERINGS OF  
ANY KIND ARE ALLOWED IN THE POOL.**
- **Do Not move the patio furniture!**
- Only authorized swimwear that is commercially sold will be allowed in the pool. No cut-off pants or shorts.
- **Each member 9 or older needs to show their  
Amenity Card at the pool gate.**
- Ice chests, coolers and similar containers shall not be brought into the pool area. However, they can be left outside the gate. (BVSA Rule 1103)
- Bringing alcoholic beverages into the pool area is prohibited.
- **NO SMOKING IN THE POOL AREA, THIS  
INCLUDES VAPPING**
- NO running, horseplay, or rough housing in the pool area is allowed.
- NO flips, twists, or jumping backwards into the pool is allowed.
- NO squirt guns, water balloons, hard balls, rafts, recreational type flotation devices, diving into shallow end, sitting on shoulders, climbing on rocks, or running in the pool area.
- NO vulgar or profane language in the pool area.
- Children 13 and under must be accompanied by a responsible adult. If they are 14 or older please bring your children to the gate to ensure they are admitted. (BVSA Rule 1102c).
- A maximum pool capacity of **93** in water will be in effect with a deck capacity of
- **Guests** will be charged a \$5 guest fee per day AND **MUST BE ACCOMPANIED BY A PROPERTY OWNER.** Limit of 3 guests per Track/Lot 13 yrs. old & older. Children 5-12 are \$3; children 4 and under are free. Amenity Passes (without the resident) will NOT be honored.
- All swimmers may be required to prove their ability to swim.
- Property Owners must be in good standing to enter the Pool area.
- Health Breaks, which consist of a 10-minute rest period for children 13 and under, requires that they are completely out of the water. These will be enforced every hour on the hour and only patrons 14 and up can swim during these 10 minutes. These breaks may be more frequent if capacity is reached.

## Preparing for power down

As we move into the summer and fire season, the likelihood of Public Safety Power Shutoffs (PSPS) increases. During past years Bear Valley Springs residents experienced hundreds of hours without power due to shut-off events during "red flag" fire weather. Sustained wind speeds, dry vegetation, low humidity, and high temperatures are some of the risk factors that determine the need for fire weather warnings.

### PSPS Process

When weather forecasts indicate an impending wildfire risk, power companies begin assessing the potential impact on the areas they serve. SCE has an established process for notifying residents directly, so it is essential to sign up for their alerts at [www.sce.com/safety/wildfire/pmps/pmps-alerts](http://www.sce.com/safety/wildfire/pmps/pmps-alerts).

First Notification (2 days): SCE will notify potentially affected customers about the possibility of a PSPS.

Second Notifications (1 day): SCE will again notify impacted customers that a PSPS event is likely

Third Notification (power shut-off): When the decision to make a power shut-off is made, a third notice is sent to impacted customers.

Fourth Notification (power restoration): Once weather conditions return to safe levels, field teams are sent to inspect the lines and ensure that power can be safely restored. Once restoration takes place, notifications are sent to customers telling them that power has been restored.

### Rebates for energy generation technology

If you would like to generate your power, the Self Generation Incentive Program (SGIP) could be a good option. The SGIP program offers rebates to customers who install qualifying types of distributed generation to meet all or a portion of their own energy needs. The rebates cover nearly 85% - 100% of the cost of an average energy storage system, depending on your situation. ### PSPS Preparation

Preparing now can make life more comfortable when the power goes out.

1. Update your contact information with Southern California Edison to ensure you receive PSPS updates. The website address for this is [www.sce.com/safety/wildfire/pmps/pmps-alerts](http://www.sce.com/safety/wildfire/pmps/pmps-alerts)

2. Have a personal safety plan in place for every member of your household (including pets).

3. Plan for medical needs, like medications that require refrigeration or devices that need power.

4. Make sure your weed abatement is done to reduce the risk of wildfire to your home and property, including clearing your roof and gutters of pine needles, leaves, and debris.

5. Explore solar-powered chargers or battery backups for your necessary electronic devices.

6. Make sure any backup power sources/generators are in good working condition and ready to operate.

7. Have flashlights and/or LED lanterns available for your household (avoid using candles).

8. Stock up on the right batteries for the items you rely on.

9. Have a battery-powered or crank radio.

10. Practice opening and closing your garage door manually.

11. Freeze large containers of water to keep food cold during an outage

# Generator safety

With the prevalence of Public Safety Power Shutoffs (PSPS) in Bear Valley Springs, residents may have or plan to acquire standby generators. A PSPS occurs during times that there is a high risk of wildfire, and it would be unfortunate if the use of a generator during a PSPS became the cause of a fire, injury, or even death. Generators can create multiple safety hazards, and homeowners need to understand how to protect against these hazards.

Generators are potentially hazardous in multiple ways:

- Fuel to run the engine is flammable and may also be explosive.
- Exhaust from the engine contains carbon monoxide, which can be deadly when inhaled.
- The exhaust is very hot and can cause burns or ignite fires if too close to combustible materials.
- If improperly wired to the home or devices in the house,

electricity from the generator can ignite fires or cause electrocution.

First and foremost, if you elect to install a whole-house generator or just a manual transfer switch for a portable generator, these must be installed by a properly licensed contractor who obtains all required permits. This diligence will ensure that the generator, fuel supply, and electrical connection to the home are installed correctly according to the legally enforceable building codes.

If you have an existing whole house generator or transfer switch installed before you bought your home, have it inspected by a qualified contractor.

Once assured that your generator or transfer switch is installed correctly, you still need to pay attention to operation and maintenance requirements to ensure it stays safe. You should have an owner's manual. If you do not, chances are you can find

the right one for your equipment on the internet.

## Critical Safety Rules

- The generator must always be operated outdoors, far enough away from doors and windows to keep deadly exhaust fumes from entering the home.
- The generator should be placed on asphalt or concrete if possible and kept away from combustible materials on the ground, such as pine needles, grass, and leaves.
- The generator should be allowed to cool off before refueling, as spilling gasoline onto a hot engine or exhaust muffler may cause a fire.
- Extension cords must be grounded (three-prong plug), in good condition, rated for exterior use, and sufficient for the loads.
- Plan before a power outage where you will place the generator and route your extension cords with attention to where they will enter the home. This usually means leaving a door or window partly open, allowing exhaust from the generator into the house. If a door or window is

closed onto a cord, it may pinch the cord, cut the insulation, and create an electrocution or fire hazard.

- Understand the capacity of your generator and do not overload it.

- Never use an extension cord to connect the output from the generator into any permanent house wiring except through a properly installed transfer switch.

## Text of Proposed Changes to BVSA Rules

(Deletions are shown in ~~striketthrough~~ type and additions in **boldface underlined** type)

### **ARTICLE 3**

#### **GENERAL RULES FOR AMENITIES AND FACILITIES OPERATED BY THE ASSOCIATION**

*(Adopted 7/9/88)*

##### **SECTION 305. USE PRIVILEGE CARDS**

- (a) The Association will issue Use Privilege Cards to New Members and their ~~families~~ **immediate family, as defined in Art. 3, Sec. 305, par. (o)** upon application and presentation of evidence of eligibility for membership in the form of a recorded grant deed or a currently effective title insurance policy on property within Bear Valley Springs (BVS), a valid State of California Real I.D., a valid State of California Driver's License, **or a recent utility bill showing that the individual(s) listed are the owner(s). On-line applications for a change of address requests from the California Department of Motor Vehicles will not be accepted as proof of residency. Issuance of Use Privilege cards is limited to a family unit living at the same residence. Children over the age of twenty-six years will not be issued amenity cards and will be considered an additional family. Any request for additional cards will be made in writing outlining justification and submitted to the BVSA Board of Directors for review and a response will be made within thirty days of receipt for approval or denial of said request. (amended 4/25/23)**
- (b) (1) If more than one person owns a lot or condominium, all of the owners are deemed one Membership, pursuant to Par. 11b (2) of the Covenants and Restrictions (C&Rs). (2) Pursuant to Art. VII, Sec. 2 of the Association Bylaws, the persons included in the Membership have the right to designate the members of one single family residing together who may use the Community Facilities and Common Areas in BVS. *(Amended 11/21/88)*
- (c) Designation of family members must be made on an application form provided by the Association and is subject to the Association's verification that the information provided by the Membership qualifies the persons designated as family members.
- (d) (1) Use Privilege Cards will be issued to the persons designated by the Membership and found to be qualified family members by the Association.
- (2) The minor children of parents, who are divorced or separated and who have been awarded their joint physical custody as defined in Family Code Section 3004, are deemed to reside with each parent.
- (a) Applications for changes in the designated family and family members may be made to the Association upon surrender of the Use Privilege Cards issued to that Membership. *(Amended 1/27/01)*
- (b) Residences, residential lots, condominiums and condominium lots are intended to be used for residential purposes only. Short-term rentals or

leases (less than 6 months in length at any one time) negatively impact Association resources, resulting in undue costs and liability for the Association, and therefore, are disallowed. This includes Air BNB's, VRBO, or any other vacation, weekend, or short term rentals.

*(Added 10/10/15; Amended 07/10/18)*

- (c) Members who assign their rights to a tenant must immediately surrender their Use Privilege Cards and give the Association written notice of the assignment and the names of the tenant and the tenant's family qualifying for a Use Privilege Card. Upon termination of the tenancy, the Association will return or replace the Member's Use Privilege Card upon application by the Member. The Member should make every effort to ensure that the cards issued to tenants and their families are returned to the Association Office upon termination of the tenancy.
- (1) Use Privilege Cards will not be issued to tenants who have not been assigned use privilege rights by Members as provided in Article VII, Section 3 of the Bylaws.
- (2) A non-refundable deposit, in accordance with the BVSA Fee Schedule, must be deposited for each card before issuance of the cards. *(Amended 11/16/91; 08/10/11; 07/10/18)*
- (3) Tenants who have been assigned use privilege rights by Members must obtain Use Privilege Cards from the Association in order to use Community Facilities and Common Areas. Their use of the Community Facilities and Common Areas as guests of Members or other tenants will not be permitted. *(Added 2/21/98) (Amended 11/21/88)*
- (h) Upon sale, exchange or transfer of a Member's lot or condominium, the Member must surrender to the Association the Use Privilege Cards outstanding on that property. Upon failure to return the card(s), the Association may impose a fee in accordance with the BVSA Fee Schedule for each card, issued with respect to the Member's property, which is not returned to the Association. This fee may be collected through the sale, exchange or transfer escrow or any other means provided by law. *(Amended 5/15/99; 08/10/11)*
- (i) Use of BVS Community Facilities and Common Areas is limited to persons qualifying for Use Privilege Cards or Guest Passes. The Association shall require production of the card or pass prior to use of any facility. Persons operating a business on their BVS property may not extend use of BVSA common areas, facilities or amenities to outside persons as a component of their commercial enterprise.
- (j) Lost, stolen or destroyed cards will be replaced by the Association upon payment of a processing charge in accordance with the BVSA Fee Schedule and execution of an affidavit of loss, theft or destruction. *(Amended 3/10/11)*
- (k) Multiple owners of lots or condominiums who do not qualify as a family as defined by subdivision (n), and who acquired their property prior to September 19, 1987, are entitled to receive no more than six use Privilege Cards. *(Amended 7/10/09)*



- (l) An individual or a husband and wife who own two or more lots or condominiums may designate, for each lot or condominium owned, one single family related to the owners by blood or marriage, residing together, who may use the Common Areas and Community Facilities.
- (m) (1) Persons other than individuals or husbands and wives who own a single lot or condominium may designate one single family residing together who may use the Common areas and Community Facilities. *(Added 7/18/98)*
- (2) Persons other than individuals or husbands and wives who own two or more lots or condominiums may designate for each lot or condominium owned, one single family residing together who may use the Common Areas and Community Facilities.
- (a) The term "person," as used in subdivision (l), means any corporation, partnership, association, limited liability company, trust or other entity recognized by the laws of the State of California. *(Amended 7/18/98)*
- (o) The term "family" as used in the section means an individual or two or more individuals related by blood, marriage or legal adoption, or a group of individuals living together as a single housekeeping unit on a permanent basis, and all having equal access to all areas of the lot or condominium. *(Added 12/16/8; Amended 9-10-08; 7-10-09)*

## PURPOSE AND EFFECT OF PROPOSED CHANGES

The proposed changes would allow for clarification relative to the types of identification that may be used by members when applying for Use Privilege Cards as well as restricting the cards issued to a single property.

### Text of Adopted Changes to BVSA Rules

#### ARTICLE 24 BEAR VALLEY NATURE PATH & CUB LAKE WALKING PATH

*(Adopted 8/10/11)*

SECTION 2400. GENERAL RULES (a) Hours of operation are established by BVSA Management and may be changed without prior notice. (b) Every person using the Bear Valley Nature Path and Cub Lake Walking Path must possess a valid BVSA Use Privilege Card, ~~or BVSA Guest Amenity Use Pass, or be accompanied by someone with an appropriate card or pass.~~ Amenity Use Privilege Card or BVSA Guest Amenity Use Pass must be presented upon request by a BVS Ranger or BVS Management. (c) Parking must be at Beaubien Field or Cub Lake designated parking areas. (d) Users of Bear Valley Nature Path and Cub Lake Walking Path must remain on approved and posted path. (e) Motorized vehicles, including, but not limited to, private autos, trucks, and golf carts, are prohibited on the Bear Valley Nature Path. The following motorized vehicles are allowed on the Bear Valley Nature Path and Cub Lake Walking Path: Bicycles, including Type 1 and Type 2 commercially-made E-bikes. Upon request by a BVS Ranger or BVS Management, identification of the type and wattage of e-bike as indicated by the manufacturer label must be shown by cyclist. Maximum MPH for any of the above is 20 miles per hour and riders must abide by the conduct rules as outlined in Section 2401. (Ref: KC Ordinance 09-230 and BVCSD Code 6-3-6).

(f) Baby strollers, roller skates, children's toys and scooters (human powered or battery operated up to 24 volts), and

mobility scooters and bicycles are permitted on the Bear Valley Nature Path and Cub Lake Walking Path and must abide by the conduct rules as outlined in Section 2401.

SECTION 2401. BEAR VALLEY NATURE PATH AND CUB LAKE WALKING PATH CONDUCT RULES (a) Pedestrians have right-of-way. (b) Dogs are the only animals permitted on Bear Valley Nature Path and/or Cub Lake Walking Path and must be on a leash at all times. Owners of dogs must keep area clean of pet droppings. (c) All trash, debris and garbage must be placed in containers provided. [Ref: CSD Code 6-3-15:A.4.] (d) Dumping of manure, garbage, trash or other debris upon or in the vicinity of the nature path and/or walking path is strictly prohibited. [Ref: CSD Code 6-3-15:A.4.] (e) Courtesy and good conduct must be observed when encountering other users of Bear Valley Nature Path and Cub Lake Walking Path. (f) Use of profane and vulgar language is prohibited. (g) Smoking (as defined in Article 20, Section 2003) is not permitted on Bear Valley Nature Path or Cub Lake Walking Path. [Ref: BVSA Article 20 Sec 2000 (c)] (Amended 06/10/16)

SECTION 2402. MANAGEMENT AND ENFORCEMENT OF BEAR VALLEY NATURE PATH RULES (a) Any person who violates these rules shall be subject to disciplinary procedures, as outlined in BVSA Rules, Article 17 and Article 3, Section 308. Members are responsible for their guests and may be disciplined for guests who violate these rules

### Purpose and Effect of Proposed Changes:

It has been noted that there have previously been no specific rules pertaining to the Cub Lake Walking Path. Due to the proximity of the Walking Path with the Nature Path, it makes sense to clarify that the rules are the same for both paths.

Rule changes will also address the updated technology of electric and battery powered vehicles. These changes will clarify and permit Type 1 and Type 2 Electric (E-bikes) on the Nature Path and Cub Lake Walking Path. Type 1 (pedal-assist) & Type 2 (operation without pedal) E-bikes perform and are used in a similar manner and speed as a human powered bicycle, with maximum speeds of 20 mph. The State of California makes no differentiation in safety concerns between Type 1 and Type 2 E-bikes compared with traditional bicycles. Additionally, members with disabilities are utilizing these types of bikes and mobility scooters to be able to enjoy outdoor recreation. This change would permit these and other updated technology created since these rules were initially adopted, while also outlining appropriate conduct for the safety of all who are using these amenities.
