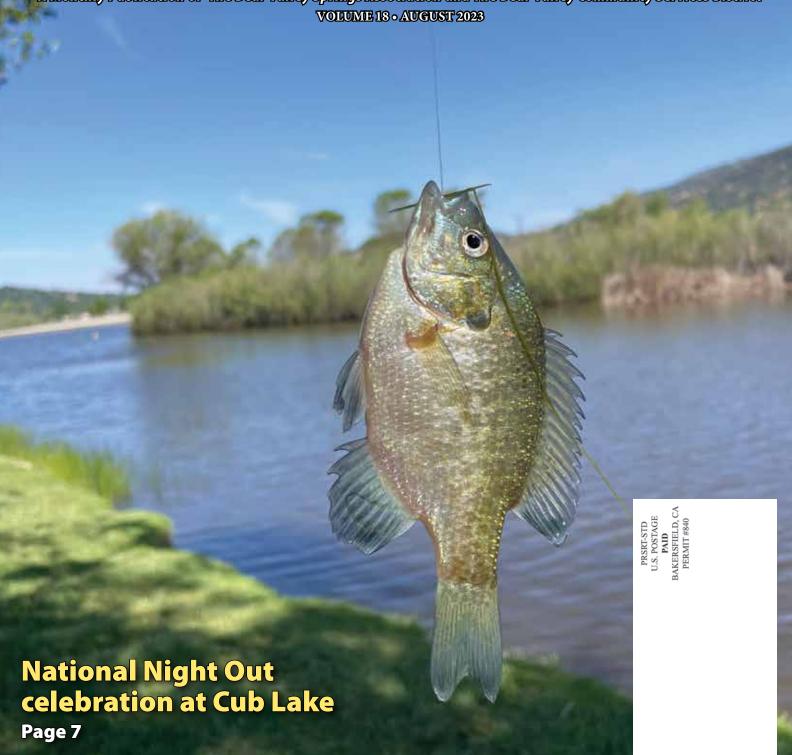

# Bear Valley Springs: A common interest development

First of all, a hearty welcome to all you newcomers to the Bear Valley Springs community. In recent weeks, we have experienced an influx of new owners and tenants into the community. Our community is unique, as we are a common interest development home owner's association. A very brief explanation of this just

# Four Island Lake fishery update

The Lake Quality Advisory Committee is happy to announce that Four Island Lake was restocked with Fish on June 29. While there is still an abundance of Bullhead catfish present within the lake, the ongoing removal efforts are making a significant difference. From May of 2022 through June 17 of 2023, more than 24,000 pounds of fish were removed from Four Island. From June 17, through the day that I am writing this on July 9, more than 3,500 pounds of juvenile Bullheads have been removed. Just for reference, this equates

to approximately 3,300,000 juvenile bullheads removed in less than three weeks. The reason we have so many juvenile Bullheads this year is because there are very few adult fish present within the lake to prey upon them. To correct this problem, the LQAC decided to move forward with stocking 2,850 Florida-strain Largemouth Bass between 3 and 5 inches. These Largemouth Bass are big enough to eat juvenile Bullheads. As the bass grow, reproduce, and prey upon the juvenile Bullheads, they will help to establish a more balanced ecosystem within the lake. The LQAC anticipates the bass should reach 10-12" by the end of this year and will begin reproducing within the Four Island Lake next season.





In addition to the 2,850 Florida-strain Largemouth Bass which were stocked, 2,100 Broodstock (adult) Bluegills, and 1,094 Redear Sunfish were

also stocked within Four Island Lake. The Bluegill will be able to reproduce throughout this summer and the Redear sunfish will be able to spawn next

spring. The Bluegills can grow to be over 12 inches in length and the Redear Sunfish can grow up to 17 inches long and weigh more than 6 pounds. These panfish, along with Golden Shiners and Mosquito Fish currently within the lake, are intended to be the base of Four Island Lake's food chain.

These fish will provide a sufficient forage base for the Crappie and Largemouth Bass as we move into the future. Bullhead catfish population reduction efforts

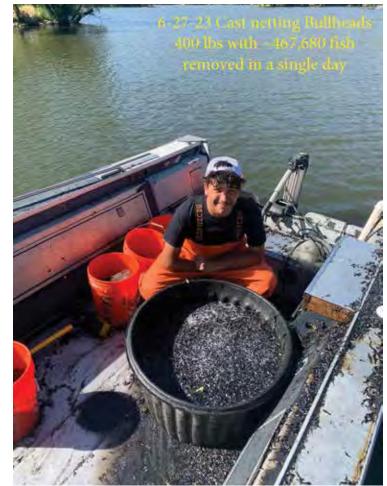
will continue until the Largemouth Bass population is large enough to naturally keep the Bullheads in check. As chair of the LQAC, I would like to thank the donors that contributed additional funds which allowed Bear Valley Springs Association (BVSA) to purchase an additional \$2,500 worth of Largemouth Bass over and above what we had budgeted for. This allowed BVSA to order and receive an additional

500 five-inch Largemouth Bass.

The LQAC anticipates that by the spring of 2025, Four Island Lake should provide a fun family fishing experience for Bluegills, Largemouth Bass, and Redear Sunfish. Until then, Cub Lake is fishing extremely well for Panfish, and Largemouth Bass. The trick is to use

> a small size 6 or 8 hook baited with a piece of nightcrawler or worm, with very little weight, 18" to 36" under a bobber.

Current harvest regulations are Bullheads and Crappies are unlimited harvest, with no size limits. All other fish are catch and release only. If you are not sure what you've caught, the accompanying QR code will take you to a document explaining and illustrating the fish within the Bear Valley Lakes. Please remember to pick up your trash and place it in an appropriate receptacle when you are done fishing for the day.

# Oak Tree Ladies' Golf **Pitch and Putt Booth** Raised more than \$1,300

During the annual July 4th celebration at Cub Lake, the Oak Tree Women's Golf Club set up their Pitch and Putt booth on the edge of Cub Lake, as usual. And, as usual, the community stopped by and tried their luck at hitting floating golf balls into a kiddy pool secured in the lake. In addition, they provided a putting contest, giving younger kids and those not wanting the challenge of chipping, a chance to win something, as well.

Those wishing to try the chipping paid \$2 for three balls. For each ball chipped into the pool, the person won a sleeve of new golf balls. Each sleeve contained three balls. If the person happened to hit the pool, but didn't get the ball in it, they were given one new ball. For the putting contest, each person paid \$1 for

# **Bear Valley Police: That text can wait**

When we talk about distracted driving, we generally talk about anything that can divert attention from the road. But, by a large margin, cell phone use has shown to be the leading cause of distractions that cause accidents. Most everyone knows that it is illegal to use a cell phone without a hands-free device in California while driving (with exceptions for calls to law enforcement, the fire department, or other emergency services). Indeed, most are aware the law prohibits texting while driving.

Most everyone knows, but sometimes it seems not everyone cares. Look left, or right next time you're stopped at a red light, and you'll routinely see folks violating these laws. We all know what it usually means when that car in front of you fails to proceed when the light turns green.

Perhaps some do not realize that drivers are 23 times more likely to be in an accident if they are texting and driving.1 According to the California Office of Traffic Safety, motorists reading or sending texts take their eyes off the road for an average of five seconds. At 55 mph, you have just covered the length of a football field, totally blinded by what is in front of you.

Some rationalize they have special multi-tasking skills and excellent peripheral vision. Unfortunately, there is no skill involved. It is carelessness and complacency and will eventually turn around and bite you.

In 2018, distracted driving-related accidents killed 2,841 people in the U.S. Among those killed include 1,730 drivers, 605 passengers, 400 pedestrians, and 77 bicyclists. Many of these accidents were related to the use of cell phones.<sup>2</sup>

If helping to save lives by making calls using hands-free devices and refraining from reading or writing emails or text messages does not convince someone to change behavior, the first violation starts at \$162.

That text can wait. So can the phone call.

# Off-season swimming and water aerobics

One of the newest clubs in Bear Valley Springs is the Bear Valley Aquatics Club. Although the formation of the club is new, the off-season swimming collaboration and training is not new. More than 15 years ago, BVSA Board opened up off-season swimming to those who went through orientation, agreed to maintain the pool, and follow specific off-season rules, including signed liability forms. off-season swimming This group covers and uncovers the pool, cleans the baskets, sweeps the pool deck, and verifies that only trained people use the pool from September to May. Prior to this innovative collaboration, the pool was covered, partially drained and unused during some of the best swimming times of the year. Immediately after the off-season swimming began, BVSA maintenance shared how much better the pool weathered the winter because the pumps and heater performed needed less maintenance when they were actually

left running during those inclement weather months. So, it was a win-win collaboration.

Why do people get wet in the cold of winter?

Swimming is a winter sport that all levels of athletes can use. Regardless of the temperature you can swim; this only adds character to those enjoying the pool (imagine biking or running in the rain and snow). Pool activities are appropriate for people recovering from surgery, dealing with health issues, and training for competitive events throughout winter months and not just in the summer.

Swimming and water aerobics are physiologically unique in many ways. Swimming is the one sport that takes place within a medium providing resistance for every movement. Swimming occurs in a prone position, meaning your brain and heart are in-line as you exercise. Instead of your heart pumping against gravity, your entire body is oxygenated. Swimming is contact free and impact free,

improving joint, respiratory, and cardiovascular health.

Many people have joined off-season swimming to train for Triathlons, Ironman, swimming events and open water races. In the 2022-23 BV Aquatics off-season, we had people qualify and medal in the USA National Master's Swimming Competitions, in a variety of Triathlons around the country and in open-water distance swims in Turks and Caicos, Mexico and Fiji.

How can you join this group of health-conscious year-round water enthusiasts?

The first step is to attend a one-hour orientation meeting. These orientations are currently scheduled for Saturdays on Aug. 12, 19, and 26, and Wednesdays on Aug. 16, 23, and 30. They occur at 8:15 and 9 a.m. on each date. Check the BVSA web page for additional information.

This year, the BVSA Board has made some changes, which is why we became a club. The dues for the club will pay for liability insurance (\$30 for a single person and \$40 for a family membership).

The group has been contributing to the cost of gas for heating the pool since last year. Now, as a club, we have a specific bill we must pay to the BVSA, which is a \$120 fee, per person, for the entire off-season privilege.

These funds (dues and fees) must be paid prior to the orientation and can be left in a lock box in the lifeguard station at the pool.

Join the "group me" app, which allows us to communicate swim times and other important announcements. We can help uploading app to your phones at the orientation.

Attend the first meeting of the upcoming off-season of the BV Aquatics Club on October 7. Call 661 747-0986 if you have questions.

The group helps new swimmers learn skills and encourages training for those with competition goals. Join us this next off-season.









# Pollinators and native plants important to valley

There has been a lot of news lately about the importance of native plants and pollinators and the fact that they are disappearing at an alarming rate around the globe. Why are they so important and what can we do to help increase their numbers?

Pollinators are needed in 90% of all flowering plants: bees, butterflies, moths and flies. All insects have evolved with the native plants that are present in any food web. They have developed very specialized relationships.

There are 1,600 species of native bees in California alone. They can use the nectar from any plant for energy to fly, but they need the pollen from the specific native plant that they have evolved with. The pollen



is where they get protein and other nutrients for themselves and for their young. Native bees nest in old wood and underground.

The same is true for butterflies. The nectar from any flower will fuel their flight. Although they do not eat the pollen, they lay eggs on their host plant because the larvae need to eat that specific plant. Think about the relationship between Monarch butterflies and milkweed.

We don't usually think about moths being important pollina-

tors, but in fact they outnumber butterflies about 7 to 1. Worldwide there are 140,000 species of moths compared to 20,000 species of butterflies. Moths are also host plant specialists. To help moths survive, turn off lights at night or change to a yellow bulb.

Birds are not pollinators, but the health of the bird population indicates the health of the food web in an ecosystem. Birds need 6,000 to 10,000 caterpillars to raise a clutch of babies to fledge. All those caterpillars come predominately from butterflies and moths. Caterpillars transfer more energy from plants to animals than any other plant eaters.

We can help our local food web by planting and encouraging native plants. Five percent of native plants provide 75% of the necessary caterpillars. These are called keystone plants. They are, oaks, willows, birches, cottonwoods, asters, goldenrod, sunflowers, and in Bear Valley Springs, lupine and sagebrush. Oaks alone support 950 species of caterpillars, as well as gall wasps and acorn weevils, which are important food for birds.

Here are five simple steps to help pollinators: Grow pollinator friendly plants; Change outdoor lights to yellow; Provide nest sites; Avoid pesticides; Spread the word.

The newly reinvigorated Water Wise Garden by the CSD office is a great resource for ideas of which plants grow well here. Another resource is calscape. org, the California Native Plant Society website. Enter your address to find the plants that are native to your location and which nurseries carry them. HIGHCOUNTRYGARDENS. com is a catalogue that carries organically grown native plants.

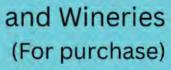

- NO SNORKELS OR FACE COVERINGS OF ANY KIND ARE ALLOWED IN THE POOL.
- DO NOT move the patio furniture!
- . Only authorized swimwear that is commercially sold will be allowed in the pool-no cut-off pants or shorts.
- . Each member 9 or older must show their Amenity Card at the pool gate.
- · Ice chests, coolers, and similar containers shall not be brought into the pool area. However, they can be left outside the gate. (BVSA Rule 1103)
- Bringing alcoholic beverages into the pool area is prohibited.
- NO SMOKING IN THE POOL AREA: THIS INCLUDES VAPING
- . NO running, horseplay, or roughhousing in the pool area is allowed.
- · NO flips, twists, or jumping backwards into the pool is allowed.
- NO squirt guns, water balloons, hard balls, rafts, recreational type flotation devices, diving into the shallow end, sitting on shoulders, climbing on rocks, or running in the pool area.
- NO vulgar or profane language in the pool area.
- A responsible adult must accompany children 13 and under. If they are 14 or older, please bring your children to the gate to ensure they are admitted. (BVSA Rule 1102c).
- . A maximum pool capacity of 93 in water will be in effect, with a deck capacity of 150
- Guests will be charged a \$5 guest fee per day AND MUST BE ACCOMPANIED BY A PROPERTY OWNER. Limit of 3 guests per Track/Lot 13 yrs. old & older. Children 5-12 are \$3; children 4 and under are free. Amenity Passes (without the resident) will NOT be honored.
- All swimmers may be required to prove their ability to swim.
- · Property Owners must be in good standing to enter the pool area.

Health Breaks, which consists of a 10-minute rest period for children 13 and under, requires that they are completely out of the water. This includes the baby pool. These will be enforced every hour on the hour, and only patrons 14 and up can swim during these 10 minutes. These breaks may be more frequent if capacity is reached.

# Winslow Meteor Crater worth a visit



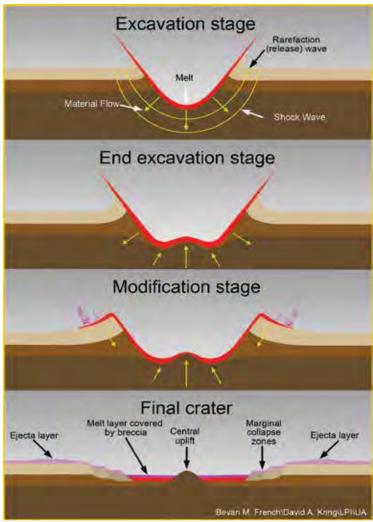
Less than 30 minutes from a corner in Winslow, AZ, there is what is claimed to be the best-preserved meteorite impact crater on earth. Meteor Crater National Landmark measures 3,900 feet in diameter and is 560 feet deep. The impact which created this crater occurred about 50,000 years ago. # ARTICLE 3 GENERAL RULES FOR AMENITIES AND FACILITIES

OPERATED BY THE ASSOCIATION (Adopted 7/9/88)
SECTION 305. USE PRIVILEGE CARDS

- The Association will issue Use Privilege Cards to New Members and their-families-immediate family, as defined in Art. 3, Sec. 305, par. (o) upon application and presentation of evidence of eligibility for membership in the form of a recorded grant deed or a currently effective title insurance policy on property within Bear Valley Springs (BVS), a valid State of California Real I.D., a valid State of California Driver's License, or a recent utility bill showing that the individual(s) listed are the owner(s). On-line applications for a change of address requests from the California Department of Motor Vehicles will not be accepted as proof of residency. Issuance of Use Privilege cards is limited to a family unit living at the same residence. Children over the age of twenty-six years will not be issued amenity cards and will be considered an additional family. Any request for additional cards will be made in writing outlining justification and submitted to the BVSA Board of Directors for review and a response will be made within thirty days of receipt for approval or denial of said request. (amended 4/25/23)
- (b) (1) If more than one person owns a lot or condominium, all of the owners are deemed one Membership, pursuant to Par. 11b (2) of the Covenants and Restrictions (C&Rs). (2) Pursuant to Art. VII, Sec. 2 of the Association Bylaws, the persons included in the Membership have the right to designate the members of one single family residing together who may use the Community Facilities and Common Areas in BVS. (Amended 11/21/88)
- (c) Designation of family members must be made on an application form provided by the Association and is subject to the Association's verification that the information provided by the Membership qualifies the persons designated as family members.
- (d) (1) Use Privilege Cards will be issued to the persons designated by the Membership and found to be qualified family members by the Association.
- (2) The minor children of parents, who are divorced or separated and who have been awarded their joint physical custody as defined in Family Code Section 3004, are deemed to reside with each parent.
- (e) Applications for changes in the designated family and family members may be made to the Association upon surrender of the Use Privilege Cards issued to that Membership. (Amended 1/27/01)
- (f) Residences, residential lots, condominiums and condominium lots are intended to be used for residential purposes only. Short-term rentals or leases (less than 6 months in length at any one time) negatively impact Association resources, resulting in undue costs and liability for the Association, and therefore, are disallowed. This includes Air BNB's, VRBO, or any other vacation, weekend, or short term rentals. (Added 10/10/15; Amended 07/10/18)
- (g) Members who assign their rights to a tenant must immediately surrender their Use Privilege Cards and give the Association written notice of the assignment and the names of the tenant and the tenant's family qualifying for a Use Privilege Card. Upon termination of the tenancy, the Association will return or replace the Member's Use Privilege Card upon application by the Member. The Member should make every effort to ensure that the cards issued to tenants and their families are returned to the Association Office upon termination of the tenancy.
- (1) Use Privilege Cards will not be issued to

- tenants who have not been assigned use privilege rights by Members as provided in Article VII, Section 3 of the Bylaws.
- (2) A non-refundable deposit, in accordance with the BVSA Fee Schedule, must be deposited for each card before issuance of the cards. (Amended 11/16/91; 08/10/11; 07/10/18)
- (3) Tenants who have been assigned use privilege rights by Members must obtain Use Privilege Cards from the Association in order to use Community Facilities and Common Areas. Their use of the Community Facilities and Common Areas as guests of Members or other tenants will not be permitted.

(Added 2/21/98)

(Amended 11/21/88)

- (h) Upon sale, exchange or transfer of a Member's lot or condominium, the Member must surrender to the Association the Use Privilege Cards outstanding on that property. Upon failure to return the card(s), the Association may impose a fee in accordance with the BVSA Fee Schedule for each card, issued with respect to the Member's property, which is not returned to the Association. This fee may be collected through the sale, exchange or transfer escrow or any other means provided by law. (Amended 5/15/99; 08/10/11)
- (i) Use of BVS Community Facilities and Common Areas is limited to persons qualifying for Use Privilege Cards or Guest Passes. The Association shall require production of the card or pass prior to use of any facility. Persons operating a business on their BVS property may not extend use of BVSA common areas, facilities or amenities to outside persons as a component of their commercial enterprise.
- (j) Lost, stolen or destroyed cards will be replaced by the Association upon payment of a processing charge in accordance with the BVSA Fee Schedule and execution of an affidavit of loss, theft or destruction. (Amended 3/10/11)
- (k) Multiple owners of lots or condominiums who do not qualify as a family as defined by subdivision (n), and who acquired their property prior to September 19, 1987, are entitled to receive no more than six use Privilege Cards. (Amended 7/10/09)
- (l) An individual or a husband and wife who own two or more lots or condominiums may designate, for each lot or condominium owned, one single family related to the owners by blood or marriage, residing together, who may use the Common Areas and Community Facilities.
- (m) (1) Persons other than individuals or husbands and wives who own a single lot or condominium may designate one single family residing together who may use the Common areas and Community Facilities. (Added 7/18/98)
- (1) Persons other than individuals or husbands and wives who own two or more lots or condominiums may designate for each lot or condominium owned, one single family residing together who may use the Common Areas and Community Facilities.
- (n) The term "person," as used in subdivision (l), means any corporation, partnership, association, limited liability company, trust or other entity recognized by the laws of the State of California. (Amended 7/18/98)
- (o) The term "family" as used in the section means an individual or two or more individuals related by blood, marriage or legal adoption, or a group of individuals living together as a single housekeeping unit on a permanent basis, and all having equal access to all areas of the lot or condominium. (Added 12/16/8; Amended 9-10-08; 7-10-09)

#### ARTICLE 8

## CUB LAKE AND FISHING AT CUB AND FOUR-ISLAND LAKES

(Adopted 7/9/88)

#### SECTION 800. PROHIBITIONS

All boats and swimming are prohibited at Cub Lake. [Ref: CSD Code 6-3-17:C.]

#### SECTION 801. FISHING

(a) Area signs containing fishing rules are posted at the lakes and must be observed.

[Ref: CSD Code 6-3-19:A.]

- (b) Fishing permits are required as follows at both lakes:
- (1) Before fishing, a fishing permit issued by the Association must be secured at the Whiting Center and have it available on his/her person while fishing, by all persons who are not Members of the Association. Guest passes must also be obtained when guests are not accompanied by a BVSA Member. Permits will be issued to guests' children under 16 years of age at no cost. Fishing permits and Guest Passes must be shown to BVSA Rangers or other BVSA Staff upon request. (Amended 3/18/95; Amended 09/15/17)
- (2) <u>Annual and single</u> Single day fishing permits may be purchased at the Whiting Center.
- (c) Live bait is allowed but may not be released into the lake, and kernel corn may not be used or possessed while fishing. Absolutely no netting Netting of live unhooked fish is not allowed unless working with the Lakes Advisory Committee or the Recreation Committee
- (d) A person fishing may use one two poles only, with not over two hooks lures per pole. All poles must be attended. Trotlines and chumming are prohibited.
- Fish stocking levels and harvest limits for all (e) stocked species; including "Bluegill/Red Ear Sunfish, Crappie, Bass, Catfish and Trout" shall be set Lake Quality Advisory Committee and forwarded to recreation management for implementation. In the event that there is not a Lakes Advisory Committee operating, the decisions shall default to the Recreation Manager for implementation. These limits may change seasonally to promote a healthy and sustainable fish population. The current harvest limits per person, per posted on the BVSA website, at day will be the Lakes, available from the Rangers or Whiting Center staff.

(Amended 1/15/94 & 9/24/94; Amended 09/15/17, Amended 05/05/20)

(f) Fishing hours are:

- (1) Cub Lake: To start not earlier than two hours before sunrise and to end not later than two hours after sunset.
- (2) Four-Island Lake: To start not earlier than one half hour before sunrise and end not later than one half hour after sunset.
- (g) Fishing is prohibited at locations adjacent to the golf course that are in line of balls driven from the course.
- (h) Any activity or presence is prohibited on the dam at Four Island Lake. (Added 09/15/17)
- (i) Any breaches to the fishing rules as provided in this section may result in fines as posted on the fee

schedule. (Added 02-10-11; Amended & Renumbered 09/15/17)

#### SECTION 802. MEMBER RESPONSIBILITIES

- (a) Anyone who is unable to swim or otherwise needs supervision must be supervised by a responsible person while using the lake. (Amended 8/10/08)
- (b) All pets must be restrained on leashes. The Lakes are part of the Common Area and no pets are permitted to run loose. Horses are not allowed in the Lake area. Members and their guests who take pets to the Lake area must clean up after their animals.
- (c) Picnicking is permitted at Cub Lake. Fires may be used only in the receptacles provided. ONLY charcoal briquettes may be used for fuel.

# (d) Glass is not allowed on the beaches, boat ramps, docks or private vessels.

(d) (e) All trash, debris and garbage must be placed in the containers provided.

(e) (f) Vulgar or profane language will not be tolerated.

(f) (g) Excessive use of alcoholic beverages is prohibited.

(g) (h) Vehicles must remain on blacktop areas and may not be driven or parked on lawn areas.

(h) (i) Radios, musical instruments and the like must be played in a manner that is unobjectionable to others.

(i) (i) Model boats powered by wind shall be allowed without restriction. Modell airplanes, gliders, drones, and helicopters (amphibious or otherwise) are prohibited. Boats powered by electric motors or any type of internal combustion engine are prohibited unless by special permission of the Board or its designee. (Repealed and added 7/18/92; Amended 9/24/94; Amended 10/1/2021)

(†) (k) Due to danger from thin ice during winter at B.V.S., all ice skating on the lake is prohibited. (k)(I) This Article will be enforced as provided in Article 17 and Article 3.

#### SECTION 803. MANAGEMENT RESPONSIBILITIES

(a) The Association may require that Members and their guests vacate the Lake area during special events or when repair work is being done.

(b) This Article will be enforced as provided in Article 17 and Article 3. (Amended 12/10/13)

# ARTICLE 9 FOUR-ISLAND LAKE - BOATING (Adopted 7/9/88)

#### SECTION 900. BOATING EQUIPMENT

- (a) Only the following vessels are permitted on Four-Island Lake:
- (1) Human and wind powered vessels
- (2) Electric vessels
- (3) Inflatables and Paddleboards
- (b) The maximum length of a vessel on the lake is as follows:
- (1) Human and wind powered vessels: 20 foot class vessels
  - (2) Electric vessels: 16 foot class vessels
- (3) Inflatables and Paddleboards: 20 foot class vessels
- (c) All vessels must be privately owned by Members, unless participating in a BVSA or BVSA Club sponsored event in which case a liability form is required to be filled out by the vessels operator at the Whiting Center. (d) All vessel owners must carry homeowners or boat liability insurance during any boating activity, at their own cost and expense, in an amount of not less than \$100,000, approved by the Board or its designee and issued by an insurance company authorized to transact insurance in the State of California. (*Amended 9/24/94*;

Amended 09/15/17, Amended and Restated 08/10/20) (e) Any Member who wishes to launch a vessel, as listed in Section 900, Subsection (a) numbers (1) and (2) on Four Island Lake, must register their vessel at the Whiting Center where they will receive a BVSA Vessel-Use permit. This BVSA Vessel-Use permit is to be affixed to the vessel's port side bow and is to be renewed biennially by December 31st of every odd year. Section 900 Subsection (a) number (3) Inflatables and Paddleboards are exempt from this requirement. (Added 09/15/17, Amended and Restated 8/10/20)

(f) All vessels must be equipped with a personal flotation device (PFD) approved by the United States Coast Guard for each person aboard. All persons under 13 must wear a PFD at all times while participating in any boating activity. (Added 10/18/03; Renumbered 09/15/17, Amended and Restated 8-10-20)

- (g) For the purpose of Standup Paddle Board usage Four Island Lake is defined as a swim zone, and as such persons operating a paddleboard are only required to use a leash or wear a PFD if white caps from wind are on the lake. A PFD is required to be worn by children under 13 years of age when on a paddleboard. (Added 10/18/03; Renumbered 09/15/17, Amended and Restated 8/10/20)
- (h) The lakefront, dock and marina areas of Four Island Lake are Common Areas and may not be used for storage of any vessel or recreational vehicle. Vessels may not be operated on the lake earlier than one-half hour before sunrise and later than one-half hour after sunset. Vessels on privately owned lakefront property must be stored outside the Common Area. (Added 8/10/20)
- (i) Vessels left overnight or abandoned at the lake may be removed and stored by the Association. Stored vessels will be returned to owners upon proof of ownership and payment of a storage fee established by the Board. The Association may dispose of unclaimed boats. (Added 8/10/20) (Amended 10/30/20)

#### SECTION 901. SAFETY

- (a) Scuba diving is prohibited.
- (b) Swimming is allowed in all of Four Island Lake except for the buoyed area by the 7<sup>th</sup> tee and the dam area. All swimming in Four Island Lake is at your own risk. (Amended 09/15/17, Amended 8-10-20)
- (c) No camping is permitted on the Islands.
- (d) Swimming and fishing are prohibited at locations adjacent to the golf course that are in line of balls driven from the course. (Added 09/15/17)
- (e) Any activity or presence is prohibited on the dam at Four Island Lake. (Added 09/15/17)

#### SECTION 902. MEMBER RESPONSIBILITIES

- (a) Children under 13 years of age must be supervised by a parent or responsible adult during the entire time the children are in and around the lake area. (Amended 8-10-20)
- **(b)** No person may operate any type of vessel in a reckless manner. (Amended 8-10-20)
- (c) The owner and operator of any type of vessel are jointly and separately responsible for any vessel being operated on the lake and by using the lake agree to hold harmless and indemnify the Association for any damage arising from an accident, both as to bodily injury and property damage. (Amended 8-10-20)
- (d) Sail boats, while at dock area with no one aboard, must have all sails lowered and secured.

# (e) <u>Glass is not allowed on the beaches, boat</u> ramps, docks or private vessels.

- (e) (n) All trash, debris and garbage must be placed in the containers provided.
- (f) (g) Vulgar or profane language will not be tolerated. (g) (h) Excessive use of alcoholic beverages is prohibited.
- (h) (i) Vehicles must remain on blacktopped areas and may not be driven or parked on lawn areas.
- (i) Except as provided in subdivision (n), picnicking

is permitted at Four Island

Lake. ONLY charcoal briquettes or propane BBQ may be used for fuel. Open fires are subject to fines. (Amended 09/15/17)

(j) (k) Radios, musical instruments and the like must be played in a manner that is unobjectionable to others.

(k) (L) Model boats powered by wind shall be allowed without restriction. Model airplanes, gliders, drones and helicopters (amphibious or otherwise) are prohibited. Boats powered by electric motors or any type of internal combustion engine are prohibited unless by special permission of the Board or its designee. (Repealed and added 7/18/92 & 9/24/94; Restated 10/1/2021)

(t) (m) All pets must be restrained on leashes. The lake area is part of the Common Area and no pets are permitted to run loose. Horses are not allowed in the lake area. Members and their guests who take pets to the lake area must clean up after their animals. (Amended 1/27/01)

(m) (n) Due to danger from thin ice during the winter at B.V.S., all ice skating on the lake is prohibited.

(n) (o) At all times, the islands are closed before 8 AM and after dusk. No BBQs or fires are allowed on the islands. In addition, the three islands furthest from the beach are closed to public use during the period January 1 to the Saturday morning of Memorial Day weekend to provide for a bird sanctuary. (Amended 09/15/17, amended 8-10-20)

(o) (p) All vessels as listed in Section 900, Subsection (a) numbers (1) and (2) must register their vessel at the Whiting Center where they will receive a BVSA Vessel-Use permit. This BVSA Vessel-Use permit is to be affixed to the vessel's port side bow and is to be renewed biennially by December 31st of every odd year. Section 900, Subsection (a) number (3) Inflatables and Paddleboards are exempt from this requirement. (Added 10/18/03, Amended 8-10-20)

(p) (q) This Article will be enforced as provided in Article 17 and Article 3. (Added 12/10/13)

#### SECTION 903. MANAGEMENT RESPONSIBILITIES

- (a) The Association may permit motor powered vessels on the lake lakes for the exclusive purpose of enforcement, patrolling, or maintaining Four Island Lake the lakes (Amended 8-10-20)
- (b) The Association is not responsible for damage to privately owned vessels while using Four Island Lake. (*Amended 8-10-20*)
- (c) The Association may require Members and their guests to vacate the lake area during special events or when repair work is being done.
- (d) This Article will be enforced as provided in Article 17 and Article 3. (Amended 12/10/13)

# Get Involved



**THE GOAL:** Make your community stronger by getting trained and getting involved.

It takes more than police, fire and EMS to respond to a disaster. It takes people who are committed to neighborhood, churches, schools and volunteer organizations. When people are willing to work together for the good of others, communities are stronger.

People who are involved are the key to a disaster resilient community. They are willing and able to look out for themselves and others. A resilient community is one that can withstand a disaster and get back to normal quickly (even if normal isn't the same as it was before).

CHOOSE ONE OF THE FOLLOWING THINGS TO DO THIS MONTH TO BECOME BETTER PREPARED:

Connect with an isolated individual in your neighborhood or start a neighborhood organization.

Isolated individuals are more vulnerable during and after a disaster. They are less likely to ask for help or follow emergency instructions. The elderly or those with disabilities may have trouble getting out of the house, and may not have much contact with the outside world. Someone who doesn't speak English well may have trouble understanding emergency instructions. People may also be isolated just because they are new to the area, or because their work hours keep them from meeting their neighbors.

Who are the isolated individuals in your neighborhood? Take time to meet them. Help them make a plan for emergencies, and include checking on them in your plan.

Neighborhood watches and other groups can be a great way for you to become better connected to your neighbors. If your neighborhood doesn't have a group, consider starting one. There are resources available online at www.usaonwatch.org or by calling your local police or sheriff's department.

## ☐ Promote emergency preparedness in your community.

Scout troops, service clubs, residential associations, communities of faith—almost any organization you belong to can become a partner in emergency preparedness. Organizations that promote emergency preparedness make their community more able to withstand and recover from disaster. Here are some suggestions for involving your organization:

- Include a Do 1 Thing preparedness topic in newsletters or on bulletin boards each month.
- Talk to your scout troop leader about how Do 1 Thing activities can be used toward a preparedness badge.
- Get a group together to make emergency kits for seniors or kids who stay home alone.
- Visit the www.do1thing.com website to see how other organizations are promoting preparedness in their communities.

The Red Cross, Ready.gov, and many other organizations also promote preparedness. Find the materials that will work best for your organization and become a partner in preparing your community!

# ■ Become a volunteer in your community (CERT, Red Cross, Neighborhood Watch, etc.).

There are many places to volunteer in your community. Many police and fire departments use volunteers to help with special projects, events, or program. The American Red Cross, Salvation Army, and other organizations train volunteers to work in disasters.

If you are interested in helping in your community or other communities during a disaster, become a volunteer for your local Red Cross or Salvation Army chapter. But don't wait for disaster to strike—volunteer now. These organizations won't send untrained volunteers into disaster areas.

Many communities also have a volunteer center or a Retired and Senior Volunteer Program (RSVP). These programs can find ways for you to help in your community that will fit your schedule and abilities.

If you are already a member of a volunteer organization, consider getting your volunteer group involved in VOAD (Voluntary Organizations Active in Disaster). VOAD is a national program that helps volunteer groups work in their community during a disaster.

Community preparedness starts at home. If you know that your family is prepared at home, you will be better able to help others in your community.
