1) MPS	Committee including Kathy Carey, Debi Kermode, Doug Slavin, and Suzi Vlietstra met several times to research and evaluate the condition and requirements to maintain and enhance the EC arenas and round pens. Suzi gave a detailed summary of their findings and recommendations. All in all it was felt the arenas and footings are in pretty good conditon. The committee recommended the report and recommendations which include three phases of best practices should be presented to the entire board before the finalization of budget. Suzi will send an electronic copy of this report to the board and to the EAC Secretary to be forward to Presidents of the clubs for information to their members. The committee is requesting \$5,000 quarterly for proper maintenance. This does not affect each arena 10-year reserve budgets which have not been funded per the schedules. It was also agreed to inform the clubs of these finds and proposed fiscal increases.
2) Kitchen Update	A report was not offered for the grill function. Don Ciote, Doug Slavin, Jim Panek, and Cheryl Akerly will meet to discuss the kitchen. Buckaroos have offered to pay for some changes to the kitchen.
3) CLUB UPDATES	Buckaroos: Buckaroos had a very successful year with over 30 kids participating at every playdays, full sorting schedule, and rewarding Mule and Horse Show. Rewards dinner will probably be in January. Looking to have a kids only sorting day practicec next year. Carriage Club: Members wanted to participate in the Horsemen's ride however some of the trails were not conducive to carriages. Club will have a "Ride N Drive" the day after Thanksgiving and are hoping for a good turnout. Horsemens: Horsemens had a ride on the 28th to the winery with 9 riders participating. A Christmas ride around the Equestrian area will be in December. ECC approved "no bike" signs (with some color adjustment) for Oaks Canyon and Foothill trail entrances. Bikes have been seen on the trails. When individuals have tried to inform these riders they are not allowed, they have encountered not so polite kids. Pony Club: Jena reported the Pony Club has had a great year. Their last campout at the Equestrian Center was in October. Greenhorns: Had a successful year as well. Good turnout and participation for the Bob Owens Memorial Show. The Greenhorns hosted the Kern County Cattle Womens 75 anniversary which was a three day event with clinics and rides. Dressage: A wireless head set was donated by Janice Kordes. It is customary to have century rides (rider and horse 's age are 100) and the club is looking into a 1/4 century ride to give kids a chance to participate in this. The club is also looking to do a scholarship for kids with some of their funds.
