1. David Armijo (Executive Director South Central Regional Transit District) gave a power point presentation regarding the transit program. Mr. Armijo explained the 10-year plan that was approved and has been in place. He explained in detail the four regional transit districts in the state, and described the 3-county map which includes Sierra, Otero and Dona Ana County. Due to the amount of funding in the southern part of New Mexico the program has focused primarily in Dona Ana County for the past 3 years. The goal is to make services available in Sierra County where residents desire for long distance transportation, currently Sierra County is one of the only counties without transit.

Clerk Cardona informed the Trustee's that the New Mexico Department of Transportation awarded the Village \$1,121,714.33 for the construction of Mona Ave. roadway; drainage improvements including culvert replacement and outfall erosion stabilization project. The match requirement of \$56,085.72 is the amount requested for the hardship waiver, in addition, a special meeting is needed for approval of a resolution to confirm the Village's participation and request for a match waiver; the deadline for submission is September 30, 2021.

The Trustee's of the Governing Board of the Village of Williamsburg concurred, a special meeting is needed for approval and submission of a resolution for the funds awarded from NMDOT 's FY22 TPF program, and proposed, on September 20, 2021 at 11:30 am, at the Village Hall meeting room a Special meeting shall be scheduled.

Clerk Cardona stated Dan Austin (Village Auditor) has begun with the Village's annual audit and hopes to complete it well before the deadline of December 15th.
