Clerk Cardona reported, the trees at the park are in need of trimming the best time for pruning would be when the trees are in dormancy. There are three (3) trees that have died at the Village Hall property and need to be removed. Soil Conservation will spray the 600-channel and the 800-channel leading up to Mud Dam. This plan is to foresee and control the over growth vegetation. The Village will seek estimates for these projects.
