## **Additional Affiliate Members**

Dues: \$75.00 per person any time during the year

Affiliate members shall be individuals who, while not engaged in the real estate profession as defined in the Association's By-laws (Article IV, Section 1), have interests requiring information concerning real estate and are in sympathy with the objectives of the Association.

In accordance with GFWAR policy, Affiliate membership is assigned to the company who will designate one primary member as their representative. Additional individuals may join the Association under the same Affiliate Company for a fee of \$75 per person. (Each additional person must complete a separate membership application.)

Affiliate application fees and dues are non-transferable.
