## \*Old Business:

Moving to Appointed Clerk and Treasurer- A motion was made by Ryan VO and a 2<sup>nd</sup> by Matt L to adopt the Ordinance to provide for the appointment of the Clerk and Treasurer positions. All in Favor. Motion passed. The Clerk will now call for the referendum from the County Clerk to have the referendum question added to the ballot for the next Spring Election. Troy's Position- The Chairman brought up the question of making a new "Position/Title" for Troy to be the "Head/Foreman Roadman". Discussion. The Board will think about what the title should be and discuss at the August Board Meeting.

ARPA/LFRF- Local Recovery Act Funds- The Town received ½ of the money for this. The 2<sup>nd</sup> ½ will be received in 2022. Discussion about what the town is able to spend it on. Clerk was instructed to ask the Towns Assoc for information and bring back to the August meeting. Treasurer will not be making a new account for this money but rather keeping it separate by documenting.

## \*New Business:

Treasurer asked for approval to transfer money for the 2<sup>nd</sup> half of the Ambulance (EMS) payment. Motion made by Matt G and a 2<sup>nd</sup> by Ryan VO to give the Treasurer approval to transfer this money.

Fire Inspection Report- Says 1 Fire Extinguisher is out of date. Chairman will talk to Troy about replacing it.
