PROJECT SCOPE – PRIVATE PARTNER

Status: Zoning - Complete; Annexation - Pending; Design - Underway



PROJECT SCOPE – PUBLIC PARTNERS

TOWN OF MIDDLEBURY

- Extension of sanitary sewer along parts of CR20 and SR13
- Extension of water system along CR37, CR20 and SR13
- Widening and resurface of CR37 (Within Town Limits)

- Reconstruction of CR20
- Project Status: Under design
- Project Value: \$5 \$6 Million
- Funding Model: "3P"- RDC's, Town, Jayco

PROJECT SCOPE – PUBLIC PARTNERS

Continued

ELKHART COUNTY

- Geometric capacity improvements at CR37 and CR20, and CR20 and SR13
- Paving on CR37 (County Section)
- Project Status: T.I.S. complete; design underway, right-of-way pending

- Project Value: \$2.2 \$2.3 Million
- Funding Model: Local funds

PROJECT'S PURPOSE AND NEED

Roadway Improvements:

The Town and County are working in advance of the U.S. 20 Project planned for 2024.

Local road improvements will provide congestion relief during detours and lane closures expected to be a part of the U.S. 20 project. It is critical this local work proceed as soon as possible.

PROJECT'S PURPOSE AND NEED

Utility Projects:


This project is needed to support the Jayco growth project and to strengthen the reliability and redundancy of the town sewer and water systems.

The town must plan all infrastructure projects assuming continued growth of the town.

As an example, approximately 2.5 million square feet of new industrial buildings were developed within the last 10 years.

WHAT'S NEXT

- Designs are advancing with the sewer and water project; plans are nearly complete
- Some easements from property owners are needed; project team members will be contacting owners in the next few weeks
- Some impacts are expected; representatives will discuss this with affected property owners tonight or during a scheduled meeting on your site.
- Property owners who are requested to provide an easement will be compensated

- As the roadway improvements are finalized, representatives of Elkhart County Highway will contact specific owners where additional space is needed for roadway improvements
- These acquisitions will consist of permanent right-of-way
- The county uses a prescribed method for this activity that is based on the Federal Uniform Relocation Act (CFR 49, Part 24)
