August Commentary

Where stock markets will go from here in the short term is anyone's guess, although your guess would have a higher chance of success if you know where bond yields will be too.

Lower bond yields are the primary factor driving markets higher, as stocks have not been this cheap compared to bonds since 2012.


Major headwinds for the market include political uncertainty and growth expectations. Given the Brexit doldrums, Italian chaos and Hong Kong riots you would be forgiven for hoping we are approaching a nadir but perhaps this truly is just the start of a revolution.

Growth expectations are terribly poor too, with record levels of cash, extreme pricing of defensive put options and record Google searches for 'recession' globally since March 2009 (the market bottom).

Of course, if we do enter a global recession, the latter two factors will dwarf the effect of lower yields and markets will likely fall. I suspect this scenario is still not probable, but quite highly possible. Perhaps we agree with Ray Dalio and the Fed and assume the probability of a global recession is 25% likely this year or next. It is


our sense that, say, 75% of investors are already positioned for this scenario, so the greatest shock will come if hope trumps despair again and the global economy trundles on.

Of course we do not own *stock markets*, we own *stocks* and our portfolio has very different characteristics to the market at large. For starters our portfolio trades on 13.6x PE which, irrespective of bond yields, is cheap in our opinion.



Other than two US financial positions we have very little exposure to economically cyclical sectors, and our estimated intrinsic value growth is in excess of 10% for the next few years.


