Latitude Horizon Fund



Investment Objective

The objective of the Latitude Horizon Fund is to deliver capital appreciation over the long term by holding a concentrated portfolio of stocks, whilst lowering the equity risk and enhancing return through a selection of non-equity investments.

June Commentary

Economists have been compared to monkeys throwing darts, often coming off worse in prediction competitions. Making forecasts at points of discontinuity (such as the one we are experiencing at present) is akin to a monkey throwing a dart from a merry-go-round i.e. not to be trusted.

The clearest example is the unexpected behaviour of bonds which, despite inflation and growth running at the highest levels in a decade, still yield just 0.6% in the UK and 1.3% in the US. Why?

Milton Freedman deduced that increases in money supply should drive inflation higher. However, from 2010 to 2020 excess money created excess supply. Technology, a deflationary force in normal times, offered a multiplier effect as capital found its way to the unicorn farm that is the start-up tech sector, fueling an almighty price war to "buy" customers. Excess cash replaced the need for internally generated cash flow to fund growth, keeping a lid on prices as services were offered for free. This unexpected outcome drove interest rates lower along with inflation expectations.

Today, as money is printed directly to support individuals (c.f. Joe Biden's "social infrastructure" bill), it is creating excess demand, as per the original theory. Combining this with short-term supply chain issues, a regulatory crack down on technology companies, and a

political will to turn back the tide of globalisation, it feels like this time is, indeed, different.


We continue to believe that a balanced approach, as opposed to betting on one or other outcome, will produce the strongest returns for investors over time. Yes, inflation is an enormous risk when seeking to preserve and grow one's capital, but so is positioning for it and it never materialising.

Our key defenses against inflation are our low risk (short-dated) US Inflation Linked Bonds and the pricing power embedded within our equity portfolio. As discussed in a previous factsheet, the fact that our portfolio of stocks is c.30% cheaper than the market itself offers another major source of protection.

Whatever the future holds we own assets which we believe will grow in value and, given their starting prices, should generate strong price appreciation well ahead of inflation.

Fear inflation, protect against it, but don't bet on it. Or to put it another way, beware monkeys bearing darts.


