Investment Objective

The objective of the Latitude Horizon Fund is to deliver capital appreciation over the long term by holding a concentrated portfolio of stocks, whilst lowering the equity risk and enhancing return through a selection of non-equity investments.

August Commentary

Governments are rarely compared to start up businesses. Their lack of entrepreneurialism being reasonably well understood.

That said, there is a common thread stitching together the approach taken by successful disruptive businesses of the past and the governments of today. Going for growth.

In "normal times" there is a cost to raise capital (interest rates for governments, and something higher than that for the rest of us) which restricts one's ability to grow.

However, in a zero interest rate world, businesses with a myopic focus on growth at any cost have been rewarded the most by the markets. Moreover, many have defied their sceptics by creating sustainable business models. In other words, the strategy worked.

Governments are seeking to do the same in a classic overcompensation for the dismal outcome of the austerity politics following the financial crisis. The pandemic has given license to the recent excessive spending, and we know there is nothing so permanent as a temporary government program.

ESG policies give further cover to many new spending initiatives. Subsidies and support for new environmentally friendly projects will drive widening fiscal deficits, as will "social infrastructure" bills and "levelling up" agendas. If only the G stood for improved governance within government itself, then we may be willing to expect a higher return on investment than the failed experiments in money printing and fiscal financing of the past.


Whichever countries are most successful in driving growth in the coming years will likely be rewarded, with higher levels of foreign investment and stronger currencies. This is critical to keeping the underlying rate of inflation at bay, and to maintain the ability to finance growth.

On this basis, Europe is particularly vulnerable. Emerging markets will offer highly dispersed outcomes and the US should be fine, although Biden's ratings currently suggest otherwise. The UK is a wild card.


Are there opportunities to capitalise on the early exit from the pandemic, as well as Brexit, to drive a growth agenda and massive inward investment, or is the lack of clear policy in government a hindrance? Despite near daily headlines suggesting chaos, we err on the side of optimism.

As we have mentioned before, the relevant conclusion is to expect currency volatility to be high in the coming years. Interest rates, the traditional compass for FX markets, should remain around zero for some time, so relative growth expectations are the driver to watch.


